Dear Member of Congress,

On behalf of our millions of members and supporters nationwide, we write in strong opposition to the Fiscal Year 2017 Interior, Environment and Related Agencies Appropriations bill. We urge you to oppose this bill should it come to a vote on the House floor, oppose any additional amendments that would undermine protections for our land, air, water and wildlife, and support any amendments to strike these harmful riders.

This bill has once again become a target for dozens of anti-environmental and superfluous policy provisions, which have no place in the appropriations process. This legislation and the agencies it funds are tasked with responsibly stewarding our land, air, water and wildlife and indeed the shared heritage of all Americans. Instead of fulfilling this substantial responsibility, this bill targets protections that would keep our communities healthy, our air clean, our drinking water safe, protect

our rivers and oceans from unlimited dumping of waste, and protect our imperiled wildlife from substantial harm.

Among approximately 30 anti-environmental riders in this legislation, there are provisions that would undermine the country's efforts to address climate change and protect our clean air and water, weaken land conservation, undermine farmworker protections, undercut endangered species and public health protections. These riders are aimed directly at reducing the efficacy of bedrock conservation laws like the Endangered Species Act, Antiquities Act, Clean Air Act, Clean Water Act, and the National Environmental Policy Act and have no place in appropriations legislation. Critical funding legislation should not be held hostage by unrelated and damaging anti-environmental riders.

This bill also makes some severe funding cuts which we strongly oppose. Funding for the Environmental Protection Agency is reduced dramatically, which would only serve to further undermine the protections that Americans support for clean air and water. The Land and Water Conservation Fund is cut by almost 30% below the enacted level and is well below the authorized level of \$900 million. The proposed reduction would substantially threaten incompatible development within—and public access to—federally-protected lands that bolster a robust recreational economy and provide places of refuge and healthy recreation for American families. Funding to list new species under the Endangered Species Act is also cut by nearly 30%, meaning more species in need of protection will slide closer to extinction.

In addition, structural wildfire suppression funding issues have still not been addressed, causing damaging constraints to the entire bill. The failure to identify an alternative funding mechanism for fire suppression has contributed to fire suppression costs exceeding 55 percent of the US Forest Service's budget.

So many of the programs funded by this bill are indispensable to the fundamental health of our environment and our communities. Congress should be investing in America's future—not moving us backward by undermining bedrock laws or cutting funding for programs that help our communities thrive. We urge you to oppose this bill on the floor; vote NO on final passage and on any additional amendments that undermine protections for our land, air, water and wildlife. We also urge you to support any efforts to strike these damaging provisions.
