- III. Examples of Outstanding Professional Leadership** – Nominees must demonstrate outstanding professional leadership, business acumen and integrity. Professional leadership may involve leadership roles in the company for which the nominee works or leadership roles in the community that require engineering expertise. Leadership can be demonstrated by directing a project technically, directing the people working on a project, mentoring other engineers, directing a firm, group or organization, and being responsible for informing a community of issues pertaining to engineering. ***Please attach a typed description with a maximum of 50 words.***
- IV. Civic and Humanitarian Activities** – Describe community activities that exemplify significant contributions of time and energy by the nominee. These activities should be substantial, enduring, and reflect the admiration of his/her peers. ***Please attach a typed description with a maximum of 50 words.***
