BAR EXAM UPDATES:

Revised NextGen UBE webpages

- Official Examinees' Guide to the NextGen UBE, July 2026–February 2027: This is a companion for those preparing for the NextGen UBE in July 2026 or February 2027 and provides an overview of the exam's structure, timing, content, and grading; details about the exam registration process, pre-exam requirements, and what to expect on exam day; and an attorney admissions road map that highlights key steps for law students and graduates to take each year.
- NextGen UBE Content Scope, July 2026–February 2027: The July 2026–February 2027 Content Scope describes the topics and skills that will be tested, as well as the depth at which each topic will be tested, during the first two administrations of the NextGen UBE. Remember this changes some in 2028.
- NextGen UBE exam software preview: This is an important one: It is an online preview that simulates the experience of using the secure delivery platform that will be used to administer the NextGen UBE, allowing examinees to explore the platform's features and layout. (Examinees will also be required to install a secure testing browser on their laptops and complete an exam tutorial before exam day.)
