7. Proposed Wording of Non-Reviewed articles (Juried Reviewed Papers) or Creation of clear two-track publication – William – The wording of these items needs to be clarified. Any implementation for reforming the Juried Reviewed Papers detailed in our JTMAE documentation or creating a two, tiered system needs to be carefully planned.

Currently this proposed wording is leading people to read and understand it differently.

Juried Reviewed Paper - are submitted to the editor and are distributed to jurors for acceptance/rejection. Juried Reviewed Papers are typically reviews of the literature, state-of-the-art technical articles, and other non-empirical papers. Jurors make comments to the author, and the author makes required changes. The decision of the Editor is final. Juried Reviewed Papers are usually non-research pieces of importance to the readership; this would include the White Papers.

Peer-Refereed Articles - We will have our traditional **Peer-Refereed Articles**. **Peer Refereed** articles are submitted to the editor and are distributed to jurors for acceptance/rejection. Refereed articles are original empirical research. Jurors make comments to the author and the author makes required changes. The decision of the jurors is final. **Peer-Refereed:** The *JTMAE* uses a double-blind peer-review process for "peer-refereed" articles and each "peer-refereed" article is submitted to three reviewers for comment and criticism. Articles often go through a second review after an author's first revisions after review. The review process, either via traditional hard copy or via electronic review, will usually take between three months and one year to be completed. The cover page of each *JTMAE* article that has been published after being accepted through the peer-review process denotes the article as "peer-refereed."
