PLEASE NOTE THE FOLLOW-UPDATED INFORMATION REGARDING JUDICIAL ROTA-TIONS/TRANSITIONS OF TRACK 4 CASELOADS ANNOUNCED OCTOBER: Judicial assignments in the upcoming rotation have been revised due to the recently announced retirement of the Honorable Louse G. Scrivener in the spring of 2013. To ensure the availability of trial and plea judges for the criminal caseload throughout the rotation, the Honorable Terrence J. McGann will be assigned to

the Criminal rotation, while Judge Scrivener will remain in the Civil assignment until her retirement. PLEASE NOTE THE CHANGES IN JUDICIAL ASSIGNMENTS IN THE TABLE on page 5.

Rotation of judicial assignments will occur on January 6, 2013; adjustments of case assignments to facilitate transition of caseloads begin this month. CIVIL TRACK 4 case events scheduled on or after January 6, 2013 will reflect the incoming rotation judge who will assume the civil calendar managed by the outgoing judge, with some adjustments to occur on a case by case basis due to the change in assignment noted above.

NAL TRACK 4 caseload will follow the same procedure used for the July 2011 judicial rotation. Beginning October 8, 2012, criminal cases filed on that date through December 7, 2012 AND assigned to Track 4, will reflect the following incoming criminal/general rotation judges (cases will initially be assigned to Track 2 or 3 and will reflect a current assignment plea judge):

Initially Track 2 or 3		If Track 4 is approved
Judge Bernard (651)	^	Judge Mason (638)

This will allow the incoming judge to conduct the Pretrial Hearings occurring in early 2013 and address issues and motions, as well as handle the trial. All indictments and informations filed on December 10, 2012 or thereafter will be directly assigned to the incoming rotation of judges.

With rare exceptions, TRACK 4 criminal cases that were filed before **October 8, 2012** and are pending trial on January 6, 2013 will move calendar fashion using the table below:

Exceptional cases may include: cases alleging crimes with a potential enhanced, life, or life w/out parole sen-

tences; violent or multiple victim sex offenses; cases in which substantive motions on forensic evidence/expert testimony or NCR/competency issues/ motions *in limine* have already been litigated.

In early December, the five (5) judges currently in the Criminal/General Assignment will receive a listing of their Track 4 cases that are pending trial for review to identify any exceptional cases will recommend Administrative Judge as cases they should carry forward through trial (and disposition). Subject Administrative Judge's approval, exceptional cases will stay with the current Track 4 judge for trial and disposition. Those cases approved by Administrative Judge will take priority over other assignments in order to maintain existing trial dates.

Those pending Track 4 cases with a trial date already set that will be not carried by the current Track 4 judge will be transferred to the corresponding judge UNLESS the succeeding judge's calendar will not accommodate that trial date. Where this occurs, the first available judge in the order above will become the Track 4 judge. PLEASE NOTE THAT THE TRACK 4 JUDGE IS ALSO THE PLEA JUDGE AND THEREFORE WILL CHANGE EFFECTIVE JANUARY 6, 2013 FOR SUCH CASES.

ANY postponements or changes of the already scheduled trial date must be approved by the Administrative Judge and rescheduled ONLY in conjunction with the Assignment Office to avoid disruption of other assignments. Where the judge's new rotation calendar will not allow a trial date within Hicks, that case will be scheduled before the succeeding judge in the criminal/general rotation as above, where that judge is also not available, the case will be assigned to the next judge who is available in the order above.

CRIMINAL TRACK 4 PLEA POLICY:

- 1) Track 4 cases filed **prior to October 8, 2012** will continue to have available the current rotation of plea active judges.
- 2) Track 4 cases filed on **October 8, 2012** through **December 7, 2012** will have available the current rotation of plea active judges PLUS THE TRACK 4 JUDGE (from the incoming rotation).
- 3) Cases filed on or after **December 10, 2012** will use the incoming rotation of judges consistent with Tracks 2 and 3 below.

Criminal Track 2 and 3 cases filed prior to December 10, 2012 have available the current rotation of active judges. Beginning December 10, 2012, 30 days prior to the rotation, the incoming rotation of judges will be assigned as plea judges in Track 2 and 3 cases, as well as Track 4 cases.

CRIMINAL TRACK 2 & 3 PLEA POLICY:

- 1) Plea policy is unchanged. Plea active lists using the outgoing rotation of judges will be maintained for the cases filed up to **December 10, 2012.**
- 2) All active judges in the incoming criminal rotation will be available for plea agreements up to the Pre-Trial Hearing for cases filed on **December 10**,

2012 and later. Consistent with the DCM plan, the designation of judges as plea active or inactive will begin no earlier than January 7, 2013, 4 weeks after assignments have begun.

- 3) PRE-INDICTMENT PLEA AGREEMENTS FILED BEFORE DECEMBER 10, 2012: Procedure is unchanged.
- 4) PRE-INDICTMENT PLEA AGREEMENTS FILED ON OR AFTER DECEMBER 10, 2012: May be filed before any plea active judge in the incoming rotation OR subject to certification that a written plea offer was extended on a prior date to any plea active judge available at that time. For cases filed on or after January 6, 2013, pre-indictment plea agreements may be scheduled before any plea active judge in the incoming rotation.

Civil cases: please be reminded that appearance by plaintiff's counsel or a self-represented plaintiff required at all scheduling, status/pretrial, settlement conferences, and pretrial hearings regardless of whether the defendant(s) are served or the case is at issue. Further, a notice of contemplated dismissal under rule 2-507 for failure to obtain jurisdiction over a defendant; a pending motion to defer dismissal; or an order deferring dismissal do not excuse the attendance of plaintiff's counsel or a self-represented plaintiff. Failure to appear can result in the dismissal of the action.

CIVIL TRACK 3 SETTLEMENT CONFERENCES: We continue to work to make the Settlement Conferences in Track 3 civil cases more productive for all involved. Please be reminded that Court staff in the Assignment Office who contact counsel in advance of the Settlement Conference are now requesting additional information about the status of discovery, ADR, and noting any unresolved motions. Cases with such issues are forwarded to the DCM Coordinator, who will work with the parties and make recommendations to the Court as to whether Settlement Conferences and Pretrial Hearings need to be moved to resolve issues or proceed. Counsel are urged to adhere to Scheduling Order deadlines or request their extension prior to their expiration. Finally, in those

cases in which appearance will impose a significant hardship on a party or authorized representative, any motion granted to allow telephonic participation will require just that, participation by telephone, rather than mere availability.

With these additions and the bar's continued support, the Circuit Court will be able to reach the civil caseload and other caseloads scheduled for trial predictably and promptly.

ADR: PLEASE notify the courtordered mediator with whom you are
scheduled for an ADR session at least
24 hours before any scheduled ADR
session if your case settles. We have had
several instances of court-appointed
mediators who have been appointed by
the Court to conduct ADR session(s) at
the rate set by the Court, have cleared the
time on their schedules to do so, spent
time preparing in advance of the session
only to have the parties fail to appear. On
investigation, the parties had already settled and simply did not notify the Court or
the mediator. The Court's deep pool of

experienced attorneys, former judges, and mediators will diminish if litigators do not exercise common professional courtesy in notifying the mediator that the appointment is no longer needed due to settlement

COURT INTERPRETERS: announced many times previously, court interpreters are in high demand in court proceedings throughout the State and particularly in Montgomery County. Staff interpreters must juggle the needs of multiple courtrooms every day; for many languages, the Clerk's Office must obtain contract interpreters for whom the cost must be paid, whether or not the interpreter is actually used. In September, last minute cancellations of contractual interpreters cost the Clerk of the Court \$1,500 in cancellation fees in a single day. In our present environment of extreme fiscal constraint, money spent when the court interpreter is not needed is an egregious waste of resources that are desperately needed. PLEASE notify the Clerk's Office when you have requested an interpreter for

your client or a witness and your case has settled or the interpreter will not be needed for any hearing. As noted on the request, failure to inform that Clerk's Office that the requested interpreter is either no longer needed or not needed for a particular hearing may result in the costs of the interpreter being assessed against the party or parties who have requested this services.

NEW ETHICS OPINION PRECLUDES PRACTICE OF OFFERING (AND REQUESTING) LAWYER'S INDEMNIFICATION FOR CLIENT'S POTENTIAL LIENS

Since 2010, personal injury lawyers have struggled with new regulations intended to make sure that Medicare gets repaid for treating personal injury claimants. Anyone who pays a settlement to a Medicare beneficiary is required to report the settlement to Medicare. If they fail to report, they can be held responsible for satisfying Medicare's unpaid lien, even if they already paid the claimant.

The risk of responsibility for claimants' Medicare liens has fostered a common practice. Insurance companies and their counsel sometimes ask the plaintiff's lawyer to agree to indemnify the insurance company against any claim based on the plaintiff's bills or liens. This raises ethical questions that have been addressed in other jurisdictions. In a recent 2012 opinion, the Maryland Ethics Committee (the "Committee") dealt with it as well. Ethics Docket No. 2012-03.1

The Committee opined that, not only is it unethical for a plaintiff's lawyer to execute an indemnity agreement for a client, it is unethical for the defense to request it as a condition of settlement. The opinion aligns Maryland with every other jurisdiction that has previously addressed the issue, and it offers concrete guidance on an issue that has complicated the settlement of personal injury claims.

The agreement before the Committee was the product of settlement negotiations

between a plaintiff and an insurance company. After the parties agreed upon a settlement amount, the defendant asked the plaintiff's lawyer to sign an indemnification agreement as a condition of settlement. The agreement had the plaintiff's lawyer "personally guarantee payment of all...claims [for medical bills, medical liens, and workers compensation liens], including possibly claims that the attorney, acting reasonably and in good faith, did not know about." The plaintiff's lawyer refused and requested an opinion from the Committee.

The Committee stated that it is unethical for one attorney to ask another to execute an agreement that "seeks to place on plaintiff"s attorney personally, as a condition of settlement with the attorney's client, the risk that plaintiff did not make or will not make payments of medical bills, medical liens or workers compensation liens arising out of the accident or the action filed by plaintiff." The Committee relied principally upon Maryland Rules of Professional Conduct 1.8(e), 1.7(a)(2), and 1.15.

MRPC 1.8(e) provides that, absent exemptions for the payment of "costs and expenses of litigation," a lawyer "shall not provide financial assistance to a client." The Committee stated that "[b]ecause an attorney may not directly provide such financial assistance to a client, it follows that the attorney may not promise to provide such assistance indirectly."

The Committee noted that many other state ethics committees have ruled the same way when presented with similar agreements. It cited to ethics opinions by Illinois, Indiana, Missouri, and New York committees for the proposition that this

sort of agreement goes above and beyond "costs and expenses of litigation" and into the realm of unethical financial assistance.

MRPC 1.7 includes the provisions of the Rules dealing with conflicts of interest. Under the rule, a conflict exists when "a personal interest of the lawyer" may "materially limit" the lawyer's representation of a client. The Committee adopted the logic of several other state ethics committees in ruling that this type of indemnification agreement creates a personal interest that gives rise to a conflict of interest between lawyer and client. The Committee concluded that such an agreement would "undermin[e] the duties of independence and zealousness that the lawyer owes a client."

Under MRPC 1.15, lawyers are responsible for the safekeeping of property of clients and third persons entrusted to the lawyer. Citing a South Carolina ethics opinion, the Committee noted that Rule 1.15 "includes obligations to third parties under federal and state laws" and that lawyers "are ethically bound to disburse . . . funds to their clients consistent with their retainer agreements and the governing substantive law." According to the Committee, a broad indemnification agreement of the type presented here is inconsistent with this rule.

Finally, the Committee found the agreement to be inconsistent with MRPC 1.2(a), requiring lawyers to "abide by a client's decision whether to settle a matter." The Committee recognized that these indemnification agreements could neuter rule 1.2(a) by allowing defense counsel to make a settlement offer that sets the client's interests and those of the



lawyer in opposition. The Committee cited a New York opinion noting that "the lawyer's own...interests not to incur such liability could conflict directly with the lawyer's duty to complete the settlement as the client has directed."

While the Committee's opinion is not novel, it clarifies the ethical obligations of Maryland lawyers in this common circumstance. It also illuminates subtle considerations that lawyers should keep in mind when negotiating settlements. The takeaway is that agreeing, or asking another lawyer to agree, to this type of indemnification as a condition of settlement is unethical. This will be so in any situation where the agreement constitutes a form of financial assistance to the client, creates a conflict of interest between lawyer and client, implicates the lawyer's duty to protect funds, or affects the client's ability to accept or reject a settlement offer.

Proposed Orders: Please remember to submit proposed orders with all motions, oppositions and petitions. Having a proposed order submitted with the pleading eliminates confusion, any misunderstanding and speeds the process.

<u>Interpreters</u>: If you requested an interpreter for your case and it turns out the Interpreter is not needed, it is extremely important that you notify the Clerk of the Court as soon as possible. If the cancellation is done 48 business hours

DISTRICT COURT BENCH **BAR COMMITTEE**

The District Court Bench Bar Committee had its September and October meetings. There are a number of recent developments that would be of interest to attorneys.

The following information is provided to Bar Association members from the District Court:

Holiday Closings: Holiday closings are coming up due to Election Day and holidays. Courts will be closed on November 6, for Election Day. In addition, courts will be closed on November 12 for Veterans Day, and for days surrounding Thanksgiving, Christmas, and New Years. Including the regular holidays, courts will be closed on November 22 and 23, December 24 and 25, and December 31 and January 1.

Addresses for Defendants: This applies particularly in criminal and traffic cases. The court will not solely use the attorney's address as the address for the defendant. A good address is needed for the defendant in each case. An attorney who enters an appearance will also receive a copy of all notices, but it is necessary for the notices to go directly to the defendants in these matters.

Motions for Continuance: Attorneys

are not excused from appearing if they file a motion for continuance that is not ruled upon. The attorney must appear if there has been no ruling. It is not a good idea to file a last minute continuance unless an emergency arises. If it is necessary to file a last minute continuance, the attorney should check with the clerk's office, or the law clerks for the judges, to see if the motion has been ruled upon.

Criminal Summons: If a defendant is charged by criminal summons and has not received a copy of the charging papers, the defendant's attorney can not waive the personal appearance of a defendant at the preliminary inquiry, even if an attorney's appearance is in the file. The reason for this is that the Preliminary Inquiry notice tells the defendant to appear and be advised of the charges and get a copy of the charging papers. The attorney can waive the Preliminary Inquiry, but not personal service of the charging papers. If an attorney wants to accept service of the charging papers on behalf of the defendant, personal service on the defendant can be waived if the attorney in writing affirmatively waives any defense to lack of personal service of the charging papers on the defendant.

Passports: The court is in possession of passports in circumstances where a condition of bond requires the defendant to surrender their passport. It is necessary for attorneys or defendants to obtain possession of the passport back when it is no longer necessary to be held. After a period of time passes, the passport will be forwarded to the State Department, if the defendant does not appear in the clerk's office to pick up his or her passport.

New Civil Forms: Starting January 1. 2013 there is a new DC-CV1 civil complaint form. All parties are required to use the new civil complaint form beginning January 1, 2013. Complaints filed on old complaint forms will be rejected by the clerks.

Temporary and Interim Peace Orders and Protective Orders: There is new language now on temporary and interim peace orders and protective orders that will extend the expiration of the orders if they would otherwise expire on a day when court is closed. In those circumstances, the order will be extended until the next day that the court is open.

Civil Tort Cases: In situations where counsel has more than one case, the court would like counsel not to get over scheduled. If counsel has more than two cases which will be trials and not true preliminary matters, then the attorney should consider continuing all trials over the two which will proceed, or get another attorney from the firm to assist. Cases cannot proceed in the second courtroom that requires the same defense counsel who is

tied up in a case already in progress. Therefore, the court would like counsel to schedule no more than two cases which will proceed to trial on one docket.

<u>Electronic Signatures</u>: Although electronic signatures will be coming with electronic filing, they are not currently allowed in District Court.

Telephones and Electronic Devices: The court does not want attorneys or other persons in the courtroom using their electronic devices or cell phones in the courtroom. The only exception is if an attorney is using his electronic device in a case before the court. Otherwise, attorneys are to go outside of the courtroom to use their telephones or electronic devices.

Preliminary Hearings: Preliminary hearings are typically set at a bond hearing. If the defendant's counsel is waiving a preliminary hearing it should be done by the Wednesday before the Friday preliminary hearing. If it is waived in time, it is not necessary to show up. The court will still set a control date by which the State must dismiss, indict, or file information. The control date will be sent out to the parties as a means of giving notice of the preliminary hearing.

Miscellaneous Matters: Citations will be issued for school bus violations that are caught on camera. This is where someone fails to stop and yield to a school bus when required. These citations will be scheduled and posted on the same docket as the red light camera docket on Monday in Silver Spring.

Rocket Docket: The civil resolution conferences, otherwise known as the "rocket docket", will be reopened for additional attorneys. Requirements will be provided for firms that want to be considered.

Attorney Lounge: The new attorney lounge in the Rockville Courthouse is now furnished and open thanks to an anonymous donation from a member of the Bar Association. Stop by room 616 in the Courthouse to check it out.

Collaborative Law is a confidential, voluntary process which allows parties and their attorneys to resolve disputes without court intervention. Participants in the process have found that they are able to preserve important business and personal relationships and significantly reduce the amounts of time, stress, and monetary expense normally associated with litigation. In Maryland, throughout the United States, and around the world, the collaborative process has been widely used in family law and is being used ever increasingly in other civil matters including, but certainly not limited to, probate, employment, business, construction, and medical error.

Installment plan agreements are one option for taxpayers or small businesses owing less than \$50,000 and meeting other eligibility requirements. Based on the eligibility of the taxpayer, these agreements may include fees.

The majority of taxpayers will qualify for a streamlined installment agreement which requires less taxpayer financial information to be approved, with a maximum tax liability of \$50,000 and requires payment in full within 72 months.

Lost Sales Taxes From Online Sales Will Decline With Time

States that are losing out on sales taxes from online retailing will gradually make up some of that money as more electronic retailers charge the tax, according to the National Retail Federation ("NRF").

The NRF's chief executive officer, Matthew Shay, predicted that trend in a conference call with reporters forecasting relatively healthy holiday sales for 2012—but added that the NRF supports federal legislation allowing states to require online retailers to collect sales taxes.

Shay told reporters that states are losing as much as \$25 billion annually in uncollected sales taxes, a number close to that cited by the National Governors Association and other groups pushing for legislation opening the door to greater collections. "That presumably is going to come down on an incremental basis until we get a federal solution," Shay said.


The reason, Shay said, is that retailers are working out deals with individual states to begin collecting sales taxes. Amazon is an example often cited by lobbyists and others close to the issue, as it has reversed its earlier opposition and has reached deals in California and New Jersey, for instance. But federal legislation is needed to avoid a "hodgepodge" of arrangements between retailers and states, he said.

Tax Court: World Bank Employee Liable for Failure to Pay Self-Employment Tax

A World Bank employee who did not pay self-employment tax was liable for penalties because he failed to show that he relied in good faith on a tax volunteer's advice that he did not have to pay the tax, the U.S. Tax Court held Oct. 2 (Diaz v. Commissioner, T.C., No. 20338-09, T.C. Memo. 2012-280, 10/2/12).

Judge James Halpern wrote that the taxpayer failed to show that he provided the volunteer with necessary and accurate tax information and relied in good faith on the volunteer's advice, particularly in light of the information the World Bank had provided to employees about their obligation to pay the tax.

In 2004, Humberto Diaz, a Chilean national, became a U.S. citizen while employed at the World Bank. The World Bank is an international organization exempt from employee tax withholding, and U.S. citizens employed by the World Bank are liable for self-employment tax in addition to regular income tax



Congress Likely to Move Toward International Reform in Near Term, E&Y Panelists Say

Congress is likely to move toward significant reform of the international tax system in a near-term time frame, Ernst & Young LLP practitioners said Oct. 4th.

"I believe we will have major international reform and we will have it soon," Barbara Angus, a partner in E&Y's national tax practice, said at the accounting firm's 31st annual International Tax Conference. Her words come as lawmakers are expected to begin serious consideration of reform within the next several months, with detailed proposals for a territorial tax system already on the table.

As momentum grows, "the U.S. does need to move in the direction of a territorial system," Angus said on a panel discussing the outlook for tax legislation and the prospects for an overhaul of the tax system.

She noted proposals from House Ways and Means Committee Chairman Dave Camp (R-Mich.) and Sen. Michael Enzi (R-Wyo.), with Sen. Rob Portman (R-Ohio) also expected to unveil a plan for a territorial tax regime.

IRS awards \$104 million to UBS tax case whistleblower

On September 11th U.S. tax authorities awarded \$104 million to a whistle-blower in the UBS AG matter as the government seeks to deter U.S. persons from evading their tax obligations through undisclosed offshore accounts.

By way of background the IRS has a whistleblower award program under which it may pay awards (or, for amounts paid under Code Sec. 7623(a), rewards) to informers (known as "whistleblowers") for information about tax law violations IRS has established Whistleblower Office to administer the program. Administratively, claims under Code Sec. 7623(b) (involving individuals with more than \$200,000 gross income and/or an amount in dispute in excess of \$2 million) are handled by the Whistleblower Office. All other claims (i.e., those under Code Sec. 7623(a)) are handled by IRS's Informant Claims Unit. Any whistleblower (except certain federal employees) is eligible for a reward/award. Generally, the amount of the reward/award ranges from at least 15 percent, to not more than 30 percent, of the additional taxes, interest, penalties, and fines collected by the IRS as a result of the whistleblower's information.

The IRS whistleblower office gathers information from people who want to alert the tax-collecting agency to tax misconduct. Over the years, the office has brought in hundreds of millions of dollars in tax revenue for the U.S. government that would not have been collected without tips from whistleblowers. But the office collected only \$48 million in tax revenues in fiscal year 2011, down from \$464 million in fiscal year 2010, the IRS reported to Congress in June. That was the lowest collection level since at least fiscal year 2004. The drop coincided with a decline in new whistleblower cases.

Republican Senator Chuck Grassley was the author of the whistleblower provisions that were enacted in 2006. The

Senator said in June that the IRS had been driving away whistleblowers.

The size of this award was unprecedented. In a statement the IRS confirmed that whistleblower Mr. Bradley Birkenfeld was awarded \$104 million, the largest payout made under the IRS' whistleblower program.

"The IRS believes that the whistleblower statute provides a valuable tool to combat tax non-compliance, and this award reflects the IRS's commitment to the law," said IRS spokeswoman Michelle Eldridge.

Senator Grassley, an Iowa Republication who helped write the law, said Mr. Birkenfeld's award is an important step, but urged the I.R.S. to build on the momentum it had generated. "If the IRS is serious about encouraging future whistleblowers, it needs to continue to honor the spirit and intent of the law and issue awards in a timely manner," Senator Grassley said.

The Montgomery County Foundation Pro Bono Program seeks volunteers - whether experienced or newly barred attorneys -- to join our panel. There are many county residents that are in great need of changing their current living situation and or financial circumstance and can benefit from free legal services. Your call to volunteer will make a difference to those without resources and in need of a lawyer.

The Pro Bono Program provides FREE LEGAL SERVICES to lowincome county residents in civil cases. The Pro Bono Program provides two means for residents to receive free services – at a legal advice clinic or through the client intake line for referral to an attorney volunteer for direct representation. The legal advice clinics operate in four locations across the county (SEE BOX BELOW) and provide residents the opportunity to walk-in and meet with an attorney volunteer without scheduling an appointment. Eligible clients present their legal problems to an attorney and receive free immediate legal advice and or referral to non-profit or government social service agencies that may be able to help. The client intake line operates out of the main office where the staff screens calls from potential clients in need of a lawyer. The Pro Bono Program staff conducts all screenings over the phone only. Cases referred to attorney volunteers include family law, debt collection, bankruptcy, limited employment and limited immigration, wills and power of attorney.

The Pro Bono Program currently is participating in three projects. First, we participate in the Judicare Project. Contested custody and complex family law cases are referred at a reduced fee to experienced family law attorneys. Attorneys can seek reimbursement of \$80 per hour with a cap of 20 hours per case. The Pro Bono Program requires that the attorney must accept a pro bono case for each case accepted under the Judicare Project. Second, we have a working agreement with the Collaboration Project of Maryland for family law case referrals that include modifications. Third, we refer eligible clients with debt buyer cases to attorney volunteers for direct representation under the **Consumer Protection Project.**

The Pro Bono Program provides FREE LEGAL TRAINING to attorney volunteers. The Rita Rosenkrantz Family Law Training is available via webcast to attorneys for free in exchange for agreeing to accept a family law case. You can sign-up to begin the training at any time and watch the six hours of training at your convenience over the next 30 days. The most recent training was taped during the live class presentation held November 7 & 14, 2011. Maryland barred attorneys in good standing can watch a preview of the training and then determine if they would like to proceed with the entire training seminar. Attorneys participating in the training have the opportunity to immediately join a mentoring group hosted by an experienced family law attorney.
