**Tax Information**

*Dues payments to BRHBA are not deductible as charitable contributions for federal income tax purpose. However, dues payments may be deductible as ordinary and necessary business expense, subject to exclusion for lobbying activity. Because a portion of your dues is used for lobbying by NAHB, HBAV and BRHBA, 30% of these dues, or \$48.00 is not deductible for income tax purposes. \$18 of your dues will be allocated to the Home Builders Association of Virginia PAC to support candidates for election to the office of Governor, Lt. Governor, Attorney General, and members of the General Assembly who will promote the building industry. If you do not wish to have \$18 of your dues allocated to the Builder PAC you may, without reprisal, notify, in writing, HBAV, 707 E. Franklin St. Richmond, VA 23219 and that \$18 will be paid into the General Fund.*
