The Fine Print: Contributions to the CalCIMA Golf Tournament Fundraiser will benefit the CalCIMA PAC and/or the CalCIMA Strategic Initiatives Fund. The Strategic Initiatives Fund is at the discretion of the CalCIMA Board of Directors and will be used on issues that will advance the industry.

- Contributions to the CalCIMA PAC are not tax deductible. PAC ID# 1299236
- CalCIMA PAC may accept contributions up to \$9,800 per individual or company per calendar year, provided that they are domestically controlled. Contributions in excess of \$9800 will be directed to the CalCIMA Strategic Initiatives Fund.
- California law prohibits a foreign national from making contributions to the PAC.
 - A domestic subsidiary of a foreign corporation may make a contribution, if the foreign parent does not finance the contribution and no individual foreign national makes any decisions regarding the contribution.
 - A lawfully admitted permanent resident of the United States (e.g., a "green card" holder) may make a contribution.
- Public entities and municipalities are prohibited from contributing to the PAC.
- Funds from ineligible donors will go directly to the Strategic Initiatives Fund.
