## CJRPC Jr Program Rules, Regulations, & Policies

Revision 1 - February 16, 2022

Central Jersey Rifle and Pistol Club has a robust Jr Program designed to introduce young shooters to the disciplines of shooting and archery. This document explains some of the rules specific to the Jr Program and is used in conjunction with the Jr and Coach application forms, and waiver agreements.

## General Rules, Regulation, and Policies

- 1. This document may be altered or amended anytime by a majority vote of the Board of Directors. This document is intended to provide guidance; however, it cannot cover everything that may come up so additional direction may be provided by the Chairperson of the Jr Program or the BOD.
- 2. Participants are expected to follow all applicable CJRPC General Rules & Regulations, and CJRPC Bylaws.
- 3. All applications are subject to review and approval by the CJRPC Membership Committee.
- **4.** Junior participants must be accepted into the program, having filled out an application and paid the program fees, before attending any practice sessions. The application contains further requirements which must be adhered to.
- **5.** All Jr participants must participate in Safety & Orientation training.
- **6.** Coaches must be accepted into the program, having filled out an application and passed state mandated background checks and training specified by the CJRPC training coordinator.
- 7. Any participant causing a safety or behavioral concern may be removed immediately by a Coach and may be called to a disciplinary hearing which may result in suspension or expulsion from the program.

## **Program Participation/Match Requirements**

- 1. A CJRPC Match Request must be provided to reserve range time for Jr Practices.
- 2. Practice/Match logs to record Jr attendance, scores, and ammo (per session/practice/match) used must be kept and submitted each month. Ammunition amounts used are to be reported per session/practice/match (not per shooter). Provide this documentation to the Jr Program Chairperson via email each month.
- **3.** A seasonal calendar of scheduled matches must be provided to the Jr Program Chairperson, this should contain matches at other clubs, in addition to CJRPC matches.
- **4.** Jr's must participate in both NRA and CMP certified matches.
- **5.** Ammunition, Pellets, and Targets will be provided for the Jr's while they are actively participating in training or a match. The program does not supply shooting supplies for home use.
- **6.** Ammunition and supplies must be requisitioned at least a week before needed, and total ammunition used each session recorded in a log which is located near the ammo locker (to aid us in maintaining adequate inventory).
- 7. Eye and Ear protection must be worn at all times and will be provided by the student.
- **8.** Firearms are not provided by CJRPC, Firearms brought to the Club for use by the participant must be cased and unloaded and in the possession of an adult holding a state firearms identification card.
- **9.** A list of proposed Jr's who wish to be considered for Camp Perry will be submitted at least one full month before the trip, (and the candidates need to have met the minimum requirements as defined in the application) before the Jr Chairperson will approve the trip.
- 10. All match bulletins/schedules/announcements must contain the following statements
  "NO ALCOHOLIC BEVERAGES OR EMPTY ALCOHOLIC BEVERAGE CONTAINERS ARE PERMITTED ON THE
  CLUB PREMISES. VIOLATORS WILL BE DISQUALIFIED FROM COMPETITION AND REQUIRED TO LEAVE THE
  PREMISES IMMEDIATELY."
  - "ALL FEDERAL, STATE AND LOCAL GUN LAWS MUST BE FOLLOWED."
