In October 2022, CLSA members attending the 84<sup>th</sup> annual convention in Cleveland voted to undertake a strategic planning process to understand how the Board of Governors, committees, and staff function today in their present roles, and to recommend ways forward to prepare to meet future needs and challenges of the CLSA. This process will end with a report and recommendations presented to the membership at the 2024 Convention.

As part of this process, in the spring/summer of 2023, the Strategic Visioning Committee put forward a survey. Responses from this survey will anchor the listening sessions that will take place at the 85<sup>th</sup> convention in Milwaukee and later.

Results from the survey follow in this document. Results are divided as follows:


- pp. 2-4 General questions answered by all survey participants
- pp. 5-33 questions answered by CLSA members (active, associate and student)
- pp. 34-51 questions answered by former CLSA members
- pp. 52-60 questions answered by non-CLSA members

Please note: In total 459 people responded to the survey. The survey then branched into three distinct sets of questions: to active CLSA members, former CLSA members, and non-CLSA members. The survey instrument counted the number of people who skipped a question out of the total of 459; it did not count the number of skipped questions by the number of people who actually saw the question.

How is the inclusion of a Newsfeed, which contains little, if any, news stories related to canon law, fulfilling the study of canonical sciences and the mission of the CLSA? Is there really a need for a Newsfeed on the CLSA website? Who chooses the featured news items and their sources? Is it an exercise of the BOG or the Publications committee? Why was a Newsfeed introduced?

Facilitate communication with the Dicasteries of the Holy See.

To recognize and promote the diversity of the CLSA members. The CLSA should express the Church's diversity.

It would be wonderful if the CLSA would help the USCCB create a hotline and reporting mechanisms for victims of spiritual abuse (abuse of conscience, psychological abuse, etc) in religious life. So far, the USCCB and Diocesan Offices only receive sexual abuse allegations, to the best of my knowledge.

Assist the pastors of the Church to understand the pastoral nature of fidelity to the law and the importance in it's equitable application within their jurisdictions.

Work directly with the Roman Rota on being sure what is proposed by the Holy See is clear to those of the Church (i.e. TLM guidance in 2022 having errors and uncertainties in promulgation).

Encourage and promote ongoing training through webinars and seminars to members and non-members of the CLSA.

Stay current with trends in Roman Diacasteries and Tribunals.

It might be beneficial to strengthen out outreach to non-Canonists. We have it as #4, and we often do this individually, but we do not do much outreach as a society.

Keep canon lawyers up to date regarding canon law.



Updated education in realities of the People of God. Be involved in everyday life of People of God and not just be in canon law offices of a diocese.

CLSA needs to recognize that it is not in the interest of an association of professionals, especially legal professionals attempting to promote awareness among the faithful of their canonical rights, to impede or undermine the availability of tools which the members find genuinely useful (such as Fr. Paul Hedman's CanonLaw.Ninja") on the pretense of an arbitrary application of United States copyright law to one of the only approved (or possibly the only approved) English texts of the law of the Church. It is not in keeping with any vindication of rights in the Church that law texts should be gatekept behind the copyright of a private institution, and it's a bad look for an association of lawyers to monopolize the availability of the law to the general public.

I think the Society is doing well, however, I don't think we have a presence in the wider Church. Individual canonists do, but I don't believe the Society is as active a player as it on e was.

Dialogue with USCCB - but not sure it is wanted

As shared previously, I sense a shift in the CLSA from the study of canonical sciences to more of a promotion of a ecclesiology which seems rather "partisan." For instance, in this new website Newsfeed: is this a decision of the BOG or Publications as to what news sources are used and those that are not? Is this Newsfeed a real need? Was this decided upon by the membership? Some past stories on the Newsfeed have included the Montreal Police Department being denied the use of religious symbols. What does this have to do with canon law? Also, one story had as its headline the German Church "sliding toward schism." As we know, Schism is a canonical determination but this piece was more of a critique of the Church in Germany and little to do, if anything, of how "schism" is determined canonically. Again, what does a critique of the Church in Germany have to do with canon law as found in this news piece? Do these stories reflect the official stance of the BOG and the CLSA? Why is CNS from Rome, the official news source of the USCCB, not featured? I would recommend eliminating the Newsfeed - it sends a wrong message and strays from the CLSA's mission. Other canonical societies do not have such Newsfeeds on their websites. The Newsfeed is beyond the constitutional purpose of the CLSA.

I have insufficient knowledge or information to answer.

Ongoing formation and more canonical research. To be open to inviting lecture guests from non-English speaking countries, especially if they are experts in their field.

Asinine enforcement of copyright must stop

The CLSA needs a standard of ethics for canonists that promotes an affirmative obligation to serve the ends of justice and equity over, but not in place of, one's duty to zealously represent a client. This is especially needed in the case of "captive canonists", i.e., those who work exclusively in the Chancery or for an Ordinary/Hierarch.

Other than the convention, hardly any interaction takes place between HQ & members. Easy to use, searchable, online version of CIC. CanonLaw.Ninja did this, but you all shot that down for some reason.

At times it seems the convention topics appear forced to fit a theme. It also seems at times that the planning process requires selecting topics far in advance such that they don't respond in as timely a way to our current needs.

I was embarrassed and disheartened at the debacle over Canon Law Ninja website. Th intervention of civil lawyers was so distasteful, I can hardly believe it. That is not who we are as Catholics - we are much better than that. The lack of dialogue was absolutely infantile. Moreover, the Society leadership showed themselves to be out of touch with the needs of working canonists. That was such a critical and important tool for us to have; thank God for the imagination and vision of other Sister Societies.

I almost didn't renew my membership, but I did because there is a collaborative effort among the younger canonists in the Society to renew and rejuvenate the Society. While the wisdom and experience of our more seasoned members is needed and valued - the MUST be a passing of baton to the next generation. That needs to be done by way of discipleship, older members taking younger members under their wing, teaching and instructing them - passing on the wisdom.

comunication, hospitality

An integration with scripture and the message of Jesus.

Over all "well," in some areas, "not so well"

There needs to be more emphasis on research and proposing changes in canon law as seen fit from the research. That seems to be a goal that had lost its emphasis since my earlier years in the CLSA.

Not be so elitist and in the clouds with their good ole boys mentality.

Top down

Too focused on internal issues and not the needs of the people of God.

Less concern about money. Seems to be for those who are able to afford it. Does not serve the needs of the everyday canonist. Lack of welcoming others to participate in the society. Same people all the time. When someone else offers, they are ignored in favor of the "in crowd"

Greater awareness of members outside of the US

The emphasis on the practical seems to have pushed scholarship and renewal of law to the back burner

Rewording to designate a broader function.

I see very little interaction with other organizations such as RCRI. Like the Church today, there is a clear divide between two camps, which has been seen in some conventions. Greater fidelity to Jesus Christ and the Church, especially the Church's liturgy, should be emphasized. Thus, try to overcome the anti-hierarchy mentality of some.

Too partisan and divided to have fruitful developments

The Society feels tired and in need of a new purpose. The conferences are not rigorous and the topics are too broad to be useful.

More work could be done on numbers 4, 5, 6 and 7 including making the general membership more aware of any efforts in these areas.

no access to digital copy of up to date copy of code in English

Forums are available for interaction, but I don't see much participation from the members. How to encourage use of forums for discussion.

It was wrong to shut down canonlaw.ninja. That site was so helpful to canonists. We needed it

CLSA is too focused on guarding its copywrite of the CIC translation and should be more focused on sharing the Code as a means of furthering the pastoral mission of the Church. Specifically, allow CanonLaw.Ninja to use the CLSA translations!

The connection between paying dues and the benefits of membership is at times obscured. Canonists across the spectrum at times question the utility of remaining in the Society. Greater transparency of the work of the BOG and CLSA outside conventions would help and emphasizing how this work benefits members. Many canonists benefit from the work of the Society but can withdraw and still benefit from publications, scholarship, networking, etc. Canonists ask: "If I can't attend the convention this year, why keep my membership active?"

Many of our approaches are dated and ineffective. Far fewer of our members are in dedicated academia, and the society still operates assuming that volunteers with plenty of time to write are available. This is not the case.

I don't have enough information to accurately say, but from the newsletters and communications it seems as though the society is doing a good job.

Lacking relevance and internal divisions must be overcome.

Don't bully the ninja.

I haven't seen much of the sharing of ideas and praxis outside of the convention.

The inability to produce a current written or digital copy of the Code for this long has been embarrassing. I understand the complications, but a way should have been forged long before now. The snafu with canonlaw.ninja is also an embarrassment that has made my daily work more difficult. The CLSA still has not provided a digital option for its translation and I am not confident that one will be forthcoming. In 2023, this is inexcusable, on top of shutting down the best resource online for American canonists. Shameful.


I think the CLSA is doing well. I would like to see more information coming out of CLSA directly to its members.



At the time of the conference in Atlantic City, I was caring for a newborn and unable to go.

I attempted to go to the Conference in San Diego, for which I was rather excited, but the booking and registration system prevented this, as (despite my having seemed to have it confirmed) the booking was never made with the hotel by the app interface used, and multiple calls confirmed this.

After 25 years, many topics not so helpful to me personally/professionally. It is not easy being gone from parish and so has to be of significant interest.



Since the questions bishops ask us tend to be related to how to apply the law in concrete situations, more presentations on practicalities would be helpful.

Workshops geared towards practical professional improvement in canonical practice, such as instructing a deposition as judge, or the \*ethical\* use of machine learning tools in canonical practice.

I would really like to see an afternoon/day scheduled with break sessions structured with the opportunity for general questions/shared responses with pre-designated topics/areas...marriage law, penal law, religious law, etc. An expert for each field could be the moderator type person with others sharing their experience/expertise as appropriate.

New presenters

I commend CLSA for supporting this ministry. I am grateful that many priests and laity are active in this ministry. However, I am at the point of life and ministry when a more active participation in CLSA does not appeal to me.

Having the CUA professors always as presenters seems odd. Most of them were had by the Canonists that are attending, thus everything they have to say we have already heard time and time again. Speakers should be people NOT teaching, active in Canon Law and advocation of, and those from international arenas that are relative to the needs of the members continued education.

Meeting in a month other than October

These options represent the issue: the topics should be more serious, more canonical, less preachy and pastoral; the liturgies should be more "normal" (and conform to the liturgical norms); the speakers, especially keynotes, should be experts in \*canon law\* Have not attended. Not sure.

Would be helpful to have electronic access to sessions soon after they are completed or at least an electronic version of proceedings soon after the close of the convention since one often has to choose between excellent seminars held at the same time More practical penal law sessions within the convention itself -- need for better, briefer formularies

More variety in speakers and their canonical perspectives. I worry that CLSA in general can tend to be somewhat insular, which Pope Francis has warned leads to decay within the Church. The impression to some is that it largely tends to be the same contingent of longstanding CLSA members who run the Convention and make decisions on things like topics and speakers. And, therefore, we can tend to see the same (or very similar) speakers over and over again on the same (or very similar) topics. I worry that CLSA in general can tend to be insular, and that is sometimes reflected in the Conventions as well.

Greater emphasis on prayer, worship, discernment; opportunities for adoration and/or confession

I get the sense from these questions that the CLSA is considering marketing itself to non-canonists. PLEASE do not do this. The number 1 value of CLSA is that its members are canonists. Are there other societies that do this?


languages other than English only if there is electronic simultaneous translations.



The CLSGBI Newsletter is very professional and serious. It reads more like a journal and the Abstracts are excellent. Respectfully, since 2020, I sometimes find myself asking why I remain a member of CLSA in the past few years when our Newsletter contains stories by the Executive Director about her personal pursuits, travels, and personal living conditions. Even other diocesan canonists ask if this is what we are paying dues for.

Having never attended myself I I not well-positioned to recommend attendance to others.



Making more resources available for encouraging and assisting those interested in canon law in their determination to enter study, including concerning the scholarships available. Make the costs of conventions lower by reducing the venue costs. Yes, many members, myself included, have the cost covered by their place of employment, but many do not. Specifically, many members who rarely attend conventions do not...and I often hear of the cost being prohibitive for them. For myself, if I did not have it covered as a employee, I could not afford most years the \$2000-\$4000 expense when travel, registration, and hotels and meals are considered.

The past couple of years having met extremely gifted canonists through work who are not presenting.

Have resources that are beneficial. Weekly or monthly meeting sessions where veteran members could hold sessions for student canonists, advocate/notaries that do not hold JCL's, and also for newer canonists that are still unsure of various aspects.

I think the one thing I would add is fostering a better sense of fraternity between older members and younger/new canonists. There is much to learn from each other but at times it feels like a welcoming/supportive environment is not present for younger canonists who are new to the field.

#### digitize

Listen to ordinary people. Stop being a "mouth piece" I AND stop being afraid of what Bishops might do including shutting down CLSA. LCWR had to face that and well they didn't do it too well but they are still around.

Even as a member, we are not able to access committee reports on the website since it says that they are private groups, so that leaves us at a deficit in understanding their work.

The Society can be a great resource for canonists if, instead of taking away useful resources for our practice and general canonical literacy, it finds a way to support them in their utility to practitioners in the field. The policing of copyright demonstrably had a negative effect on the experience of many canonists of their practice in making us use inadequate and inefficient resources to try and further the vindication or rights in the Church, and this is exactly the opposite of the reasons why a canonist would consider membership in our Society valuable.

Additionally, the general concern for ethics in canonical practice by CLSA members would indicate the need to examine whether the good that membership "is" should be subjected to more scrutiny as far as ethics in membership.

It is always helpful to any organization to Periodically review its mission, its governing structure and examine where improvements could be made. I applaud the CLSA for this self study.

Maybe you do this already and I've missed it, but perhaps membership could asked what topics they would find helpful in webinars and/or conventions.

We are increasingly finding too few JCL applicants for open tribunal positions - fewer priests available and lay people understandably reticent to pay for a 3-year education, low salaries, etc.

quite interested in this as I am also a civil attorney and serve as in-house general counsel. However, there were few civil attorneys presenting at this conference and those that did focused almost exclusively on religious liberty issues. Again, where was canon law on this? While these attorneys are fine persons, it would have been more worthwhile to have civil attorneys present who are also canonists. In addition, why was not the General Counsel of the USCCB presenting? Was he invited? It may have been of interest to also have some attorney presenters who may not be canonists but who nonetheless are recognized for their breadth of experience and who are called upon by many US bishops, such as Mark Chopko who is the former GC of the USCCB; or Nicholas Carfardi (who IS a canonist), etc. A keynote address for this conference on canon and civil law was presented by a non-attorney. It just seemed that attorney presenters who were chosen were chosen because they represented a specific legal viewpoint based solely on religious liberty issues rather than a breadth of experience. When I saw the list of speakers for this conference, I did not bother attending and could not justify spending diocesan money to attend this conference. Several months later, by reading the Proceedings, I was correct in my initial assessment.

Also, the Executive Director in past Newsletter columns seems to be promoting the Catholic Bar Association. While it is a fine organization, why did not the CLSA also promote similar organizations, such as the Catholic Lawyers Guild to which I belong and which has been in existence since the 1920's? Or the American Catholic Lawyers Association, etc. Again, the appearance is the CLSA has begun to promote certain organizations at the exclusion of others and this is noticed by some of my attorney colleagues. I would suggest the CLSA cease promoting non-canonical organizations especially at the expense of other similar organizations.

I regret sounding like I am piling on the CLSA, but I have been a member of CLSA for over 20 years and this is the first time I am questioning my continued membership that is provided by my diocese, especially now with the jump in dues. Publicly apologize to Fr. Paul and restore the American translation to CanonLaw.Ninja. This could have been handled better.

The canonlaw.ninja copyright cease and desist was very unfortunate and difficult to understand from the outside. The CLSA should be working creatively to encourage and collaborate with such resources and canon law enthusiasts rather than defensively "protecting" copyrights through threats of legal action. Many canonists and others were upset by this short-sighted approach and the lack of explanation regarding it. It was a significant missed opportunity to think outside the box and partner with someone for the furtherance of canon law. Hopefully the CLSA rectifies this.

Only the comment above about how the society, especially at conventions, can operate according to cliques. And I think there is tension right now as the membership diversifies between the "old guard," whi tend to say "That's not how we do things" or "That's not what we're about," and younger members who want to advocate for certain changes ad intra and ad extra.



How regularly have you typically gone to the annual CLSA convention:



To encourage all Christians or interested people to seek annulments and to better understand the total self-giving nature or marriage, to make valid vows more often, so that God enters the marriage. So that children and society and even laws are more oriented to valid vows with no conditions.

I am an attorney and an annulment advocate. I am interested in canon law, but i'm a 68 year old woman, and i am not sure that more training is in order. I feel quite comfortable with nearly all aspects, may be all if I ask for help, of the advocate process.

the Catholic church is for ALL Christians, and actually all people, since God created them. That Jesus set up the Catholic Church and it is organized the way Jesus set it up, with the hierarchy, etc. Thus, the sacrament of marriage is really important, and us trying to help all, whether entering the Catholic church or a member or not, is important. I would be really interested to know if canonists are engaging in discussions about controversial topics of the times and how deep in collaboration they are working with experts in the social sciences,

Sending out unanticipated cease and desist orders really isn't good optics for an organisation that already has the appearance of having a lot of money. Practice the principle of pastoral engagement before getting your civil lawyers to protect your interests. We're all in the same boat, and we have the same goals.
