Description: IEP Transition Plans: Indicator 13 and 14 transition requirements are robust and have significant implications for the entire IEP process. Transition planning is a critical component of IEP compliance and there are many provisions that a school must be aware of and consider in the planning process. Beyond transition compliance, transition planning is a high-leverage lens for investing and motivating students to engage in a personalized education that prepares them for their post-secondary goals and aspirations. Participants will:

- Gain a better understanding of Indicator 13 and 14 best practices.
- Be able to craft data-driven transition plans.
- Understand how to use transition plans to drive the rest of the IEP process.

Specially Designed Instruction in Math

Description: Are your students with specific learning disabilities in math still not closing the gap after their third round of a research-based math intervention program? This is because 1) research-based programming is not a "one-size-fits-all" remedy for reading deficiencies, and 2) the magic is in the implementation not the box set. Special Education teachers must adeptly diagnosis root cause gaps in skills and knowledge, and specially design curriculum and instruction to address these personalized needs- and they must do it efficiently. Participants will understand the different cognitive processing of math, and will be able to improve student growth by implementing a continuous data inquiry cycle in which:

- Teachers collect various screeners that assess the different processing of math.
- Teachers plot and analyze screening data to determine root cause gaps.
- Teachers triangulate data with other assessment and observational sources.
- Teachers prioritize instruction through a problem solving process.
- Teachers implement prioritized instruction and progress monitor goals/objectives.
- Teachers review progress monitoring and adjust groupings and instructional plans.

In addition to gaining a deeper understanding of the cognitive processes of math and building a stronger skill-set in data-driven instruction, participants will learn instructional best practices and evidence-based programming options for specialized instruction in math calculation and math problem solving.
