The Second Regular Session of the 71st General Assembly officially commenced yesterday. 2018 Legislative Priorities

Each year the League conducts an extensive process of outreach and feedback to arrive at our <u>annual legislative agenda</u>. This year was no exception. These priorities were formalized and approved by the League's board at its monthly meeting in early December.

Governor's Revised Budget Projects Even More for 2018-19 School Funding

When Governor Hickenlooper first released his proposed 2018-19 budget earlier this fall, it included good news for schools in Colorado. Specifically, it called for a \$70 million buy-down of the so-called Budget Stabilization Factor (formerly the Negative Factor), which would result in an average perpupil increase of approximately \$343 per student heading into next school year.

Last week these projections grew even stronger when, as a result of new revenue coming from improved economic conditions and the newly adopted federal Tax Cuts and Jobs Act, the Governor amended his budget proposal to increase the buy-down by another \$30 million to \$100 million in total. Additionally, the Governor proposed extending last year's \$30 million investment in rural schools (SB17-267) by another one-time \$30 million rural school appropriation next school year.

The Governor's budget proposal is just that - a proposal - and nothing becomes official until the legislature finalizes the budget this spring. However, it's a positive sign that the Governor has chosen to prioritize school funding in this fashion. We will be sure to keep you posted as the conversation around the budget progresses throughout the legislative session.

Your Investment in Action: Charter Advocacy Helps Limit Damaging Impacts of Federal Tax Reform

The League's advocacy efforts are not just limited to the Colorado legislative session and state-level affairs. If there is a federal issue in need of attention, we will engage there as well, which we did to positive effect late in 2017 as the tax reform debate unfolded in Washington, D.C. At issue were so-called Private Activity Bonds - which many Colorado charter schools have relied upon to finance their facilities - and whether these bonds would remain tax-exempt going forward. With your help, the League swung into action, sent a number of emails and letters to members of Colorado's Congressional delegation, and was able to add its strong voice to those advocating for the preservation of this important facilities financing mechanism. While not all aspects of the final legislation were positive for charter schools, we were able to stave off its most damaging provisions, which is a testament to the strength of the charter school community when united. THANK YOU to everyone who responded to our calls for action (Action Alerts) and contacted their legislators. It really does make a difference.

In order to expand and enhance our advocacy offerings, the League is hiring for a new <u>Associate</u> Director of Organizing.

The ideal candidate will be committed to the charter public school sector and the <u>mission and vision</u> of the League. We are seeking candidates who have experience working in a senior organizing role and successful work experience in low-income communities and in multicultural team environments. This candidate will possess a deep understanding of and appreciation for relational organizing as well as the ability to act with civility, motivate, and empathize and communicate with people from all walks of life.

The Associate Director of Organizing is a full-time position that will connect and mobilize a network of parents, teachers, and supporters statewide to advocate for charter school initiatives and priorities. This person will work in conjunction with the advocacy team to develop short- and long-term organizing goals, strategies and target areas.
