Current ACCME guidelines state that participants in CME activities should be made aware of any affiliation or financial interest that may affect the speaker’s presentation(s). Therefore, it is the policy of the American Society of Cytopathology to insure balance independence objectivity and scientific rigor in all its educational activities. All individual that are involved in the planning of the ASC educational activities are expected to disclose any real or apparent conflict(s) of interest that may have a direct bearing on the subject matter of the continuing education program. This pertains to relationships with pharmaceutical companies, medical device manufacturers or other corporations whose products or services are related to the subject matter of the presentation topic. It is merely intended that any potential conflict should be identified openly so that the listener may form his own judgment about the presentation with the full disclosure of the facts. It remains for the audience to determine whether the speaker’s outside interests may reflect a possible bias in either the exposition or the conclusions presented.
