E-discovery is, quite simply, the legal discovery under the Rules of Civil Procedure of electronically-stored information ("ESI"). As businesses progress steadily toward a "paperless society," in which information is no longer recorded on paper documents, but is instead stored in computers and other electronic storage devices, e-discovery, once a creature found only in the federal courts, is inevitably coming to state courts.

ESI is not in the exclusive domain of big corporations. Anyone who has ever sent or received an e-mail has discoverable ESI. ESI can be retrieved from such commonplace devices as personal data organizers (e.g., Black-Berries), telephones, cell phones, telephone answering machines, fax machines, copiers, automobiles, etc. Case discussions will include the recent (2/25/12) opinion from the Manhattan federal court, discussing and approving of coded-computer-conducted electronic searching of millions of documents as a better-than-human way.

This seminar will cover the legal limits on retrieving and protecting ESI, and the ethical duties the Rules of Professional Conduct impose upon lawyers, who now have the duty to educate their clients who are subjected to the requirements of e-discovery in 2012. The seminar will cover the electronic architecture of the modern business and household and where counsel must search for ESI; how to shift the often substantial expenses of producing ESI to your opponent; the role of the "ESI vendor;" how to advise the small business; how to defend against unreasonable requests for ESI; the "litigation hold" letter; and the need to meet with and educate key personnel of your client, without so alienating the affections of your client that (s)he fires you. There will be ample time for questions and answers.

NOTICE**

On February 27, 2012, pursuant to 28 U.S.C. §2071(e), the judges of the United States District Court, determining that there is an immediate need, approved a Resolution amending Local Rule of Civil Procedure 7.1 (c) *Motion Practice*, to comply with changes made to the Federal Rules of Civil Procedure relating to deadlines in seven-day multiples, and also amending Local Rule of Civil Procedure 7.4(b)(2), *Notices; Stipulations*, to comply with changes made to the Federal Rules of Civil Procedure relating to extensions of time to respond to a Complaint to read as follows:

Rule 7.1 Motion Practice

(a) Every motion shall be accompanied by a form of order which, if approved by the court, would grant the relief sought by the motion. Every response in opposition to a motion shall be accompanied by a form of order, which, if approved by the court, will deny or amend the relief sought by the motion.

(b) Every uncontested motion shall be accompanied by a certificate of counsel that such motion is uncontested.

(c) Every motion not certified as uncontested, or not governed by Local Civil Rule 26.1(g), shall be accompanied by a brief containing a concise statement of the legal contentions and authorities relied upon in support of the motion. ~~Unless the parties have agreed upon a different schedule and such agreement is approved under Local Civil Rule 7.4 and is set forth in the motion, or unless the Court directs otherwise, any party opposing the motion shall serve a brief in opposition, together with such answer or other response which may be appropriate, within fourteen (14) days after service of the motion and supporting brief, except that in the case of a motion under Fed. R. Civ. P. 12(b) or 56, the opposing party shall respond within twenty-one(21) days. In the absence of timely response, the motion may be granted as uncontested except that a summary judgment motion, to which there has been no timely response, will be governed by Fed.R.Civ.P. 56(c). The court may require or permit further briefs or submissions if the Court deems it appropriate, except that a movant has a right to file a reply under Fed. R. Civ. P. 56(c)(1)(C), though the Court in its discretion may alter the time for reply.~~ **Unless the Court directs otherwise, any party opposing the motion shall serve a brief in opposition together with such answer or other response that may be appropriate, within fourteen (14) days after service of the motion and supporting brief. In the absence of timely response, the motion may be granted as uncontested except as provided under Fed. R. Civ. P. 56. The Court may require or permit briefs or submissions if the Court deems them necessary.**

Rule 7.4 Notices; Stipulations

- (a) All notices by parties or counsel shall be in writing.
(b) Stipulations of Counsel

(1) Stipulations of counsel relating to the business of the court, except such stipulations at bar as are noted by the Clerk upon the minutes or by the court reporter's notes, shall be written and signed by counsel of record. Upon receipt of a stipulation, the Clerk shall stamp the date it is received and forward it to the Court for consideration.

~~2) When the parties file with the Clerk a written stipulation for an extension of time to answer, plead or otherwise move, and no such prior extension has been granted (which shall affirmatively appear in the stipulation), the Clerk shall grant the stipulated extension for a period not exceeding thirty (30) days by endorsement upon the stipulation.~~

~~(3) Except as provided in paragraph (2) and except as permitted by Federal Rule of Civil Procedure 29, no stipulation between the parties relating to extension of time shall be effective until approved by the court.~~

(2) In accordance with Fed. R. Civ. P.6(b), no stipulation between the parties relating to extension of time shall be effective until approved by the Court.

Robert Herdelin v. Michael Chitwood

Civil – Defamation – Immunity of High Public Official

It has long been held in Pennsylvania that high public officials are immune from suits seeking damages for actions taken or statements made in the course of their official duties. See Montgomery v. City of Philadelphia, 140 A.2d 100, 102 (Pa. 1958); Durham v. McElynn, 772 A.2d 68, 69 (Pa. Super. 2001); see also 42 Pa.C.S.A. § 8546.

This sweeping immunity is not for the benefit of the public official, but rather serves the deeper purpose of protecting the community so that full public disclosure of information will not be regulated because the chief of police or other public officials fear lawsuits against them personally for speaking out on matters of public concern. Durham v. McElynn, 772 A.2d at 69 (Pa. Super. 2001); see also Lindner, 677 A.2d at 1196 (“[The] deeper purpose [of the absolute privilege] is the protection of society’s interest in the unfettered discussion of public business and in full public knowledge of the facts and conduct of such business.”); Montgomery, 140 A.2d at 103 (“Absolute immunity is thus a means of removing any inhibition which might deprive the public of the best service of its officers and agencies.”). The Pennsylvania Supreme Court has recognized that, in protecting this important public policy, “the innocent may sometimes suffer irreparable harm.” Lindner, 677 A.2d at 1196; Durham, 772 A.2d at 69.

In order to determine whether high public official immunity is applicable to a particular defendant, the court must determine: (1) whether the defendant qualifies as a “high public official,” and (2) whether the defendants’ allegedly actionable behavior was made in the course of their official duties. Montgomery, 140 A.2d at 103. The determination of whether a particular public officer is protected by this absolute privilege “depends on the nature of his duties, the importance of his office, and particularly whether or not he has policy-making functions.” Lindner v. Mollan, 677 A.2d 1194, 1198 (Pa. 1996); see also Durham, 772 A.2d at 69; Montgomery, 140 A.2d at 105. The pivotal issue in determining the scope of immunity, however, is not the strict adherence to whether an individual has policy-making functions, “but rather the public interest in seeing that the official not be impeded in the performance of important duties.” Durham, 772 A.2d at 70; see also Lindner, 677 A.2d at 1197 (Listing Pennsylvania cases wherein defendants were found to be high public officials); Durham, 772 A.2d at 69 (Finding an Assistant District Attorney to be a high public official); Schroeck v. Pennsylvania State Police, 362 A.2d 486, 489-90 (Pa. Cmwlth. 1976) (Finding a State Police Commissioner and State Police Captain to be high public officials).

The Court held:

This is a defamation action brought by Plaintiff/Appellant, Robert Herdelin, president of 6840 Market Street, Inc. which owns the bar “Cheers” in Upper Darby Pennsylvania, against Defendant/Appellee, Michael Chitwood, the Superintendent of the Upper Darby Township Police Department. Appellant alleges that certain statements made by Superintendent Chitwood to the media concerning Cheers were defamatory and caused Appellant financial harm. However, because Superintendent Chitwood is immune from suits seeking damages for statements made in the course of his official duties as a high public official, this Court granted summary judgment in favor of Defendant. This appeal followed.

Following a string of criminal investigations and complaints surrounding Cheers and a November, 2009 homicide that occurred in the Bar’s restroom, Superintendent Chitwood gave a series of interviews to the press wherein Superintendent Chitwood stated, *inter alia*, that Cheers was a “criminal enterprise.”

Following these interviews, Appellant commenced the present defamation action in the Delaware County Court of Common Pleas. Appellant’s Complaint alleged that Superintendent Chitwood’s comments were defamatory and resulted in financial harm to Appellant. Appellant does not dispute that Superintendent Chitwood was speaking to the press as the Superintendent of the Upper Darby Police Department or that his position is that of a high public official, but alleges that Michael Chitwood made the statements in his personal capacity.

This Court, however, found that Superintendent Chitwood, a high public official, was speaking to the press in the course of his official duties and the nature of his statements could not be a basis to alter this high public official status. Therefore, pursuant to the common law doctrine of absolute privilege for high public officials, Superintendent Chitwood is immune from this defamation suit. Thus, on December 6, 2011, this Court granted summary judgment in favor of Defendant. On January 6, 2012, Appellant filed a Notice of Appeal with this Court.

Upon appeal, it was again held that because Superintendent Chitwood is a high public official and the statements at issue were made in the course of his official duties, the common law doctrine of high public official immunity is implicated. Although this court recognizes that, in cases such as these, an innocent party may suffer irreparable harm (*Lindner, supra*), as a matter of law, there are no genuine issues of material fact to be determined at trial that would allow for a permissible recovery under the law of this Commonwealth. Thus, this Court entered Summary Judgment in favor of Defendant.

Therefore, for the foregoing reasons it is respectfully suggested that this Court's Order of December 6, 2011 should be AFFIRMED.

OPINION

This is a defamation action brought by Plaintiff/Appellant, Robert Herdelin, president of 6840 Market Street, Inc. which owns the bar "Cheers" in Upper Darby Pennsylvania, against Defendant/Appellee, Michael Chitwood, the Superintendent of the Upper Darby Township Police Department. Appellant alleges that certain statements made by Superintendent Chitwood to the media concerning Cheers were defamatory and caused Appellant financial harm. However, because Superintendent Chitwood is immune from suits seeking damages for statements made in the course of his official duties as a high public official, this Court granted summary judgment in favor of Defendant. This appeal followed.

FACTUAL BACKGROUND

This defamation action stems from media and press coverage surrounding police investigations of the bar/tavern popularly known as "Cheers," located in Upper Darby, Pennsylvania. The relevant material facts of this case are not in dispute.

Plaintiff/Appellant, Robert Herdelin, is the president of the Pennsylvania corporation 6840 Market Street, Inc., which owns the property and liquor license for Cheers. Defendant/Appellee, Michael Chitwood, is the Superintendent of the Upper Darby Township Police Department. Following a string of criminal investigations and complaints surrounding Cheers and a November, 2009 homicide that occurred in the Bar's restroom, Superintendent Chitwood gave a series of interviews to the press wherein Superintendent Chitwood stated, *inter alia*, that Cheers was a "criminal enterprise."

Following these interviews, Appellant commenced the present defamation action in the Delaware County Court of Common Pleas. Appellant's Complaint alleged that Superintendent Chitwood's comments were defamatory and resulted in financial harm to Appellant. Appellant does not dispute that Superintendent Chitwood was speaking to the press as the Superintendent of the Upper Darby Police Department or that his position is that of a high public official, but alleges that "in

making the remarks at issue, Michael Chitwood departed from his official position and made the statements in his personal capacity.” See Plaintiff’s Memorandum of Law in Opposition of the Defendant’s Motion for Summary Judgment, at 5.

This Court, however, found that Superintendent Chitwood, a high public official, was speaking to the press in the course of his official duties and the nature of his statements could not be a basis to alter this high public official status. Therefore, pursuant to the common law doctrine of absolute privilege for high public officials, Superintendent Chitwood is immune from this defamation suit. Thus, on December 6, 2011, this Court granted summary judgment in favor of Defendant. On January 6, 2012, Appellant filed a Notice of Appeal with this Court. This opinion follows.

STANDARD FOR SUMMARY JUDGMENT

The function of a motion for summary judgment is to foster expeditious litigation and the avoidance of unnecessary trials. Giannini v. Carden, 429 A.2d 24, 27 (Pa. Super. 1984); Phaff v. Gerner, 303 A.2d 826, 829 (Pa. 1973). This Court’s review of such Motions is governed by Pennsylvania Rule of Civil Procedure 1035.2. Pa. R.C.P. No. 1035.2 provides, in pertinent part, that entry of summary judgment is proper, “whenever there is no genuine issue of any material fact as to a necessary element of the cause of action or defense which could be established by additional discovery or expert report” Pa.R.C.P. 1035.2(1). In determining whether to grant a motion for summary judgment, the court must view the record in the light most favorable to the non-moving party and any doubt must be resolved against the moving party. First Wisconsin Trust Co. v. Strausser, 653 A.2d 688, 691 (Pa. Super. 1995).

DISCUSSION

It has long been held in Pennsylvania that high public officials are immune from suits seeking damages for actions taken or statements made in the course of their official duties. See Montgomery v. City of Philadelphia, 140 A.2d 100, 102 (Pa. 1958); Durham v. McElynn, 772 A.2d 68, 69 (Pa. Super. 2001); see also 42 Pa.C.S.A. § 8546.¹

[This] *absolute privilege*, as its name implies, is unlimited, and exempts a high public official from all civil suits for damages arising out of false defamatory statements and even from statements or actions motivated by malice, *provided the statements are made or the actions are taken in the course of the official’s duties or powers and within the scope of his authority, or as it is sometimes expressed, within his jurisdiction*

Durham, 772 A.2d at 69 (emphasis in original) (internal citations omitted). This sweeping immunity is not for the benefit of the public official, but rather serves the deeper purpose of protecting the community so that full public disclosure of information will not be regulated because the chief of police or other public officials fear lawsuits against them personally for speaking out on matters of public concern. See id. at 69; see also Lindner, 677 A.2d at 1196 (“[The] deeper purpose [of the absolute privilege] is the protection of society’s interest in the unfettered discussion of public

¹ The Political Subdivision Tort Claims Act, 42 P.S. § 8541 et seq., did not abrogate the common law doctrine of absolute privilege for high public officials. See Lindner v. Mollan, 677 A.2d 1194, 1196-97 (Pa. 1996); Durham, 772 A.2d at 69.

business and in full public knowledge of the facts and conduct of such business.”); Montgomery, 140 A.2d at 103 (“Absolute immunity is thus a means of removing any inhibition which might deprive the public of the best service of its officers and agencies.”). The Pennsylvania Supreme Court has recognized that, in protecting this important public policy, “the innocent may sometimes suffer irreparable harm.” Lindner, 677 A.2d at 1196; Durham, 772 A.2d at 69.

Thus, given the great potential for harm, the privilege must be limited to those statements and actions which are in fact ‘closely related’ to the performance of those official duties. Although the difficulties in application are readily apparent, such a test at least provides some guidance for the trial court’s determination of when a ‘high public official’s’ statements or actions fall within the scope of absolute privilege.

McCormick v. Specter, 275 A.2d 688, 689 (Pa. Super. 1971).

In order to determine whether high public official immunity is applicable to a particular defendant, the court must determine: (1) whether the defendant qualifies as a “high public official,” and (2) whether the defendants’ allegedly actionable behavior was made in the course of their official duties. Montgomery, 140 A.2d at 103. The determination of whether a particular public officer is protected by this absolute privilege “depends on the nature of his duties, the importance of his office, and particularly whether or not he has policy-making functions.” Lindner v. Mollan, 677 A.2d 1194, 1198 (Pa. 1996); *see also* Durham, 772 A.2d at 69; Montgomery, 140 A.2d at 105. Pennsylvania State Police, 362 A.2d 486, 489-90 (Pa. Cmwlth. 1976) (Finding a State Police Commissioner and State Police Captain to be a high public officials).

In the present case, Defendant Chitwood is the Superintendent of Upper Darby Township Police Department. As the Department’s Superintendent, he is the highest ranking officer in the Department and has the power and authority to set Department policies, including those regarding relationships with the press. *See* Deposition of Michael Chitwood, 2/16/2011, at 14: 5-9. Additionally, the important public policy that is furthered by this common law immunity is specifically implicated in this case as there is great public interest in not impeding such a high ranking police official from disclosing important information to the community through the media. *See* Lindner, 677 A.2d at 1196. Therefore, this Court found Defendant Chitwood to be a high public official and, thus, immune from suits seeking damages for statements made in the course of his official duties.

Further, Superintendent Chitwood was acting within the scope of his duties when he made the statements that are at issue in this case. All of the defamatory statements,² and more specifically the “criminal enterprise” statement which is truly at the heart of this law suit, were made either during official press conferences

² For purposes of deciding this Motion, this Court assumed that a jury could find the comments made by Superintendent Chitwood to be defamatory and caused Plaintiff harm.

or otherwise in interviews with the press. There are no statements more closely related (McCormick, *supra.*) to a Police Superintendent's duties than those made to the press concerning official police business. Superintendent Chitwood was speaking in his official capacity, in uniform, about matters of public concern related to investigations by the Upper Darby Police Department and the performance of his official duties as Police Superintendent. Informing the public of matters pending in the police department and overseeing and directing communications with the media is specifically part of a Police Superintendent's job and certainly within the scope of Superintendent Chitwood's authority and jurisdiction. See Durham, 772 A.2d at 69.

Appellant argues that the content of the defendant's speech could remove the high public official's immunity. It is, however, not the content of the defendant's speech, but whether the official made the alleged defamatory statements during the course of his official duties, that is the pivotal question in this analysis. See Durham, 772 A.2d at 69. To hold otherwise would so degrade the privilege, in that all plaintiffs would merely allege that the content of the speech at issue went outside of the defendant's official role, that the privilege would be rendered essentially non-existent. As a corollary, Plaintiff also argues that the question of whether Superintendent Chitwood was acting within the scope of his duties, given the nature of and motivation for his comments, is a question for the Jury. See Plaintiff's Memorandum of Law in Opposition of the Defendant's Motion for Summary Judgment, at 5. While offering no case-law to support this proposition, Plaintiff cites as precedent § 13.09 of the 2003 Pennsylvania Civil Jury Instructions titled Defamation: Defense of Privilege." Section 13.09 of the 2003 Pennsylvania Civil Jury Instructions, however, was revised in 2009 and now states, with respect to absolute privilege, that No instruction need be given. See Pa. SSJI (Civ), § 13.18 (2009) (formerly § 13.09) (again renumbered in 2011 as Pa. SSJI (Civ), § 17.200 (2011), with no substantive changes). The subcommittee notes following the Instruction further elaborate that, "*the jury would not need an instruction with respect to an absolute privilege, because that is a complete bar and would be ruled on by the court as a matter of law (i.e., by a dispositive pretrial motion).*" Pa. SSJI (Civ), § 17.200 (2011) (emphasis added). Accordingly, Plaintiff's very own reference to this section again leads to the inevitable legal conclusion that this claim, under the facts of this record, faces a complete bar at every turn of the law as it is now and has been written and understood for at least several decades.

Because Superintendent Chitwood is a high public official and the statements at issue were made in the course of his official duties, the common law doctrine of high public official immunity is implicated. Although this court recognizes that, in cases such as these, an innocent party may suffer irreparable harm (Lindner, *supra*), as a matter of law, there are no genuine issues of material fact to be determined at trial that would allow for a permissible recovery under the law of this Commonwealth. Thus, this Court entered Summary Judgment in favor of Defendant.

CONCLUSION

Therefore, for the foregoing reasons it is respectfully suggested that this Court's Order of December 6, 2011 should be AFFIRMED.
