

COLORADO EDUCATION POLICY FELLOWSHIP PROGRAM 2019-20 APPLICATION FORM

We are pleased you are considering the Colorado Education Policy Fellowship Program. The Education Policy Fellowship Program (EPFP; <https://epfp.iel.org/>) is a ten-month professional development program for individuals whose work record reflects strong leadership abilities and a concern for issues important to children and education. Participants in the Fellowship Program hold full-time positions in diverse organizations at the local, state, and national levels. Fellows are endorsed and supported by their employing agencies in the Fellowship Program.

Participation in EPFP yields key results. The program stands on three pillars of *policy*, *leadership*, and *networking* that provide Fellows with an exceptional opportunity to learn, to apply new insights, and to practice acquired skills (please see our theoretical framework that guides the EPFP approach: https://cdn.ymaws.com/epfp.iel.org/resource/resmgr/docs/infographics/National_EPFP_Content_Framework.pdf).

Through monthly seminars, workshops, and discussions, as well as a spring project, the EPFP Fellows:

- Develop a broadened understanding of the policy process and the various aspects of education policy;
- Enhance their communication and decision-making skills;
- Refine their potential for leadership; and
- Expand their network of professional colleagues.

As a result, employing agencies are rewarded with better informed and more skillful staff.

The nationally recognized EPFP was established in 1964 by the Institute for Educational Leadership (IEL) in Washington, DC. IEL supports the program in its network of 17 state affiliates and in the District of Columbia. EPFP has produced over 9,500 alumni who now lead at high levels in various sectors.

Between 1978 and 1997, the Colorado EPFP served over 145 Coloradans, and was re-established in 2012-13. Over the past seven years 58 Colorado Fellows have completed the program. Colorado EPFP seeks 8-10 Fellows for the 2019-20 cohort, individuals eager to play a leadership role in education policy in our state.

Colorado Education Policy Fellowship Program

The Colorado Education Policy Fellowship Program brings together a diverse cohort of professionals from education, health, human services, government, business, and community organizations.

ELIGIBILITY AND SELECTION PROCESS

Colorado EPFP invites you to apply if you have:

- A commitment to personal and professional development on behalf of children and youth;
- A track record for making things happen—inside and across agencies and organizations;
- Substantive work experiences, leadership experience, and a full-time professional position;
- A Bachelor's degree or its equivalent;
- The endorsement and financial support of your employing organization.

What is my commitment if I am accepted as an EPFP Fellow?

- Participate in a half-day retreat in the fall and eight 3-4 hour seminars, often held at the conclusion of a normal work day (such as dinner meetings on Tuesday or Wednesday from 4:30-8:00 or 4:45-8:15) in Denver, over ten months. Keep up with recommended readings in advance of the monthly meetings.
- Travel to and participate in the four-day Washington Policy Seminar, **March 22-25, 2020** in Washington, D.C., meeting with Fellows from other states, many with Education Policy Fellowship Programs now in their third or fourth decade. As participation in the Washington seminar is the major expense for each sponsoring agency, *all candidates must be able to attend the event in March*. - Commit to produce a policy brief, perhaps with other Fellows, on an issue relevant to your sponsoring organization. Our final event (June 2020) is a public presentation of each Fellow's policy brief.
- Share your experience and knowledge with other Fellows through presentations, class discussion, and class projects.
- Conduct independent study and research to expand on issues explored in the program.

How will my organization benefit from my participation in the EPFP?

Employers gain:

- Access to a professional development program with a proven track record.
- Better informed, more skillful employees.
- Employees who are ready to assume more leadership responsibilities.
- Expanded networks that enhance the organization's ability to access key leaders and decision makers who shape policy in Colorado on behalf of children and education.

How is Colorado EPFP different from other professional development programs?

The focus of EPFP is developing leadership and knowledge as it pertains to education policy. EPFP is supported by a national and state network of highly accomplished men and women with expertise in research, policy development, and effective practice in education, child development, health, and human services. Through collaboration with the University of Colorado at Denver's School of Public Affairs and several Denver-based nonprofit education organizations, we will lead discussions and skill development workshops that explore major education policy issues for Colorado—and the country. Fellows will meet with a number of key education policy officials. In addition, Fellows work on a project and make a presentation during their graduation

ceremony. Participation in the **Washington Policy Seminar** increases Fellows' knowledge of national policy issues and processes and gives them a chance to explore the impact of national policy on their work.

EMPLOYER'S COMMITMENT TO and SUPPORT of FELLOWS

PROGRAM FEES AND EMPLOYER SPONSORSHIP

Each Fellow or the Fellow's employing agency—the sponsor—will pay a fee of \$1,450 to help cover costs of the program. Of this amount, \$925 goes directly to the Institute for Educational Leadership, which puts on the national conference in Washington, D.C. **The sponsor or the Fellow will also pay for travel and hotel expenses** for the national conference (March, 2020). (PLEASE NOTE: *Adding up the cost for 3-4 nights in a Washington hotel and the flight to D.C. can exceed \$1,000. We HOPE that cost never falls on the Fellow's shoulders alone.*) In addition, the employer provides release time as needed for participation in the fall half-day retreat, for the monthly meetings in Denver, and for other program activities, including one visit to a school.

TO THE SUPERVISOR/EMPLOYING AGENCY REPRESENTATIVE:

The 2019-20 Colorado Fellows are expected to participate in the half-day retreat in the fall, attend the eight seminars/meetings in Denver, and take part in the national policy seminar (scheduled for **March 22-25, 2020**, in Washington, D.C.) that brings together Fellows from all EPFP sites.

Your signature affirms:

- (1) your employee's release time for full participation in the Fellowship Program and
- (2) payment of **\$1,450** to help cover costs of the program.

The sponsor or Fellow will also pay for travel and hotel expenses to the Washington Policy Conference in March 2020. (AGAIN NOTE: Based on the past two years, this expense can exceed \$1,000.)
