# What is the Substantial Damage Administrative Procedures (SDAP) Program?

---

- **Challenge:** Communities are not prepared to administer SI/SD at scale after disasters. Many communities have at least some procedures, but they are not written down or compiled in one place, resulting in inconsistent and ineffective enforcement of local SI/SD provisions at the moment when they are most meaningful.
- **Goal:** Communities should have a central plan for all their processes and procedures so when disaster strikes, they are ready to quickly scale up their SI/SD operations and build back stronger, more efficiently, and in compliance with the NFIP.
- **SDAP Solution:** Using the SDAP Plan Template as the foundation of their experience, flood-prone communities are shepherded through a process where they are assessed, trained, and provided technical assistance, resulting in a completed SDAP Plan that they can use when the next disaster strikes, and update over time.



# About the Substantial Damage and Substantial Improvement Program

---

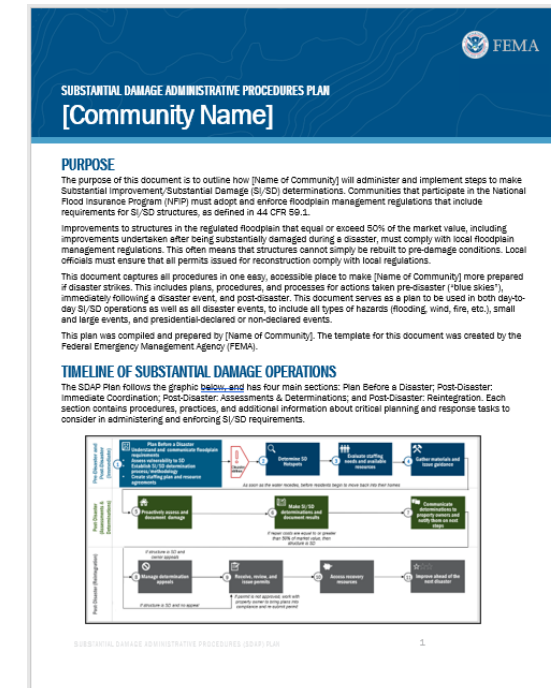
- The SDAP Program works to increase local administration and enforcement of SI/SD requirements, most notably readying communities to carry out these activities in the post-disaster environment
- The SDAP Program is intended to reduce the administrative and resource burden for FEMA and states associated with planning and producing workshops for communities
  - This is accomplished by providing templated materials and enabling multiple communities to participate in a single workshop

# Substantial Damage Administrative Procedures Plan

- The SDAP Plan is the foundational document of the SDAP Program, capturing a community's existing procedures, links, reference materials, and points of contact for every step of the SD administration and enforcement, from pre-disaster to reintegration
- Its purpose is to outline how a community will administer and implement steps to make SI/SD determinations
- It is a “living document” — one that evolves and can be updated over time as regulations, procedures, staff, and experience change
- The SDAP Plan is a template to help organize and consolidate existing procedures, as well as highlight any gaps or remaining needs. The template uses fill-in-the-blank boxes and indicates where input is requested.

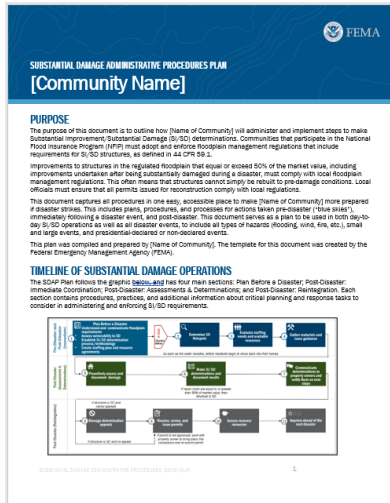
- Understand the basics of administering compliant SI/SD procedures, including the benefits of creating an SD administrative procedure

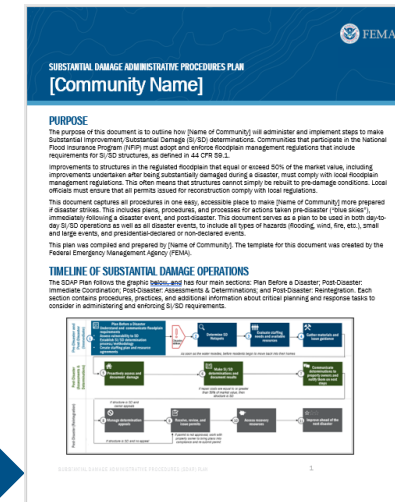
**Before the workshop:**

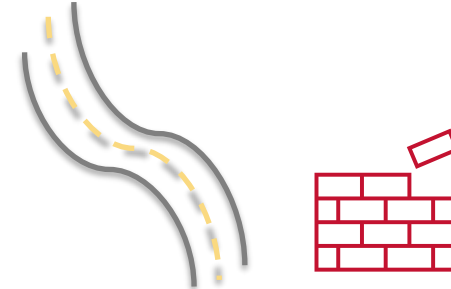
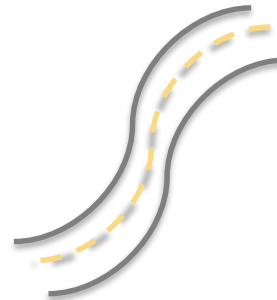
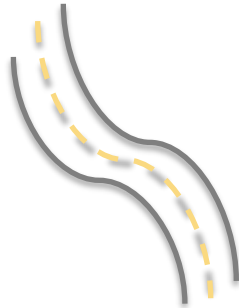
## Federal and State Contacts

## Financial Reimbursement for Post-Disaster Activities

Financial assistance may be available for reimbursement of floodplain management, building code, and SI/SD activities through Public Assistance Category G, based on changes in the **Disaster Recovery Reform Act (DRRA), Section 1206**.

# Technical Assistance Tables Dynamics

Technical Assistance Tables enables collaborations between communities, sharing methodologies on data collection and how to streamline process to establish a successful Post Disaster SD Mission.

Communities share Ideas on:

- Initial Damage assessment (Targeting pre-identified areas of interest in SFHA)
- Leverage of internal stakeholder (sharing of captured data amongst internal stakeholders).
- SD determination platforms (SDE 3.0 Tools).
- Equipment needs
- GIS Data visualization

# Eligibility for Community Rating System Credits

---

Community Rating System is a voluntary incentive program that recognizes and encourages community FPM practices that exceed the minimum requirements of the NFIP through reductions to flood insurance premiums.

## **Activity 512.d: Substantial Damage Management Plan (SDP) Credits (max. 140 points)**

- SDP1: SDP (40 points available)
- SDP2: FEMA SDE Tool pre-populated (50 points available)
- SDP3: Pre-event mitigation alternatives are considered (50 points available)

## **Activity 430: Higher Regulatory Standards (max. 110 points for SD-related elements)**

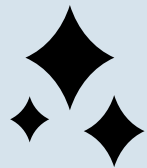
# Local Mitigation Strategy (LMS) – new requirements for LMS updates

---

## Element C: Mitigation Strategy Requirements

C2. Does the plan address each jurisdiction's participation in the NFIP and continued compliance with NFIP requirements, as appropriate? (Requirement 44 CFR § 201.6(c)(3)(ii))

C2-a. The plan must describe participation in the NFIP for each participant, as applicable, in accordance with NFIP regulatory requirements. The following information must be provided for each participant.



5. Description of how participants implement the substantial improvement/substantial damage provisions of their floodplain management regulations after an event.
