Class A: Any person of good character who at the time of application for membership has served as a Golf Course Superintendent for more than three years and is currently employed in such capacity.

Class B: Any person of good character who at the time of application has less than three years of experience as a Golf Course Superintendent and is currently employed in such capacity.

Class C: Any person of good character who at the time of application for membership is currently employed as an assistant to a Golf Course Superintendent.

Class S: Any person of good character who at time of application for membership is a full time turfgrass student enrolled in a formal course of education in a recognized Florida school

Class AA (Lifetime Member): When a 25 year member of a Florida GCSA chapter retires as a Golf Course Superintendent, he may become a Lifetime Member. He shall have all the privileges of the FGCSA except the right to hold office. He shall not pay annual dues. A member with less than 25 years may become a Lifetime Member at the discretion of the Board of Directors.

Class Honorary: The Executive Committee shall have the right to recognize individuals who have made special, valuable contribution to our profession by extending an Honorary (non-dues paying, non-voting) membership to said individual.
