It is designed to train those who will be actively involved in designing temporary traffic control in a work zone. Course material is referenced directly from the: FDS (Index 600 Series), MUTCD (Part 6) Florida's Plans Preparation Manual (FPPM), Florida's Construction Project Administration Manual (FCPAM) and Florida's Standard Specifications for Road and Bridge Construction (FSSRBC). In addition, *flagging operations will be covered in enough detail that an individual who successfully completes this course will be capable of providing basic training as required by the DOT. (details may be found in the [MOT Topic No. 625-01010](#) dated August 2010.)*

**Completion of this course allows individuals to train flaggers to meet DOT's requirements.*

A written test is required and students will receive a certificate of completion and a wallet size card.
