#### **MEETING MINUTES:**

## 1. Updates

- A. Marketing and Membership Committee (Mandy Kustra)
  - i. Please review the membership flyer and email Mandy Kustra or Alison Sanders with suggestions/feedback.
  - ii. Mandy is working on having the Kids Work Zone Safety Calendar Contest in place by 2020. Plan is to award \$500 savings bonds to each winner.
  - iii. Discussed whether Safety Committee participants should be required to be FTBA members.
    - a. Encourage membership but don't require it?
  - iv. A LinkedIn Group will be created for Safety Committee members. Information will be sent out once the group is ready.
  - v. There will be a National Work Zone Memorial at the FTBA annual convention.
  - vi. FTBA socials might be a good way to distribute the flyer and spread the word about increasing membership.

### B. Technology Committee (Bill Phelps)

- i. No significant changes since last meeting.
- ii. Group discussion
  - a. Oxblue builds cameras to monitor construction sites.
  - b. Artificial Intelligence being used in construction safety.
  - c. Cell phone control technology allows certain capabilities to be enabled or disabled on employee cell phones.
  - d. "No Text" program uses a small hidden device to disable cell phone use inside a vehicle.
  - e. Several telematics companies in use including Fleetmatics and Keeptruckn.

#### C. Training Committee (Bryan Stone)

- SCTPP (Safety Certification for Transportation Project Professionals) will be offered to FTBA members.
- ii. ARTBA is working on creating an OSHA 10-Hour Course.
- iii. Group discussion
  - a. In May, SCTPP received ANSI (American National Standards Institute) accreditation. It is now the transportation construction industry's only internationally-accredited safety program.

- Having multiple presenters at trainings will help to make it more interesting/engaging. As long as a qualified trainer is present, others may contribute.
- c. How do we promote SCTPP training to support the long-term goal of getting certified professionals out in the field?
- d. Working on getting a breakout session for safety training in place for the next conference.

## D. Resource Development Committee (Jamie Bertoch)

- i. How do we use our avenues of communication to create an ecosystem of resources?
- ii. Resource development is beginning to resemble a communication strategy.
- iii. Should Safety Committee web page be members only?
- iv. Our existing channels of communication are web page, emails, weekly newsletters, and people.
- v. We need to create a basic framework of resources.
- vi. Become a thought leader in the industry.
- vii. Resources should have value for people at all levels in the industry. Ultimate goal is to improve safety in the industry.
- viii. Jamie will explore the webpage needs in terms of depth and appearance/setup. He will also explore the approval process.
- ix. Phillip Russell volunteered to contribute some case studies as a resource.
- x. Group discussion
  - a. Long term goal should be for the FTBA SC web page to be a "go to" resource for those seeking safety information in the transportation construction industry.
  - b. What have other organizations done to share their resources? How can we avoid re-inventing the wheel?
  - c. Skype could be used as a tool to deliver training virtually. Safety Committee can provide the industry experts and calls can be recorded to be posted as a resource on the website under the heading "Ask the Committee".
  - d. <u>www.Drivingdownheartache.org</u> is a website dedicated to honoring those lives lost in work zone accidents and promoting work zone safety awareness.
  - e. Higher Logic is an app that we might explore as an alternative to LinkedIn if LinkedIn proves to be insufficient for the Safety Committee's communication needs.
