a) 1-3 Definitions. Major Item of Work.: Modify definition to include, any item of work having an original Contract value in excess of 5% of the original contract amount **or \$250,000 whichever is less**

Some projects may not have a single item which exceeds 5% of total contract Allow price adjustments to any item of work which exceeds 125% of original quantity?

- b) 4-3 and 5-12 Extra Work an Claim Specification
 Separate working group to go through proposed changes submitted by FTBA
 FDOT to work with FTBA to set up meeting dates
- c) 7-15 Opening Sections of Highway to Traffic.: Limit exposure to defective material or work. Allow for acceleration costs associated with getting certain areas ready quickly? Strike phrase, "or to any cause other than ordinary wear and tear"? Fixed cap?
- d) 8-10 Liquidated Damages for Failure to Complete the Work: Limit LD's to actual construction engineering and inspection costs when traffic is in its final configuration and the project is functional for its intended purpose.
 - Follow up with FDOT management regarding commitments made to limit LD's to actual CEI costs when facility is open
- e) Fuel & Asphalt Pay Adjustments: Work added by Supplemental Agreement FTBA would like no adjustments made to work added by Supplemental Agreement. Can the system differentiate the work when plan quantity is adjusted by a Supplemental Agreement?
 - How to compile final quantities?
- f) Temporary Attenuators
 - Used to be invoice +20%
 - Cap contractor's exposure?
- g) Pressure testing requirements of 55-4.3.2 Industry requests Department to revisit pressure testing of J&B pipe under pavement
