Bio Similar Legislation

Brock Clay continues to track all potential legislation related to the bio similar issue. Currently, no discussions are currently taking place to push such legislation. However, we are planning to meet with Rep. Lynn Riley (R – Johns Creek) next week to further explore her plans for the issue.

[HB 198 - Licensing Health Navigators](#)

House Insurance Chairman Richard Smith (R - Columbus), introduced [HB 198](#) in order to comply with provisions of the Affordable Care Act, which will allow up to 850,000 Georgians to shop for health insurance via online health exchanges. The new healthcare navigators will help potential customers determine whether they're eligible for Medicaid, commercial plans, or tax subsidies. Such navigators will go through 35 hours of training and be required to submit to continuing education requirements. HB 198 passed the House on Wednesday by a vote of 154-16.

[HB 57 - Synthetic Marijuana](#)

In recent years, the General Assembly has enacted legislation to add synthetic marijuana and narcotic drugs known as bath salts to the list of Schedule I Controlled Substances. However, manufacturers of these substances have changed their formulas so as to avoid the legal effects of these provisions. This bill seeks to once again ban these substances by adding to the definition of Schedule I controlled substances. Rick Allen, Director of the Georgia Drug and Narcotic Agency, testified in favor of the legislation and it passed committee unanimously.

[Governor Nathan Deal Signs SB 24](#)

Wednesday, Governor Deal signed SB 24, which authorizes the Georgia Department of Community Health to plug a \$700 million hole in Georgia's Medicaid budget by extending the levy of the controversial hospital bed tax, or Medicaid financing fee. Passed two years ago, the 1.45% fee is levied upon the gross receipts of hospitals in the state of Georgia.

[State Revenues Increase 10% in January](#)

The week began on a positive note as Governor Nathan Deal announced that state revenues were up 10.4% for the month of January. This represents an increase of \$164 million over January of 2012, and a total increase in state revenues of 5.7% for FY2013. Individual income tax collections increase almost 18% for this period, while corporate income tax collections soared by almost 710%.

[HB 285 - Invest Georgia](#)

[HB 285, the Invest Georgia Act, establishes a new component of Georgia Tech's Advanced Technology Center under the University System of Georgia.](#) As \$.92 of every investment dollar in Georgia comes from other states, Georgia lags grossly behind her neighboring states in the area of technology investment. Under this legislation, Georgia, over the next five years, would sell insurance premium tax credits to insurance companies. The system would begin with \$10 million in 2014 and extend to \$35 million in 2018. The system will be overseen by a 5-member appointed board. The Board will hire a third party administrator who will select venture capital funds to manage investment activities in Georgia. 100% of the investment tax dollars will be returned to InvestGeorgia, as well as 80% of the investment profit.

The legislation has been endorsed by the Georgia Chamber as a scorecard issue, and is being carried by Representatives Allen Peake (R - Macon) and Ed Lindsey (R - Atlanta). It has been assigned to the Ways and Means Committee.

[HB 280 - Updates to Pharmacy Code](#)

This legislation is sponsored by House Economic Development Chairman Ron Stephens (R - Savannah). The bill makes several changes to the code section dealing with the board of pharmacy and makes several housekeeping changes and updates.
