# WELCOME TO DR. GREGORY FENVES, EMORY'S 21ST PRESIDENT

Dr. Gregory L. Fenves begins his tenure as the President of Emory University on August 1. Prior to coming to Emory, Dr. Fenves served as the President of The University of Texas at Austin. Dr. Fenvis served UT Austin for 12 years,

first as dean of the engineering school, then as provost and finally as president.

Dr. Fenves earned a bachelor's degree from Cornell University and a master's degree and Ph.D. from the University of California, Berkeley, all in civil engineering. He began his career in 1984 as an assistant professor in UT's Department of Civil Engineering. He then served more than 20 years on the faculty of University of California, Berkeley, where he became an internationally renowned expert on structural engineering for earthquakes and chair of its top-ranked department of civil and environmental engineering.

For his research in earthquake and academic leadership, Dr. Fenves was elected in 2014 to the National Academy of Engineering, the highest recognition for an engineer in the United States. He has received numerous national awards, including the Presidential Young Investigator Award from the National Science Foundation, the Walter L. Huber Research Prize, the Moisseiff Award and the J. James R. Croes Medal from the American Society of Civil Engineers.

# TITLE IX - ROLE OF ADVISOR

GICA is hosting a webinar created exclusively for Compliance Collaborative members focusing on Title IX – Role of Advisor on Tuesday, August 25, 2020, from 1:30 to 2:30 pm.

The role of a Title IX Advisor has changed dramatically with the adoption of the new Title IX Final Rule. Morphing from the previous role as a "potted plant" to now an active participant in the Live Hearing, individuals who are serving in this important function need to understand their responsibilities and duties. In this webinar we will be defining the Advisor role from a statutory perspective and as well as providing an overview of the Title IX process and where the Advisor "fits" into the process.

The Advisor role is defined by statute; however, institutions also have some flexibility in defining this role. Thus, this webinar is designed to be a supplement to institution-specific training of Title IX Advisors. It is suggested that Advisors attend this webinar to receive an overview of their statutory responsibilities. It is suggested that, after this webinar, the institutions provide specific training on the Advisor's role in their specific Title IX policy and process.

#### TITLE IX - HEARING PANEL MEMBER TRAININGS

GICA is hosting in-person and online trainings created exclusively for Compliance Collaborative members focusing on Title IX – Hearing Panel Member Training in September 2020. The exact dates and locations of these in-person and online trainings have not yet been finalized. Dates will be announced on the GICA website and through emails.

The role of the Hearing Panel members has changed with the adoption of the new Title IX Final Rule. Panelists/decision-makers now play a more active role in the Live Hearing. This training is designed to provide a base knowledge of the role of the Hearing Panel members. Since institutions do have some

flexibility in determining how a Live Hearing is conducted, each institution is strongly encouraged to also provide institution-specific training of Hearing Panel members. To understand their role in this process, attendees will be provided an overview of the new terminology of what constitutes sexual harassment as well as an overview of the changes in the investigative process. Training will highlight the changes in the Live Hearing and appeal process and will use newly developed Title IX specific videos to walk through a Title IX hearing.

# PUBLICATION OF COMPLIANCE RISK ASSESSMENTS: AN INTRODUCTION

GICA Compliance Collaborative Program Consultant, <u>Judy Spain</u>, J.D., CCEP, recently wrote her second book, *Compliance Risk Assessments: An Introduction*, which is published by the Society for Corporate Compliance and Ethics. The book focuses on the nature of risk and how compliance risk management differs from other forms of risk management, including enterprise risk management. It is designed to walk readers through the risk assessment process from identifying the risk universe to assessing the likelihood of occurrence of a risk as well as the impact of the risk to developing a compliance risk survey to developing a risk mitigation plan. The book also outlines commons pitfalls and ways to building toward continuous improvement.

Judy is also the author of *Higher Education Compliance: Blueprint for Success,* which is the only book focused on compliance in higher education. Prior to working with the GICA Compliance Collaborative Program, Judy served as General Counsel and Chief Ethics and Compliance Officer at Eastern Kentucky University and Manhattanville College, where she developed and implemented compliance programs.
