REID TECHNIQUE OF INVESTIGATIVE INTERVIEWING AND POSITIVE PERSUASION

All GICA members are invited to attend the Reid Technique of Investigative Interviewing and Positive Persuasion on March 11, 2020, at Brenau University from 9:00 am to 4:00 pm. This unique training opportunity will provide our members the opportunity to learn from industry leader Joe Buckley, President. John E. Reid and Associates began developing interview and interrogation techniques in 1947. The Reid Technique is now the most widely used approach to question subjects in the world; has been recognized by the United States Supreme Court; and is the recognized gold standard for interviews.

Training program consists of three primary topics: Behavior Symptom Analysis; Behavior Analysis Interview; and Seven Steps of Positive Persuasion.

Who should attend:

Title IX Coordinators, Deputy Title IX Coordinators/Investigators, HR Professionals, Student Conduct Officer, Police Chief, police officers, etc. - anyone who is involved in interviewing students, employees, or faculty for any type of investigation.

How many can attend if a GICA Compliance Collaborative institution:

Maximum of 7 persons; no cost to GICA Compliance Collaborative member institutions; registration due by no later than February 15, 2020

How may can attend if NOT a GICA Compliance Collaborative institution:

Maximum of 5 persons; cost is \$200 per person; 5 members can attend for \$700; registration due by no later than February 15, 2020

After February 16, 2020, we will open up any available seats; GICA Compliance Collaborative member institutions will have first preference to bring more persons.
