Key Points:

- Be clear, concise and polite.
- Identify yourself as a stakeholder.
 - o Do you represent a larger group?
- Present the problem, support it with facts, and add a personal story.
- Propose a solution.
- Offer to answer questions.
- Thank them for their time.

Structure:

- Your information
- Recipient information
- Introduction
- Problem
- Facts and reasoning
- Personal story
- Call to action
- Closing Thank You
- Contact info
- Signature respectively, sincerely or appreciate your consideration

Tips:

- Polite and respectful
- Focus on one issue
- Keep it brief typically one page
- Simple language readers may not understand technical jargon
- Personalize how, why it affects you
- Be specific
- Proofread and Review

As the October 15th Board Meeting approaches, I wanted to offer my support for adopting the amended codes currently being considered. I understand there may be some reluctance to adopting the 2024 versions of the IBC, IRC and IECC but wanted to offer the following perspective.

After adopting the 2009 IECC in 2010, It took over 10 years to adopt the 2018 IECC. It's hard to calculate the hours spent reviewing and vetting 2012, 2015 and 2018 versions. During which time turmoil significantly increased between various stakeholders and industry participants. That turmoil extended to the legislature multiple times resulting in various changes in statutes and administrative rules.

The end result produced more of "us versus them" than a practical solution. Unfortunately, the code that was finally "approved" for Idaho wasn't different than what we had proposed amending for many years prior. Delaying it, versus amending it, only adds time for people to define areas of influence or control.

I know that "no codes are perfect" but we have legislative directives for amending codes and considerable flexibility in doing so. Our focus should be on what is the greatest benefit to homeowners with the least disruption between the parties trying to deliver that benefit.
