

The Constitution and Bylaws of the INMM Korea Chapter as of June 2006

CONSTITUTION

Article I – Name

Section 1 The name of this membership organization shall be the Korea Chapter of the Institute of Nuclear Materials Management (hereinafter referred to as the *Chapter*).

Article II – Purpose

Section 1. Functioning within the Constitution and Bylaws of the parent organization, the Institute of Nuclear Materials Management (hereinafter referred to as the “INMM”), this Chapter is formed to provide:

- a. Participation at a regional level in the activities of the INMM by those members of the Chapter.
- b. Encouragement of participation by nuclear materials custodians and fissile materials handlers in activities relating to nuclear materials.
- c. The promotion of research in the field of nuclear materials management.
- d. The increase and dissemination of nuclear materials management knowledge through meetings and professional contacts.

Article III – Membership

Section 1 Membership in the Chapter shall be open to members in good standing of the INMM and to those persons active in nuclear materials management and related fields who have an interest in advancing the objectives of the Chapter.

Section 2 Any reputable firm, association, institution, or corporation, or subdivision of any such, may become a Sustaining Member of the Chapter under the conditions and with the rights specified in the bylaws.

Article IV – Officers

- Section 1 The officers of the Chapter shall be a President, Vice President, Secretary, and Treasurer.
- Section 2 There shall be an Executive Committee which shall be composed of the current officers of the chapter, **six (6)** members at large elected from the membership of the chapter, and the immediate past President of the Chapter. The President of the chapter shall be the President of the Executive Committee.

Article V – Meetings

- Section 1 There shall be at least one meeting of the Chapter each year. The Executive Committee shall determine the date and place of the meeting(s).
- Section 2 The Secretary shall send a notice of each meeting to every member at least two (2) weeks in advance of such meeting.

Article VI – Headquarters

- Section 1 Headquarters of the Chapter shall be located in **Daejeon City**, Korea.

Article VII – Amendments

- Section 1 This Constitution may be amended by the consent of two-thirds of those members voting on a ballot mailed by the Secretary to each member at least two (2) weeks before the date specified for the receipt by the Secretary of the returned marked, sealed ballot. The Secretary shall supply with the ballot an envelope within which the marked ballot shall be sealed and returned to the Secretary in an outer envelope bearing the member's signature.
- Section 2 Proposed amendments may be originated by:
- a. The Executive committee upon approval of the proposed amendment by a majority of the members of that Committee.
 - b. Five (5) members in good standing who submit a proposed amendment in writing over their signatures to the Executive Committee through the President of that Committee.
- Section 3 The Secretary shall mail to each member in good standing a copy of the proposed amendment

along with the ballot referred to in Section 1 of this article.

Section 4 The Secretary shall notify each member of the results of the voting on a proposed amendment.

Article VIII – INMM Constitution

Section 1 Nothing in this Constitution shall conflict with any provision of the Constitution of the INMM and if there is no relevant provision for the question at hand, the Constitution of the INMM shall apply mutatis mutandis.

Article I – Membership

Section 1 Grades

The constituted membership of the Chapter shall consist of full members, associate members, student members, and sustaining members. Voting privileges in the Chapter will be extended to full members and associate members only. Only full members may hold offices of President, Vice President, Secretary, and Treasurer. Both full members and associate members may hold positions as members at-large on the Executive Committee.

Section 2 Members

- a. A candidate for member, associate member or student members must file with the Secretary a completed application form as issued by the Chapter, accompanied by the membership fee. The application shall be promptly forwarded by the Secretary to the President of the Executive Committee. The Executive Committee shall review the application and vote upon admitting the candidate to membership. If approved, the application shall be so certified approved by the President of the Executive Committee.
- b. In the event that a majority of the members of the Executive Committee vote to reject an application for membership, the President of the Executive Committee shall return the originally submitted membership fee to the applicant along with the notice of rejection.
- c. Full members of the Chapter will be “regular members” in good standing of the parent organization as described in Article I, Sections 1 to through 4, of the Bylaws of the INMM.
- d. Student members, at the time of admission to that grade, shall be at least eighteen (18) years of age and of good character; shall be engaged in or interested in nuclear materials management, or in an allied fields of a technical or administrative nature; and shall be

enrolled as a student at the college level in an accredited educational institution approved by the Executive Committee. Student Members shall be assessed dues substantially lower than those assessed members.

- e. Associate members will be all other persons. The application form shall provide associate membership in the Chapter for a period shall not to exceed three (3) years.
- f. Since many private corporations or divisions thereof, governmental agencies, and other collective groups share **an interest in** the objectives outlined in the **Article II** of the Constitution of the Chapter and may wish to make financial contribution on a regular basis to encourage and assist the endeavors involved in meeting these objectives, such contributing groups, upon their application, may be recognized by designation as sustaining members. The funds collected from these dues shall be restricted for use in technical activities of the Chapter such as standards, technical committee, technical staff, and special publications.
- g. Each sustaining member shall designated and be represented by an individual employed by or associated with it; and such individual shall, on behalf of the sustaining member organization, have all the rights and privileges of a full, member. Sustaining members shall be privileged to send a number of their employee to sponsored meetings of the Chapter at a reduced rate.
- h. Any resignation from the Chapter shall be submitted in writing to the President of the Chapter.

Article II– Dues

Section 1 The dues for membership in the Chapter shall be determined by the Executive Committee.

Section 2 All regulations regarding payment of dues shall be made by the Executive Committee.

Article III– Elections of Officers

Section 1 All officers of the Chapter and the **six** members at large of the Executive Committee elected from the membership of the Chapter shall be elected by ballot mailed to each member of the chapter. The candidate for each elective position receiving the vote of a majority of those

voting shall be elected. If votes are cast for more than two candidates for a given elective position and if none of the candidates receive a majority of the votes, then a special election shall be held in which the two candidates who received the highest number of votes in the first election shall be candidates for the special election; the candidate receiving the vote of a majority of those voting in the special election shall be elected. If a tie results in the balloting for two or more candidates for an elective office, the Executive Committee will determine the method for resolving such tie.

Section 2 Elected officers shall serve for a term of one year beginning October 1st of each year, or in the event of a delayed election, until their successors are elected. In the event of a delayed election, the newly elected officers shall serve until September 30 of the year following their election or until their successors are elected. The outgoing President shall serve as a member of the Executive Committee **for the service term of his predecessor.**

Section 3 Each of the six members-at-large of the Executive Committee elected from the membership shall serve for a term of two years. **The reappointment is allowed for the following two years just one time.** Terms of membership shall be arranged to elect **two or four** members in odd-numbered years, and the remaining member in even-numbered years. The retiring members of the Executive Committee shall not be eligible for election to the Executive Committee until the expiration of two years, except for members-at-large who may be nominated for office positions. In the event that a vacancy occurs in these six positions of the Executive Committee, the Executive Committee shall appoint a successor to fill the unexpired term in which the vacancy occurs. ✓
