



2017 Nomination/Qualification Form Region Chair or Region Vice Chair

AUTHORIZATION: As noted in Article V., Section 1, Paragraph b. and c. and Article VI, Sections 2 and 3, Paragraph b., of the LeadingAge Florida Bylaws

Region Chairs shall serve as members of the Board of Trustees and shall be the primary liaison between the Regions and the Board. The Board shall be comprised of the elected Officers, the Immediate Past Chair, the Region Chairs; two At-Large Trustees; one Associate Trustee; and any LeadingAge Florida elected representatives to the LeadingAge, Inc., Policy Congress. **PROCESS: The Region Chairs and Vice Chairs shall be elected by the members of the applicable Region who are eligible to vote pursuant to Article V. Elections for Region Chairs and Vice Chairs may be conducted at a meeting of the members of the Region, or by mail ballot in accordance with Article IV, Section 6 of the Bylaws. Proxy voting is permitted. Region Chairs shall be elected prior to the annual conference and shall take office at the close of the annual conference.**

QUALIFICATIONS:

- A. An applicant/nominee must be a member in the geographic Region for which he or she will represent.
- B. An applicant/nominee must be a designated official representative of a LeadingAge Florida Regular Member Community in the applicable Region.
- C. An applicant/nominee must be affiliated with a LeadingAge Florida Member Community or Community belonging to an out-of-state association of homes for the aging for at least two (2) years.
- D. If elected to a Region Chair position, the Region Chair shall not serve simultaneously in any other elective office of the Association.
- E. Application Deadline: **April 21, 2017**
- F. **Term Limit:** Two-year term. **(Please note – the positions of Region Chair and Vice Chair of Membership - Central Region and Vice Chair of Membership – Southeast Region are currently filled.)**
