Stewardship Award – Act in a manner worthy of trust and respect.

Recognizes an individual or organization that has advanced public trust and confidence in aging services through public service, collaboration, media or other efforts to educate consumers and help them make informed choices.

***Criteria:** Nominee shall demonstrate scope of public impact and community benefit; has furthered public trust and understanding of aging services.*

Vision – Respect the past. Lead today. Create the future.

Recognizes an individual or organization that has made an outstanding contribution of service to aging and/or to the association through inspirational leadership and vision.

***Criteria:** Nominee must demonstrate leadership in the field by exhibiting vision – the ability to see with the end in mind; serving as an advocate and pioneer in the field; mentoring others with inspirational involvement in and positive promotion of aging organizations; demonstrating community involvement; and/or extraordinary, exceptional and/or unique contribution to LeadingAge Virginia and/or LeadingAge, impacting the state, regional or national aging field and services. Retired individuals are eligible.*

Power of Purpose – Changing the way Virginians live and age.

Recognizes a front-line caregiver who demonstrates remarkable commitment to the people they serve.

***Criteria:** Nominee shows compassion, volunteers for extra work, mentors new employees, tackles problems in fresh ways, is open to change and/or goes the extra mile to enhance the lives of those they serve. Their commitment to mission – the power of their purpose – is evident every day.*
