## Level 3 lockdown Regulations announced

Earlier today, Honourable Minister Nkosazana Dlamini Zuma's Level addressed the nation with regard to level 3 Regulations.

The regulations apply from 1 June 2020 and allow for the complete reopening of the industry and while we do encourage members to read the entire document, we draw attention to the following key areas.

Members should take heed of clause **33 (4) a** – were in terms of Form 2 Annexure A, people are allowed to move between provinces, metropolitan areas, districts and hotspots, providing that they are performing work permitted under level 3 and that they are possession of a permit issued by the employer.

**Clause 46**, "operation of economic and Public Sector in particular 46. (6) and (2) are extremely pertinent.

**46. (6)** Specifies requirements Construction Industry firms and other manufacturing operations that employ more than 500 people.

**46. (2)** Refers to businesses that have more than 100 employees, making provisions to minimise the number of employees in the workplace.

**Clause 47** deals compliance matters and business that are not allowed to operate under specific economic inclusions.
