Pope Scholarship Award

Requirements and Eligibility

- 1. The Pope Scholarship is designed for students whose studies are primarily directed towards the mortgage banking or mortgage-financing field (i.e., real estate, banking and economics). Applicants must apply and state why they are seeking the scholarship and what mortgage banking goals have been set.**
- 2. Applicants must currently be a rising junior in a 4-year accredited college or university in either North Carolina or South Carolina. Applicants may be the children of MBAC members; however, the contributions of the parent-member of MBAC will not be considered in the selection of recipients.**
- 3. Applicants must reside in either North Carolina or South Carolina. They may attend a school not necessarily in the same state as they reside, so long as it is a North Carolina or South Carolina college or university**
- 4. The need for the scholarship will not be the basis for the decision of the committee.**
- 5. A grade point average of 3.0 has been established and is required, but the committee considers grades only a part of the total review of each applicant.**
- 6. Applications must be in the hands of the committee by July 31.**
- 7. The scholarship will be in the amount of \$3,000 for each winner and will be awarded in four equal installments during the recipient's junior and senior year.**
- 8. Please provide a current certified transcript and a photograph suitable for reproduction.
