SUBJECT: Energy Efficiency Filings

IAMU is again assisting municipal gas and electric utilities complete energy efficiency regulatory filings due throughout 2013. The three filings that IAMU will be assisting utilities with are shown below. If you would like IAMU to assist you with your energy efficiency reporting requirements, please complete and return the data request sent with this email.

1. **IUB Biennial Energy Efficiency Plan**

Due January 1, 2014

Required: Municipal Gas and Electric Utilities

All municipal gas and electric utilities are required to submit a Biennial Energy Efficiency Plan to the Iowa Utilities Board on January 1st of even-numbered years. The next plan is due on January 1, 2014. As in the past IAMU is planning to coordinate a statewide joint filing that includes all municipal utility results. The report must include:

- Results of energy efficiency programs for 2011 and 2012. Results include programs/measures offered, number of participants spending, energy and demand savings, and demonstration that programs are cost-effective.
- New energy efficiency savings goals for 2014 and 2015

2. **EIA-861 Schedule 6**

Due April 30, 2013

Required: Municipal Electric Utilities

IAMU helps utilities calculate the energy and demand savings from their energy efficiency programs for the EIA-861 schedule 6. All municipal electric utilities are required to file the EIA-861 or EIA-861s (short form of the report)

Important: This year the EIA has implemented a short form of the EIA-861 for some of the smaller utilities. If your utility is required to file the short report (EIA-861s), schedule 6 has been reduced to a "Yes/No" question and you do not have to report efficiency program details. If you had any energy efficiency program or demand response program, you should answer "yes" to the question.

3. WAPA Minimum Investment Report (MIR/IRP)

Due: Varies by utility

Only Electric Utilities who purchase power from WAPA are required to file

IAMU will compile all data and submit all forms and letters to WAPA to verify compliance. IAMU will copy you on the submission of all data and letters to WAPA.

Energy Efficiency Plan Pricing

Because much of the work involved in preparing each of the three reports is similar, IAMU will charge a flat rate for preparing your utility's energy efficiency plans. The fees are outlined below. To determine which cost category your utility falls into, please see the following page.

<u>Electric Utilities*</u>	<u>Price</u>
Small	\$200
Medium	\$300
Large	\$400

<u>Gas Utilities</u>	<u>Price</u>
Small	\$100
Medium	\$200
Large	\$300

Combined Electric and Gas

And electric price and gas price, subtract 10%.

Filing Joint Report to IUB (without performing savings calculations)

\$75 If your utility only requires IAMU to include its energy efficiency plan in the report to the IUB, then the charge is \$75. The utility will be responsible for compiling all data in compliance with the IUB.

*If IAMU complete your EIA 861 Schedule 6 in 2012, the charge will be credited against this year's charge.
