

REPORTING TO SPECIALTY BOARDS

If you would like the DCMA to report a diplomate's participation in your program to one of these 5 specialty boards (American Boards of Anesthesiology, Pathology, Surgery, Orthopaedic Surgery, or Thoracic Surgery), you must provide board specific disclosures to learners in your announcements (website, emails, flyers, etc.) **and** within your program. Your announcements and program must include the following disclosures as well as the board-specific disclosures below for the boards in which you wish the DCMA to report:

Reporting of MOC Credit

Many specialty Boards will allow their diplomates to self-report the credit earned. However, the DCMA can report the MOC credit claimed for the following boards using the diplomate's Name, Board ID, and Date of Birth (month and day): Anesthesiology, Pathology, Surgery, Orthopaedic Surgery, and Thoracic Surgery. This information must be supplied accurately on the evaluation form to ensure credit can be reported. (Board ID is optional for the ABOS and ABS).

By claiming the MOC credit on the Evaluation form, you are giving the DCMA permission to use this information/data to report your participation to these Boards via the ACCME Program and Activity Reporting System (PARS).
