New DOJ Pawn Systems: Where is your City?

The California Department of Justice has released the California Pawn & Secondhand Dealer System (CAPSS) that was outlined in 2012 by Assembly Bill 391. CAPSS offers the pawn and secondhand dealer industry tools to manage and renew their operating permits and electronically report business transaction to law enforcement. CAPSS is designed to replace the paper "JUS 123" forms that dealers previously provided to law enforcement when secondhand items were acquired from members of the public. Percentage-wise, the Northern Chapter had the largest growth rate of 22%, increasing membership from 184 to 225. Time to Renew Your MISAC Membership

If you haven't renewed your MISAC dues yet, it's past time to do so! The MISAC membership year runs from September 1 – August 31 and those who have not re-upped by October 1 are subject to being dropped from the membership rolls and the MISAC listserve.

If you're not sure whether or not you have renewed for the 2016-17 membership year, it is easy enough to find out. Just log into your MISAC membership account and click on the "Members" tab. Scroll down and click on "Manage Your Profile." Under "Invoicing, Payments & History," click on the "Membership" option. In the grey box, it will show your name, the type of membership you hold, and then will give you a date showing when your membership expires. If this date is anything other than 8/31/2017, you need to remit your 2016-17 dues payment. The only exception are those who are Lifetime Members.

Bill Me!

MISAC uses YourMembership (YM) as our online database program. Through YM, MISAC members can renew their memberships, register for MuniTech Academy classes, buy items from the online store, and much more.

When making payments for items through the MISAC website (i.e., YM), buyers are offered two options – one is to pay with a credit card and the other is the "Bill Me" option. The credit card payment option is fairly straightforward but we have had some issues with the "Bill Me" option that we would like to clarify.

When you click on the "Bill Me" option, YM immediately and automatically generates an invoice for you and attaches it to your membership record. You will not receive a separate email from YM or from MISAC staff with a copy of the invoice. As such, when you select the "Bill Me" option, you can (and should) immediately print out a copy of the invoice and hand it over to your accounting department so they can make the payment.
