Since joining the MBA in October 2018, I've noticed we receive quite a lot of calls requesting lawyer referrals. We started tracking them and we are receiving over 10+ calls on a daily basis/100 + calls a month from people in the community feeling they need. Our **Find a Lawyer** program allows the community to search for Mobile practicing attorneys by 43+ different areas of practice.
