MWL Bylaws: ARTICLE I: MEMBERSHIP; MEETINGS OF MEMBERS:

Section 1. Membership

This corporation shall have members and associate members. A member of this corporation is (a) any person who has received a juris doctor at either an accredited law school or a law school applying for accreditation in any jurisdiction of the United States, or (b) any law student in good standing at an accredited law school or a law school applying for accreditation in any jurisdiction of the United States. Membership and associate membership is granted upon the payment of annual dues.

Existing members who become suspended or disbarred from the practice of law in any jurisdiction must notify the corporation of the suspension or disbarment, at which time membership will be revoked and all membership dues will be forfeited. Membership can be reinstated if: (a) The individual provides the corporation with verification from the appropriate licensing body that the individual is currently a member of the bar in good standing; and (b) Receipt of annual payment of dues. If reinstated within the same fiscal year in which their membership was initially revoked, the individual would not need to pay dues a second time.

ARTICLE V: NOMINATING COMMITTEE

Section 3. Qualifications

All nominated individuals shall be current members in good standing of the corporation and shall meet any other qualifications as reasonably determined by the Board of Directors.
