C. National Treasurer: We need to make note that NAPMW was recently the victim of a wire fraud scam. A sophisticated phishing email resulted in a loss to the association of \$5,035. Because of our proactive action as soon as we learned of the fraud, we have been able to recover nearly \$2,000.

We are working with the banks involved to continue to collect on the remaining amount. We have spoken with legal counsel on the matter, and have looked at our financial systems to ensure that this does not happen again. The sum is not reflected on this month's financials because the matter has been held in suspense while we did our due diligence to investigate and fix the problem. The sums will be reflected on next month's financial statements.
