



## **NASAO | Airspace and NextGen Committee | Revised Charter & Language Considerations**

**Mission:** To monitor Airspace and NextGen impacts, evaluate and develop NASAO's priorities on critical NextGen/Airspace/Technology issues and work with congress and/or the Federal Aviation Administration and the aviation industry to address concerns and related issues to insure a safe aeronautical transportation system.

**Purpose:** To work through and beyond the FAA's NextGen deadline of January 1, 2020, by reviewing the impacts on the aviation community nationwide relative to ADS-B, airspace coverage, aircraft equipage and coverage. Reviewing the impacts of other airspace (MOA, restricted, special use, TFR, ADIZ, remote ATC, etc.) on manned/unmanned general aviation, commercial aviation and private activity operations nationwide. Monitoring and providing input on the development of emerging NextGen air traffic control technologies such as remote air traffic control towers. Partner with other NASAO committees or entities when needed for a unified/comprehensive approach to address related issues impacting the National Airspace System.

### **Objectives:**

- Promulgate best practices and work to advance the NASAO overall mission
- Identify existing issues and needed action related to NextGen, Airspace and Related Technologies
- Identify partnerships needed to advance and address specific issues
- Identify any subcommittee work that may be needed
- Collaborate with other NASAO committees
- Coordinate how the outcomes of the committee will be shared with the NASAO membership
- Provide support, review and research, respond to inquiries, and propose recommendations to the NASAO Executive Board

### **Goal(s):**

- To clearly articulate NextGen/Airspace and Technology issues, concerns, improvements, and developments and how they should be addressed.

### **Committee name:**

- Airspace and NextGen Committee

### **Membership:**

- State Directors and staff are eligible to serve on the Committee with full voting privileges.
- Business partners may serve on the Committee in a non-voting role.
- Federal officials and other subject matter experts may participate on the Committee in a non-voting role.

### **Leadership:**

- Beginning January 2019, the Chair of the committee will serve a 1-year term (from NASAO Annual Convention to NASAO Annual Convention) at the pleasure of the NASAO Executive Committee. The Airspace and NextGen Committee will make a Chair recommendation via meeting, teleconference or e-balloting, to the Executive Committee 30 days prior to the Annual NASAO Convention. A Chair will be selected upon recommendation to the Executive Committee.

### **Meeting schedule:**

- The committee will regularly meet quarterly via teleconference and hold a meeting at the annual convention. The committee may call for an additional meeting based on need, topic discussion and desire of the committee membership. Additional/Special meetings may be called in conjunction with the NASAO Legislative conference, by the Chair or committee request.
