## Fall 2021, 40-Hour Divorce Mediation Training, Online

Due to the Covid-19 pandemic, the NJ Supreme Court, and NY Part 146, have approved this training to be delivered online, live You must attend all five days, and you must have a device with a camera and microphone, and sufficient internet speed to participate in this class.

Divorce mediation is rapidly becoming the preferred method for couples to get divorced. If you are an attorney, mental health or other professional and want to become a divorce mediator and receive training from New Jersey's premier association of professional mediators, you should take this course.

- The course fee of \$1,550 has remained the same since the fall of 2018. It includes:
  - 1. Membership to NJAPM through 9/30/2022 with your full payment
  - A course manual that will be mailed to you in advance of the class as long as you register by September 30
  - 3. Access to files, forms and additional training materials via DropBox
  - 4. A 40-Hour certificate e-mailed to you following the class; suitable for framing

- If you have made a deposit, the balance of \$1,250, must be made by September 15
