CORONAVIRUS PREVENTION


We received the following OSHA guide and felt it was important for members to have.

The US Department of Labor OSHA has published a "Guidance on Preparing Workplaces for COVID-19". Please find below the introduction to the guide.

To reduce the impact of COVID-19 outbreak conditions on businesses, workers, customers, and the public, it is important for all employers to plan now for COVID-19. For employers who have already planned for influenza pandemics, planning for COVID-19 may involve updating plans to address the specific exposure risks, sources of exposure, routes of transmission, and other unique characteristics of SARS-CoV-2 (i.e., compared to pandemic influenza viruses). Employers who have not prepared for pandemic events should prepare themselves and their workers as far in advance as possible of potentially worsening outbreak conditions. Lack of continuity planning can

result in a cascade of failures as employers attempt to address challenges of COVID-19 with insufficient resources and workers who might not be adequately

trained for jobs they may have to perform under pandemic conditions.



The Occupational Safety and Health Administration (OSHA) developed this COVID-19 planning guidance based on traditional infection prevention and industrial hygiene practices. It focuses on the need for employers to implement engineering, administrative, and work practice controls and personal protective equipment (PPE), as well as considerations for doing so

This guidance is intended for planning purposes. Employers and workers should use this planning guidance to help identify risk levels in workplace settings and to determine any appropriate control measures to implement. Additional guidance may be needed as COVID-19 outbreak conditions change, including as new information about the virus, its transmission, and impacts, becomes available.

DOB AUDITING OP-128 SUBMISSIONS

LOCAL LAW 152 UPDATES

We will be sending out an update early next week regarding the status of where we believe the process is at this time.

The MPC still recommends that members wait until the issues are resolved prior to commencing with these inspections. The current coronavirus situation is another reason to postpone. While most inspections are able to be conducted, any restoration work may be hindered due to lack of access to the work areas.

2020 SCHOLARSHIP PROGRAM

Now accepting applications for the 2020 Scholarship Program!

Application Deadline is Friday, April 17, 2020!

Each year, the Master Plumbers Council offers scholarships to honor and further the education of worthy students. The program is divided into two levels, High School (Entering Grades 9-12) and College/Post High School. Two high school students will each be awarded \$1,250 and two college students will each be awarded \$2,500.

- In order to be eligible for a scholarship, the applicant must be either:
 The child or grandchild of a NYC Licensed Master Plumber who has been a member in good standing of the MPC for a minimum of one year preceding the application date or a child or grandchild of a deceased member who met such membership requirement.
- The child or grandchild of an employee who has been employed for a minimum of one
 year by a Licensed Master Plumber who is a member of the MPC. These applicants
 must be sponsored by a Master Plumber Member of the MPC.
