NYC Department of Buildings Permit and License Renewal Extension

Dear Department of Buildings Licensee/Permit Holder:

The New York City Department of Buildings (DOB) is writing to remind you of the upcoming change to License and Permit Renewal Expiration Dates.

Effective August 7th, 2020, all Licenses/Registrations and Permits issued by DOB are no longer subject to automatic extensions resulting from the COVID-19 emergency.

All Licenses/Registrations and Permits issued by the Department of Buildings with an **original expiration date on or after August 7, 2020** will expire on that original expiration date per <u>Mayoral Emergency Executive Order No. 134</u>.

Licenses/Registrations and Permits that were subject to <u>Mayoral Emergency Executive Order No. 107</u>, subsequent orders, and <u>Local Law 57 of 2020</u>, which were automatically extended through August 6, 2020, will expire according to the below schedule.

Original (Pre-COVID) Expiration Dates	Final Extension Date
March 12, 2020 – March 31, 2020	September 30, 2020
April 1, 2020 – April 30, 2020	October 31, 2020
May 1, 2020 – May 31, 2020	November 30, 2020



June 1, 2020 – June 30, 2020	December 31, 2020
July 1, 2020 – August 6, 2020	January 31, 2021

NYC Department of Buildings Reopening Guidance - NYC Construction Activity

What do you need to do on an actively permitted job to remain compliant? -- Are you responsible or are your subs?

Message from the Executive Board:

Since July 8, 2020, the DOB has been issuing Stop Work Orders and violations to anyone who is not in compliance. From what we have heard, inspectors are bending over backwards to provide contractors with the



opportunity to prove compliance. We have still been getting questions about what happens if you are not actively working on a job, who is responsible for your subs on the job.

The Committee drafted a sample package of everything you should need to be compliant. The package contains a link to the Service Notice on how to get a Stop Work Order lifted. The MPC also sent a list of questions and concerns to the DOB and has their answers available for members to reference. **This information was originally sent to members on July 8, 2020.**

How to Apply for a DEP Water Meter Permit or Break Seal Permit via Email (Updated 07-31-20)

Message from the Executive Board:

On Friday, July 10th, the DEP sent us the procedure to return a meter permit. The entire process from obtaining a permit to return a completed form is now complete.

The DEP requests that you put the required amount of money in your account prior to submission of the application. This will save time in processing your application.

The next item is that, due to the COVID-19 pandemic, they are taking 5-7 business days to process an application. One of the reasons that the timeline has started to stretch out is that a few plumbers keep emailing them to ask about their application. Please be considerate and do not contact them to follow-up on your application until 5 business days have passed.

*Please be aware that the DOB requires you to take this course within one year of your license renewal date.

Licenses/registrations and permits that were automatically extended through August 6th, 2020, will expire according to the following schedule.

DOT Insurance

"It has come to the NYC Subsurface Plumbers Association's attention that there is a large flaw in the enforcement of Permittee's insurance requirements by the DOT. There are at least four (4) exclusions in insurance coverage that virtually nullifies coverage for a Permittee performing sewer, water or excavation work in the City of New York. We have contacted Commissioner Trottenberg regarding this issue but have yet to receive a response.

These exclusions are not addressed by the DOT in the current "Certification by insurance broker or agent" letter required by the DOT. Though we are active participants in the regularly scheduled DOT CAC meetings, the DOT has declined our request to add this important point as an agenda item.

Current DOT enforcement of insurance requirements leaves an exposure for all concerned parties and provides an unfair advantage to both unscrupulous plumbers and insurance brokers alike. <u>DEP ANNOUNCES ROUND 2 OF WATER CONSERVATION AND REUSE GRANT PROGRAM</u>

Property Owners Can Receive Funding for Water Conservation and Reuse Projects

The New York City Department of Environmental Protection is rolling out Round 2 of their Water Conservation and Reuse Grant Pilot Program following a successful pilot of the program over the past year. The grant program aims to conserve the City's drinking water supply, with a corresponding reduction of flows into the sewer system, by reimbursing commercial, industrial, and multi-family residential property owners who invest in water efficiency projects, including low-flow fixtures, as well as innovative water saving technologies such as on-site water reuse systems.
