

## Q2 How many accounts were not disconnected as a result of the order, January 1 to May 31, 2020?





# Q3 How many accounts were reconnected as a result of the order, January 1 to May 31, 2020?





#### Q4 Estimated average cost per reconnection?









#### Q10 Current COVID-19 illness:








