3. Cancellations must be received in writing at least 5 weeks prior to the scheduled event date. There will be no refunds or credits for "no-shows" or last minute cancellations.
4. Vendors are limited to no more than 2 onsite representatives. A 6-foot clothed exhibit table is provided by OCTLA.
5. Vendors may collect business cards for a raffle drawing only during the reception hour. Drawings are limited to one.
6. If the vendor remains onsite during the MCLE presentation, all conversations must be taken outside.
