The FIAP Collections Service

The FIAP Collections Service manages The Artistic Patrimony of FIAP. Patrimony* (according to the Cambridge Dictionary) means the "valuable objects, buildings, ideas, etc., that a society gets from the people who have lived in the past." These images are the legacy, the heritage of the FIAP. This legacy or heritage is made up of the photographs submitted to the Service by applicants for FIAP distinctions.

A large part of "The Artistic Patrimony of FIAP" (the prints) is stored in the Musée de l'Elysée in Lausanne, Switzerland. Since 2013 FIAP has only accepted digital images. These pictures are stored on different hard drives located at different addresses. Since the number of pictures that FIAP receives every year is very high, it has been decided that only a limited number of images can be placed on the cloud. These are low resolution images with a watermark and are accessible to everyone at the web address: http://collections.fiap.net.
