MINUTES OF THE OPENING GENERAL SESSION

FRIDAY, JUNE 27, 2008

The 165th Psi Upsilon Convention was called to order by James A. Swanke, Jr., Rho '80 at 7:15 p.m. on Friday, June 27, 2008. On behalf of the Executive Council, Brother Swanke welcomed the delegates to Indianapolis and then appointed the following temporary officers of the 165th Convention:

treasurers of all chapters to collectively discuss proper budgeting, debt collection techniques, and fundraising ideas for the purpose of assisting chapters in properly allocating available financial resources in the most

effective manner.

John Lalomio, Eta '10 presented the following recommendation:

Recommendation #2

Whereas: Psi Upsilon chapters could not function or exist without the support and

guidance of the International Fraternity; and

Whereas: The International Fraternity's budget is incredibly limited; therefore be it

Recommended: That the undergraduates attending the Convention should educate the other

undergraduates of their chapters about the purpose and benefits of the International Fraternity and the critical need for undergraduate and alumni

financial support; and be it further

Recommended: That all undergraduates participate in the 1833 Club, which is an easy way to

become accustomed to annual giving, and chapters should aim for 100%

participation.

Stefanos Kasselakis, Tau '09 presented the following resolution which was approved by a majority vote.

Special Resolution #21

Whereas: The Psi Upsilon Constitution Artcle II Section 3 requires two undergraduate

members and one alumni member to attend the Convention as official delegates;

be it

Resolved: That a chapter which is not sending at least a full delegation must submit a letter

to the International Office 30 days before the start of the Convention detailing both the reason for the partial or full absence and plan for rectifying it for the following year, to be approved by the Nominations and Credentials Committee;

and be it further

Resolved: That a chapter whose proposal is denied by the Nominations and Credentials

Committee for two consecutive Conventions, or fails to send at least a full delegation without notification will be notified by the International Office that

any further absence will forward the matter to the Executive Council for further action including the possible suspension of its charter; and be it further

Resolved: That this resolution take effect immediately prior to the 166th Convention.

Stefanos Kasselakis, Tau '09 presented the following Recommendation:

Recommendation #3

Whereas: The Psi Upsilon Constitution Artcle II Section 3 requires two undergraduate

and one alumni members to attend convention as official delegates; be it

Recommended: That in the case that a chapter submits a letter to the Convention setting forth

the reasons for the Chapter's failure to provide a full delegation to the Convention, the International Office shall try to assist the Chapter in

attending future Conventions.

Molly Malloy, Gamma '10 presented the following Recommendation:

Recommendation #4

Whereas: No site has been selected for the 168th Convention in 2011, be it

Recommended: That the Executive Council shall explore the possibility of holding the 168th

Convention in the Washington, D.C. area, hosted by the Phi Delta Chapter, or

in the Ann Arbor, MI area, hosted by the Phi Chapter.

Theodore Nielson, Omega '10 presented the following Recommendation:

Recommendation #5

Whereas: Concerns have been raised about the smoking of tobacco products in chapter

houses, be it

Recommended: That the undergraduate brothers and the alumni association of each chapter

shall discuss or consider a policy on smoking with regard to public areas and private rooms and report back to the International Office prior to the 166th

Convention in 2009

Michael Storey, Theta Theta '09 discussed the work of the **Committee on Unfinished Business**. Sam Bauch, Gamma '10 presented the following resolution which passed unanimously:

Special Resolution #22

Whereas: Mental health being a vitally important aspect of personal general well-being; and

Whereas: Mental well-being is generally not discussed sufficiently on college campuses;

therefore be it

Resolved: That the Executive Council continue to research mental health programs, e.g.

Mental Health Edu; and be it further

Resolved: That chapters should actively seek available mental health educational resources.

Stefan Grundmann, Zeta '10 presented the following resolution which passed unanimously:

Special Resolution #23

Whereas: The role of the undergraduate delegate is vital to the work of the convention, and

Whereas: The role of the undergraduate is not sufficiently defined in advance of the

Convention, therefore be it

Resolved: That the Executive Council create and provide guidance on the responsibilities

and requirements of the undergraduate delegate in advance of the Convention and

notify all of the active undergraduate chapters.

Laura King, Chi Delta '04 presented the following recommendation:

Recommendation #6

Whereas: There has been a tremendous increase in commitment and distinction in the

areas of philanthropy and community service among chapters; and

Whereas: Many chapters have found their philanthropy and service experiences

cultivate positive relationships both within the community and within the

chapter, therefore be it

Recommended: That the Psi Upsilon staff restructure the current chapter service report forms

to include successes, failures, and possible strategies in order to better assist

all chapters in developing and implementing community service and

philanthropic events.

Michael Storey, Theta Theta '09, presented the following resolution which passed unanimously:

Special Resolution #24

Whereas: The committee on unfinished business has reviewed the Executive Council

minutes for the 2007-08 year; therefore be it

Resolved: That the 165th Convention has reviewed the actions of the Executive Council

taken since the 164th Convention, ratifies those actions, and thanks the Executive

Council for its service and attention to the business of the fraternity during that time.

Eldred A. Halsey, Delta '56 encouraged the chapters to participate in the Challenges and Choices program.

Upon a motion duly made, seconded and approved unanimously the 165th Psi Upsilon Convention was adjourned sine die at 11:01 a.m.
