Subject: The provision of Heavy Urban Search and Rescue (HUSAR) team

**WHEREAS:** THE provision of Heavy Urban Search and Rescue (HUSAR) team capabilities is vital to public safety across Canada;

<u>AND WHEREAS:</u> IT is imperative that the Canadian network of HUSAR teams be available for immediate deployment on a local, Provincial, Territorial, National and International basis without delay;

**AND WHEREAS:** AT present, Canadian HUSAR teams are not presently International Search and Rescue Advisory Group (INSARAG) qualified;

<u>AND WHEREAS:</u> AT present, Canadian HUSAR teams do not have National deployment agreements in place in the same manner that Forest Fire suppression teams do;

AND WHEREAS: THE absence of these pre-established National deployment agreements would result in significant delays in Canadian HUSAR teams being able to deploy to emergencies on a National or International basis;

AND WHEREAS: THE recent hurricane and earthquake events clearly demonstrate the critical need for Canadian HUSAR resources that are able to deploy both across Canada and Internationally without delay or issue;

<u>THEREFORE BE IT RESOLVED:</u> THAT the CAFC petition Public Safety Canada to implement the necessary National Deployment Agreements with each of the Canadian HUSAR teams as an urgent matter of National public safety;

<u>And be it further resolved</u> THAT the CAFC petition Public Safety Canada to facilitate INSARAG qualification for each of the Canadian HUSAR teams as an urgent matter of public safety;

<u>And be it further resolved</u> THAT\_the CAFC petition Public Safety Canada to allocate the funding required to deploy Canadian HUSAR teams to International disasters such that the experience level of the Canadian HUSAR teams remains very high and such that Canadian HUSAR teams can assist in saving lives during time of disaster;

And be it further resolved THAT the CAFC petition Public Safety Canada to make the continuing support of Canadian HUSAR teams a top National Public Safety priority
