FAIRFAX LAW FOUNDATION ENDS ITS CAPITAL CAMPAIGN

une 30, 2010 marked the end of the Fairfax Law Foundation's Capital Campaign. The Campaign began in late 2006 with the goal of raising \$1 million to create, seed, fund, and sustain the many programs and services that support the local justice needs of the community. These programs include the Fairfax Public Law Library, *Pro Bono* Services, the Juvenile & Domestic Relations District Court pamphlets, the Conciliation Program, and all of the Law Related Education Programs, including the Court Tour Program, the Children's Play, and the Speakers Bureau.

The program got off to a strong start with a \$75,000 donation from Odin, Feldman & Pittleman, followed by \$25,000 donations from Peter and Katherine Greenspun, Lieblich & Grimes, Shoun Bach Walinsky & Curran, P.C., and Cooley Godward Kronish LLP.

As the Foundation continued on its quest to raise funds for its programs, the economy failed to work in its favor. As a result, the Foundation set its sight on raising \$500,000. Thanks to the recent \$10,000 donation by the law firm of Bean, Kinney and Korman, P.C., the Foundation reached its goal.

Since this Campaign began, we now have a beautiful new public law library that serves more than 61,000 patrons each year. The Court Tour Program was saved and court tours were provided to 2,400 students from 26 middle schools, 4 high schools, 1 center school, and 3 private schools this past year. The Conciliation Program continued its success, resolving more than 400 cases a year and helping more *pro se* parties resolve their issues.

10TH ANNUAL SPRING GOLF TOURNAMENT

The Fairfax Bar Association held its 10th Annual Spring Golf Tournament at Westfields Golf Club on Monday, May 11, 2010. This year, the golf tournament was held in memory of Edward J. Walinsky. Present at the reception was Ed's wife, Fran, and one of their children, along with a number of his law firm members.

The golfers who participated in the tournament were treated to a perfect spring day with sunny skies and temperatures in the 70s. As in past years, a silent auction was included along with the golf tournament with the proceeds benefitting the Fairfax Law Foundation. While the economic climate remains tenuous, the silent auction resulted in the highest amount that this event has ever raised for the Fairfax Law Foundation. During the silent auction, the items purchased included a framed autographed photograph of Arnold Palmer; a framed series of photographs, along with an autographed *Golf* magazine cover of Phil Mickelson; a gift certificate for two to the Westfields Marriott Sunday Brunch; and rounds of golf at Westfields Golf Club, Creighton Farms, Heritage Hunt Golf & Country Club, Raspberry Falls Golf & Hunt Club, Old Hickory Golf Club, Virginia National Golf Club, and Blue Ridge Shadows Golf Club. The funds raised for the Fairfax Law Foundation help support valuable programs such as providing *pro bono* legal services to indigent clients, maintaining the public law library, and offering law-related education programs to area students, including the court tours that many of you have observed at the Courthouse.

The format of this golf tournament remains a scramble (Captain's Choice). The first place team with a score of 58, which is 13 under par, was the team of Jeremy Letnick, Bob Letnick, Bob Farrell, and Mike Annessa. Three teams tied with a score of 60, or 11 under par, and after a match of cards, the second place team was the team of Steve Cochran, Dave Talley, Dan Sherrange, and John Martin. The third place team was the team of Brian Drummond, Dickson Young, Ted Sibert, and Justin Daniel. As in past years, there was a team that came in last place whose names have again been redacted from this article. The good news is that their score is improving every year, however, they are under the misconception that the highest score wins.

Prior to the commencement of the golf tournament, the annual putting contest was won by Jeremy Letnick. During the golf tournament, the women's longest drive on hole 11 was won by Elaine Bredehoft, and the men's longest drive on hole 15 was won by John Whittington.

There were four closest-to-the-pin competitions with three on par 3 holes and one on the par 4, 14th hole, that measures approximately 250 yards. On the third hole, which is considered by many to be the signature hole at the Westfields Golf Club, the hole-in-one contest included a motor vehicle that was sponsored by Don Beyer Volvo at Dulles who has sponsored this event for many years. As is the tradition on this golf hole, the flag was tucked in the back left hand corner of the green, approximately 180 yards from the tee, requiring a very exacting tee shot over a water hazard to a pin only a few paces onto the green. As in the past years, our volunteer observers had to evade numerous errant tee shots because our participants on this hole were hitting the ball all over the place. For example, our third place team consisting of Brian Drummond, Dickson Young, Ted Sibert, and Justin Daniel saw their best tee shot out of the four players come to rest approximately 40 yards from the flag in the right rough. While golf stories from this foursome may be somewhat suspect, corroboration was received from the volunteer observers that Brian Drummond chipped in from 40 yards away for a birdie 2. The closest-to-the-pin competition on this hole, at a distance of 15 feet, was won by Jim Freeman. The women's closest-to-the-pin competition on hole 7 was won in a drawing by Elaine Bredehoft, while the men's closest-to-the-pin competition on hole 17 was won by Steve Cochran. On the par 4, 14th hole, the closest-to-the-pin on this drivable par 4 was won by Mike Connor who hit his tee shot to 9'6".

ESTATE PLANNING IN 2010: PRACTICAL ADVICE

from Howard M. Zaritsky, Esq.

For the first time since 1915, we have no federal estate tax, and for the first time since 1976, we have no federal generation-skipping transfer (GST) tax. The federal gift tax is lower than it has been during the lifetimes of many of us. In addition, the traditional "step-up" in basis rules have been replaced with new carry over basis rules. This situation, however, is almost certainly temporary, but we have no idea what the future holds.

It is against this backdrop that the Wills, Trusts and Estate section of the Fairfax Bar Association held its annual "Ask Howard" question-and-answer session, featuring renowned estate planning attorney, Howard M. Zaritsky, on June 16, 2010. Topics included: the current legislative situation and possible legislation in 2010; impact of the repeal of the estate tax; how to handle the repeal of the GST tax; and gifting strategies in 2010. For those unable to attend, please find certain excerpts of the discussion below.

Q. What actions, if any, do you think Congress will take this year with estate/gift tax laws?

A. It's hard to predict accurately what Congress will do in 2010 regarding estate and GST taxes, and my predictions have almost always been wrong. It might reinstate the estate and GST taxes retroactively. It might reinstate the estate and GST taxes prospectively from the date of enactment or some earlier date, such as the date on which the bill to reinstate the taxes is introduced. It might remain deadlocked and allow the estate, gift, and GST taxes to return to their pre-2002 rates and exemptions—with a top estate and gift tax rate (and only GST tax rate) of 55% and a \$1 million exemption.

The House, last December, passed a bill that would make permanent the 2009 estate tax levels, with a maximum tax rate of 45% and a \$3.5 million exemption, and provide some small business relief. The Senate is close to passing a compromise bill that would establish the estate tax at a 35% maximum rate with a \$5 million exemption. I, personally, think that we'll end up with a \$3.5 million exemption and a 45% tax rate cap.

ANNUAL MEETING REPORT

The House of Delegates of the American Bar Association held its annual meeting in San Francisco, CA, on August 9 and 10, 2010. The FBA is one of 80 local bar associations in the United States to be represented in the House of Delegates.

Much was accomplished during the two days of meetings. The highlights included:

- The installation of Stephen Zack as the new president of the ABA. Stephen Zack came to the United States from Cuba in the early 1960s and is particularly sensitive to the rule of law. In his address to the House of Delegates, Zack stated that it is the responsibility of the ABA "to always speak truth to power" and specifically identified "four responsibilities: preservation of the justice system, civic education, protecting human rights, and preparing for disaster."
- a. Preservation of the justice system. Zack expressed concern that the rule of law is endangered here in the United States, noting that 80% of our nation's poor cannot afford counsel, and the underfunding of the judicial system. Zack pointed out that the judicial system is hardly a co-equal branch of government when it receives less than 1% of government expenditures and lacks funds for judges, public defenders, prosecutors, access to courts, and where now user fees are being charged in some jurisdictions. To address this problem, Zack has created the Task Force on the Preservation of the Justice System. David Boies and Ted Olson have agreed to co-chair this effort.
- b. Civic education. Zack also noted the lack of knowledge of fundamental civics as a cause for distress that needs to be addressed. For example, in a recent study, two out of three high school students identified the three branches of government as Democratic, Republican, and Independents. Many responding to another survey did not know that the Bill of Rights protects religious freedom. Fifty percent of those who had the Bill of Rights read to them believed that it was a communist document. The House of Delegates adopted a proposal to encourage "all lawyers to consider it part of their fundamental responsibility to ensure that all students experience high quality civic learning, including the study of law, government and history."
- c. Protecting human rights. Zack noted that "[e]very day, our nation becomes more divided with respect to civil rights. We are a nation of immigrants. Our basic freedoms are based on the principle that the minority is protected from the tyranny of the majority." Observing that the Hispanic community is the fastest growing immigrant community, Zack announced the creation of a Committee on Hispanic Legal Rights and Responsibilities.
- d. <u>Preparing for disaster</u>. Zack noted that in the wake of Hurricane Katrina, many attorneys sought to provide legal assistance, but could not do so because of unauthorized practice of law restrictions. Recognizing the likelihood of future disasters, and the possibility of a suspension of *habeas corpus*, Zack noted the need for disaster readiness.
- The ABA Medal to Supreme Court Ruth Bader Ginsburg. Outgoing ABA President Carolyn Lamm awarded the ABA's highest honor, the ABA Medal, to Justice Ginsburg in recognition that for more than half a century, Justice Ginsburg has made vast and lasting contributions to the law and to the profession.

Q. A man dies testate in Virginia in 2010, with real estate as his only probate asset. The real estate is valued at less than \$1 million at the date of his death. Normally, you can file the will with qualification, and the real estate transfers. The real estate usually would be entitled to a step-up in basis since it is less than \$1.3 million. But Section 1022 of the Internal Revenue Code (IRC) says that the "executor" makes the election of which property gets the step-up hasis

Must someone now qualify as an executor solely for the purpose of making the election to allocate the step-up in basis to the real estate, even though it is the only probate asset? If not, how do you ensure that the real estate receives the step-up in basis?

A. Prior to 2010, a person who received property from a decedent took an adjusted income tax basis in that property equal to the fair market value of the property on the date of the decedent's death or, if elected by the decedent's executor, the alternate valuation date, according to current law. A person who receives property from a decedent who dies in 2010, however, takes an adjusted basis in the property equal to the lesser of the fair market value of such property on the date of the decedent's death or the adjusted basis of the property in the hands of the decedent. However, the executor of a decedent's estate is permitted to allocate a \$1.3 million aggregate basis increase among the decedent's assets, increasing the basis of each asset to its fair market value.

The IRC states that the aggregate basis adjustment is available only to the extent that the decedent's "executor" allocates them pursuant to Section 1022.2 Section 7701(a)(4) provides that the term "executor" means "the executor or administrator of the decedent, or, if there is no executor or administrator appointed, qualified, and acting within the United States, then any person in actual or constructive possession of any property of the decedent." If an estate has no appointed executor or administrator, the allocation can be made by the decedent's heirs.

The IRC further states that the allocation must be made on a tax return filed pursuant to Section 6018,³ containing bias information if the fair market value of all property (other than cash) acquired from the decedent exceeds \$1.3 million.⁴ The IRC, therefore, does not actually provide a mechanism for an "executor" of an estate with a total fair market value under \$1.3 million to allocate the basis adjustment.

Presumably, the IRS will automatically allocate the basis adjustment to all of the decedent's assets.

Q. How should we deal with generationskipping trusts this year when there is a distribution requirement?

A. If a distribution is required, do it and make it outright. There is no GST tax and no gift tax return required.

If distributions are discretionary, you should probably wait until later in the year to make the transfer. This will give you more time to ascertain whether Congress will retroactively reinstate the GST tax. If a discretionary gift is made, consider setting aside a reserve for taxes in case the GST tax is retroactively reinstated. In appropriate situations, a refunding agreement with the beneficiary may be used instead of a reserve. You may also consider making distributions by formula, such that the "skip" person would receive that portion of the distribution that can pass free of GST taxes and designated "non-skip" person (a child or charity) receives that portion of the distribution that would be subject to GST tax.

With a generation-skipping gift made in 2010, you will have to wait to allocate the gift to the GST exemption. I would suggest waiting until April 16, 2011, to file your gift tax return.

Q. In view of the uncertainty of these estate tax laws, what should we be doing now?

A. Estate planners must now re-evaluate all estate plans they prepared that did not fully address both the absence of estate and GST taxes in 2010 and the full imposition of the carry over basis rules in 2010. They must also alter their practices regarding lifetime transfers with respect to transactions occurring in 2010.

For clients with an estate in the \$3.5 - \$7 million range, I would still recommend

providing for a marital share and a nonmarital share of the assets. The marital share would pass to a QTIP trust. Any disclaimed portion of the QTIP trust should pass to the nonmarital trust. This arrangement is good because it removes assets from a spouse's estate when the federal estate tax is restored after 2010, and permits the surviving spouse to fund or add to a nonmarital trust by disclaimer if the estate tax is restored retroactively.

If a marital share is left to a power of appointment trust if the decedent dies in 2010, I would recommend that the spouse disclaim the powers granted therein.

In order to fix carry over basis problems, I would tell your clients to start compiling basis information, and add language to the clients' wills stating what factors to be considered in allocating the carry over basis increases and exonerating a family member who serves as an "executor" from liability for allocations of basis increases made in good faith.

Ascertain what gifts your clients will make in 2010. If any of these gifts are subject to gift tax and securing the low 2010 35% rate is important, make the gifts outright. Otherwise, consider using an allocation formula gift as noted above. If any of these gifts are to grandchildren or other "skip" persons, and they cannot be made outright, consider making them to a family limited partnership or family limited liability company. It looks like the IRS will be eliminating discounts for such entities, but you can beat this if you create such an entity now and make gifts.

- The House of Delegates, the policymaking branch of the ABA, adopted policies on a number of issues including:
- a. Adoption of ABA Model Access Act, intended to establish a civil Gideon right to counsel.
- b. Urged state and local governments to provide local governments to provide legal counsel to children and/or youth at all stages of juvenile status offense proceedings as a matter of right.
- c. Adoption of a policy on preemption of state tort law.
- d. Urged state and local governments to eliminate all legal barriers to civil marriage between two persons of the same sex who are otherwise eligible to marry.
