Fairfax BARdi Gras Convention in "The Big Easy"

On October 9-12, more than 50 members of the Fairfax Bar Association and spouses, along with 4 judges from the Fairfax County courts, attended a one-of-a-kind bar convention in New Orleans, equally well known as "The Big Easy" or "The Crescent City." The convention was held at the Ritz-Carlton where the attorneys, spouses, and members of the Bench socialized, studied the law in a series of four short, but insightful, two-hour seminars over two days including Circuit Court Practice, Effective Use of Experts, a judicial panel on Professionalism in the Courts, and Trial Strategy and Evidence, and then had plenty of open time to see the sights and experience the city.

It takes a few days in New Orleans to fully understand and appreciate the reasons that the city has earned one of its two nicknames as "The Big Easy." You find yourself slowly being enchanted and richly entertained by all that this beautiful city on the Mississippi River has to offer. There is the French Quarter with its terrific restaurants and unique architecture; creole and Cajun cooking including gumbo, crawfish, and shrimp étouffée (pronounced [e.tu.fe] ay-too-fay); the Garden District with historical homes including a residence that is an exact replica of Tara from *Gone With the Wind*; tours of the Bayou where you can see and hold alligators (the tour guide only let us hold a "gator" under two years of age so as not to put at risk any of our fingers); and most importantly, the kind and friendly people everywhere you go.

A cruise on the Mississippi River on the *Steamboat Natchez* attended by all—or nearly all—of the convention attendees, provided a wonderful view of houses and architecture along the river. A clear view of the bend in the Mississippi from the steamboat made evident the reason that New Orleans earned its other nickname as "The Crescent City." The spirit behind this nickname

A Treasure Not Fully Tapped

As the Clerk of the Court, John Frey has said "Most courts would never dream about having something like a Circuit Court Committee, where the Bar could have a say in the Court's procedures and policy."

The Circuit Court Committee's Mission Statement:

"Facilitate communications and coordination between the Circuit Court Bench and Bar and to study and provide feedback to the Bench and Clerk's Office and make recommendations regarding the procedures and operations of the Circuit Court."

Judge Randy Bellows and Judge Charles Maxfield serve as the Judicial Liaisons for the Circuit Court Committee. Al Bonin hit the ground running as the new Chairperson of the Circuit Court Committee, with black binders for all, filled with projects.

The Circuit Court Committee provides a valuable vehicle for communication and collaboration among the Bar, the Court, and the Clerk's Office. A recent example of this collaboration was the creation of attorney prepared summons. Over the last couple of years the economy affected the staffing at the Clerk's Office, which resulted in longer waits for Court-prepared summons. Donald Anderson, a member of the Circuit Court Committee, proposed attorney prepared summons, which could be prepared by an attorney and obtained from the Court the same day. The court agreed to this proposed change and the Clerk's Office immediately went to work on behalf of the Bar to determine if this significant change could be made. Five members from the Domestic Relations Sub-Committee led a test phase that was successful. Attorney-prepared summons are now available to the Domestic Bar.

The successful implementation of the Circuit Court Online Scheduling System (OSS) is now available for scheduling both civil and domestic cases, which will save time, effort, and costs for both the client and the attorney. Statistics to date show 74 trials scheduled online and 380 attorneys who are registered OSS users.

The new *Spare the Child* video is available and online from the Virginia State Bar.

The Circuit Court Committee continues to identify projects some of which are mentioned below.

Judge Bellows recently identified issues resulting from the United States Supreme Court's case of *Turner v. Rogers*. The Domestic Relations Sub-Committee of the Circuit Court Committee and the Clerk of the Court immediately

began work on, and continue to work on, the various issues raised by this case.

An issue was raised that the Civil Clerk's office does not accept credit cards. John Frey, being present at the meeting, immediately said he would see that the Civil Clerk's Office will be able to pay by credit card in the future.

The issue of unsigned orders, suspending orders, missing deadlines for appeals, and Rule 1:13 have been brought before the Circuit Court Committee for discussion.

A committee has been created to review and revise the *Fairfax Circuit Court Practice Manual*.

Julie Gerock will head a committee to address the concerns regarding *pro se* litigants.

Fairfax Bar Association *Legislative Committee*

The Legislative Committee meets to discuss, monitor, and promote legislation that may be of interest to FBA members. Most of these issues arise out of the Virginia General Assembly. The FBA has no lobbyist in Richmond, so a key function of the Legislative Committee is to monitor and report to the Board of Directors on important legislation. The Board then determines whether the FBA should advocate for or against a particular bill. If the FBA wants to advocate for or against a particular piece of legislation, the Committee members may begin to contact other FBA members, Delegates, and Senators to express our organization's view. As attorneys, we are often able to present unique arguments to elected officials on the possible consequences of a bill.

With the General Assembly going back into session on January 11, 2012, this time of year becomes busy. The FBA focuses on legislation that affects the administration of justice and avoids more partisan issues such as taxes, transportation, or health care. By way of example, the following bills were pending during the 2011 session with varying results:

HB 1990 and SB 1240—proposed to realign the judicial circuits and districts of the Commonwealth.

HB 1590 and SB 774—expanded the civil jurisdiction of the General District Courts to cases where the amount of the claim does not exceed \$25,000.

These are only two examples of the myriad of bills that are introduced in Richmond. You can access all the bills at leg1.state.va.us and click on the Bills & Resolutions for the 2011 Session. As of the date this article was written, the General Assembly's website did not yet post the Bills & Resolutions for the 2012 Session. If there are any bills that you believe merit attention, please contact the FBA or me at Christopher.Costa@fairfaxcounty.gov. ■

was best explained to me when my wife and I happened into a furniture store in the French Quarter that had high-end antique grandfather clocks and rare furniture for sale. After spending time showing us furniture and clocks he could probably tell that we could not afford, the proprietor explained that the kindness and welcoming spirit we were often greeted with is the essence of what it means to be received with open arms in a crescent, welcoming visitors from around the world to enjoy and partake in "The Crescent City."

Of course, no trip to New Orleans would be complete without dinner at Commander's Palace or a stroll down Bourbon Street and a chance to hear live jazz at Fritzel's European Jazz Pub. For the price of a beer or two, or three, and a tip to the band, members of the bench and bar enjoyed jazz that continued until 2:00 AM.

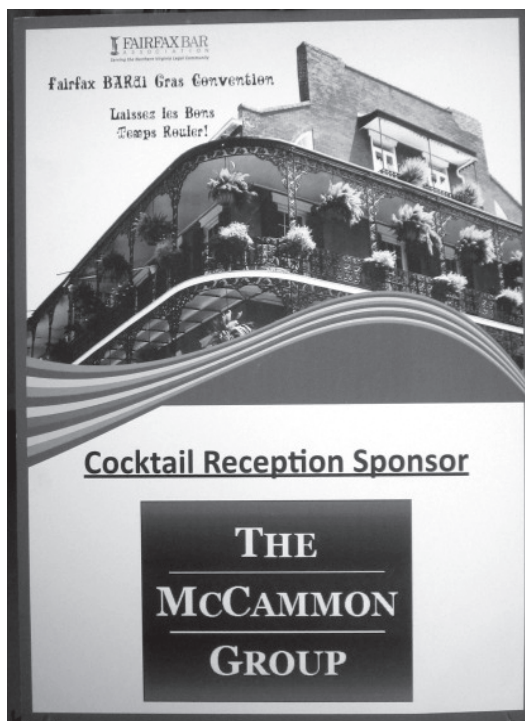
For us there was no better way to see New Orleans than a Segway tour provided by Discovery Tours, taking us in a spirited spin around the waterfront and the French Quarter with stops to learn of the City's French and Spanish histories. One very interesting fact that we learned was that during the Spanish period around 1800, the women of New Orleans enjoyed the right to vote, to own property, and to manage their own affairs. These liberties did not come to the rest of the country for another hundred years when the women's suffrage movement resulted in 1920 passage of the Nineteenth Amendment to the United States Constitution, which provided that, "The right of citizens of the United States to vote shall not be denied or abridged by the United

States or by any State on account of sex." How's that for a progressive city?

Still not convinced? In the French Quarter exists the oldest apartment building in America, called the Place d'Arms, which became the city's most famous address. It was built and owned for many years by Baroness Michaela Pontalba. The Place d'Arms, later renamed Jackson Square in honor of our seventh President of the United States, was a military parade grounds at the center of the Vieux Carré facing along the Mississippi River. Pontalba's desire was to transform it into a Parisian-style public square by flanking it with stylish row houses with shops on the street level and apartments above. By the time they were finished in 1851, the two Pontalba buildings, each with 16 apartments, set an elegant new tone for the city center, and those are still occupied to this day as apartments. Michaela Pontalba personally oversaw construction and ensured the unique nature of the buildings. The Baroness had hired the finest architects of the community, used their plans, then altered the product to her liking. The result was an amalgam of Creole, Parisian, and Greek Revival tastes and uses. All of this was done by a single woman.

Call it "The Big Easy" or "The Crescent City"—either way you leave convinced that New Orleans is unique in our American history and worth every minute of your time to visit and enjoy. By the time we left to return to Northern Virginia "The Big Easy" had infused us with its magic and charm. We can't wait to return! ■
