David J. Gogal, Immediate Past-President — Blankingship & Keith, P.C.




President's Column

FAIRFAX COURT UPDATES

We received several updates from the Fairfax Circuit Court and the General District Court. Please note that many of these changes may already be in practice.

FAIRFAX COUNTY CIRCUIT COURT ANNOUNCEMENTS

Holiday Schedule—The Circuit Court released the schedule for the upcoming 2011 Fall/Winter holidays. The Court will close at Noon on Wednesday, November 23, and will be closed all day on Thursday, November 24, and on Friday, November 25. The Court will be closed all day on Friday, December 23, on Monday, December 26, and on Friday, December 30, 2011.

Revised Criminal Forms and Procedures—The following is a list of the criminal forms and procedures which were recently revised by the Circuit Court. All of the revised forms and procedures listed below took effect on July 1, 2011. After that date, only the most recent versions of these forms may be used, as the Court will not be accepting the prior versions or procedures. Both the forms and procedures can be found on the Circuit Court's website, which is located at: (http://www.fairfaxcounty.gov/courts/circuit/).

(1) **Criminal Bond Motions**—Please be aware that the pre-printed bond motion form previously provided by the Court has been abolished. The Court will no longer accept form bond motions. Counsel must file a written bond motion which specifies the factual basis for the requested relief. Bond motions must also comply with the Court's existing filing requirements which can be found on the Court's website.

- (2) Criminal Case Status Form
- (3) Waiver of Jury Trial Form
- (4) Calendar Control Form
- (5) Restricted License Application Worksheet
- (6) Plea Forms for Felonies, Alford Pleas, and Misdemeanors Involving Potential Jail Sentences—As noted, these forms are all available on the Court's website, but they will also be available in each courtroom. The Circuit Court will accept only these plea forms. If there is a plea agreement which involves, or addresses, any issues related to the *Hernandez* decision, those additional provisions will need to be set forth in paragraph 8 of the plea forms.

Neutral Case Evaluator Program for Civil Cases Started August 1, 2011—Starting August 1, 2011, the Fairfax County Circuit Court will make available Neutral Case Evaluators (NCEs) to mediate civil cases.

The Neutral Case Evaluator Program is a voluntary program designed to facilitate resolution of civil cases without the expense and uncertainty that trial brings. NCEs are volunteer attorneys selected by the Court based on their experience and expertise.

There are different ways a civil case can utilize the NCE program. At status conference, either a judge or the parties may request the appointment of an NCE. Once requested, the Court will appoint an NCE. However, a trial date will still be assigned at status conference.

Another way to utilize the NCE program is to simply complete the request form which can be obtained at the Clerk's Office.

Once appointed, the parties and the NCE will work together to prepare for, schedule, and complete mediation. This program is designed to complement the Domestic Relations NCE Program which already exists.

FAIRFAX COUNTY GENERAL DISTRICT COURT ANNOUNCEMENTS

<u>DWI Policy</u>—In the Fairfax County General District Court, the first court date on a charge of driving while intoxicated will generally be continued and neither the Commonwealth, nor the Defense, will need to subpoena witnesses for this date. If the defendant appears with counsel, the prosecutor is to provide limited discovery as allowed under Rule 7C:5 to counsel, who are to make themselves available to the prosecutor. Trial will occur on this initial date only at the agreement of the parties. The second court date, with counsel present, is presumed to be the trial date, and no continuance will be granted except for good cause shown. Attorneys hired by unrepresented defendants after the defendant's second court date must be prepared for trial on the next court date. Defense counsel is responsible for checking the court file to determine whether there have been multiple court appearances by the defendant.

4% Credit Card Fee—Effective July 1, 2011, a 4% processing fee will be added to all credit card transactions in the General District Court. ■

2011 FAIRFAX BAR ASSOCIATION 11TH ANNUAL SPRING GOLF TOURNAMENT

The Fairfax Bar Association held its 11th Annual Spring Golf Tournament at Westfields Golf Club on Monday, May 9, 2011. Eighty-nine (89) golfers participated in this tournament, which was played on one of the first beautiful Spring days this year with sunny skies and temperature in the low 70's.

This golf tournament also included a silent auction with proceeds benefitting the Fairfax Law Foundation. During the silent auction, the items purchased included rounds of golf at Westfields Golf Club, Creighton Farms, Trump National Golf Club of Washington, D.C., Raspberry Falls Golf & Hunt Club, and Old Hickory Golf Club. The funds raised for the Fairfax Law Foundation help support valuable programs including *pro bono* legal services to indigent clients, maintaining the public law library, and offering law-related education programs to area students, including the court tours that take place at the Courthouse.

The format of this golf tournament—as in past years—remained a scramble (Captain's Choice). The first place team, with a score of 60, which is 11 under par, was the team of Steve Cochran, Scott Heon, Steve Nolin, and Dan Sherrange. The second place team, with a score of 62, was the team of Nader Hasan, Buddy Christensen, Michael Ammann, and Paul Brisson. The third place team was the team of Jeremy Letnick, Bob Letnick, George Bigus, and John Jacob. The last place team included three members who were also members of the last place team from last year. The good news is that they are playing better and their score was one stroke less than last year. As in the past, the names of those in the last place team have been redacted from this article.

Prior to the announcement of the golf tournament, the annual putting contest was won by Jeremy Letnick who also won this putting contest last year. During the event, the women's longest drive on Hole 11 was won by Elaine Bredehoft who was a repeat winner, having won the women's longest drive competition last year. The men's longest drive on Hole 6 was won by Ellis Robey.

There were four closest-to-the-pin competitions with three on par-3 holes and one on the par-4, 14th Hole that measures approximately 250 yards. On the 3rd Hole, which is considered by many to be the signature hole at The Westfields Golf Club, the hole-in-one contest prize included a motor vehicle sponsored by Don Beyer Volvo at Dulles who has sponsored this event for many years. The flag on this green was in its typical location tucked in the back left hand corner of the green approximately 180 yards from the tee box, requiring an extremely exacting tee shot over a water hazard to a pin that was barely on the green. The closest-to-the-pin competition on this hole, at a distance of 16'11", was won by Dickson Young. The women's closest-to-the-pin competition on Hole 7 was won by Allison Truesdell; while the men's closest-to-the-pin competition on Hole 17 was won by Steve Nolin. On the par-4, 14th Hole, the closest-to-the-pin on this drivable par-4 hole was won by Dan Sherrange, who hit his tee shot to 18'10".

One the fiercest competitions in this event—as in all years—was for the closest-to-the-keg prize, which again was on the 1st Hole, at a distance of approximately 150 yards off tee. This also requires a very exacting shot by hitting either a weak tee shot with a wood, or using a short iron to the placement of the keg. The winner of this competition, at a distance of 11'11", was Jim Kearney. He now possesses a special trophy, along with a gift certificate in the pro shop.

This golf tournament has a substantial list of sponsors and donors who helped make the tournament a success this year, as it has been in past years. Special recognition goes out to our premier sponsor, Don Beyer Volvo at Dulles, who sponsored the hole-in-one competition with a Volvo S60 on the 3rd Hole. The event had one other premium sponsor and special recognition goes out to the law firm of Whitestone, Brent, Young, Merrill, P.C., who was so kind as to sponsor the lunch at the grill prior to the commencement of the tournament.
