Summary of ABA House of Delegates Midyear Meeting in Houston

At its 2015 Midyear Meeting in Houston, the American Bar Association House of Delegates—made up of 560 members representing state and local bar associations, ABA entities, and ABA-affiliated organizations—adopted a broad range of criminal justice policies and a host of others, including a measure seeking more help with student debt for young lawyers. The following provides a summary of some of the actions taken.

The House approved a policy, for the first time, on the "stand-your-ground" laws that have grown in popularity during the past ten years. The approved resolution urges legislatures and governmental agencies to significantly modify or refrain from enacting laws that eliminate the duty to retreat before using force in self-defense in public places, an issue brought to the national forefront in 2012 with the fatal shooting of Trayvon Martin by George Zimmerman. Mr. Zimmerman was acquitted after claiming his actions were in self-defense. That defense was based on an expansive Florida law. An ABA task force concluded that rather than reduce the likelihood of homicides, the rate in "stand-your-ground" states actually increased. Additionally, the task force found that when whites used this defense in homicides involving black victims they were acquitted 38 percent of the time, while black defendants were acquitted in only three percent of the cases involving white victims.

The ABA House also approved a resolution that asks states that impose capital punishment through lethal injections to publicly disclose the protocols—or ingredients in the solution—that are used. In the aftermath of a botched legal injection in Oklahoma in April 2014, which prompted the case heard by the U.S. Supreme Court on April 29, 2015, several ABA entities asked the House to approve more disclosure about the drugs and other aspects of the execution process.

The policy-making ABA body also weighed in on the national immigration issue, as the House voted to support government-appointed counsel for unaccompanied children in immigration proceedings. The resolution specifically urged immigration courts not to conduct hearings unless an unaccompanied minor has an opportunity to consult with counsel. In 2014, ProBar, an ABA program in South Texas, assisted thousands of these young undocumented immigrants in immigration hearings during the wave of foreign-born children arriving in the U.S. unaccompanied by their parents or other legal guardians.

At the request of the Young Lawyers Division, the House adopted a measure that asks law schools to provide law students and young lawyers comprehensive debt counseling and debt management education. The new policy also asks bar associations to offer similar debt counseling and debt management services to young lawyers and newly admitted lawyers.

The ABA House adopted a resolution that urges governments to refrain from using shackles on juveniles in court, unless a judge orders it. It had been argued that, among peer nations, the United States is the only one in which some jurisdictions or courts allow shackling of juveniles as an automatic or routine procedure.

The ABA Commission on Domestic and Sexual Violence sponsored two successful resolutions. First, the ABA House urged governments to enact civil protection order statutes that extend protection to minor and adult victims of sexual assault, rape, and stalking outside of the context of an intimate partner relationship and without the requirement of any existing relationship between the parties. Second, the Commission won House approval for a measure that urged governments and other regulators to amend or enact laws and regulations to expand housing protections for victims of domestic and sexual violence.

Additionally, the ABA House of Delegates adopted resolutions that urge:

- Legislative bodies to approve comprehensive laws that bar the private possession, sale, breeding, import or transfer of dangerous wild animals.
- Congress, state and tribal governments to adopt recommendations in the Indian Law and Order Commission report of November 2013, "A Roadmap for Making Native America Separate," that enhances standards for the legal and justice systems in what is known as Indian country.
- Governments to continue to enforce and to enact rules or legislation that strengthen consumer protections regarding deceptive or fraudulent loan foreclosure rescue practices.
- Imposition of death-penalty sentences only by unanimous decisions by juries. Of the states, only Florida, Alabama, and Delaware do not require unanimous verdicts in capital punishment cases. The resolution also covers military courts.



THE JUVENILE AND DOMESTIC RELATIONS DISTRICT COURT COMMITTEE

The Juvenile and Domestic Relations District Court (JDRDC) Committee functions as a liaison between practicing attorneys and the judges of the Juvenile and Domestic Relations District Court. Meetings are generally held the second Thursday of each month at 12:30 PM in the Court Administrative Training Room #201.1. The stated purpose of the Committee is to provide assistance to the J&DR District Court bench and practicing attorneys. This year the Committee has undertaken a variety of issues ranging from completion of the *JDR Manual* to clarification of the requirements to be certified as a Guardian *ad litem* to *ex parte* hearings on Protective Orders, and as always, nominating a worthy individual for the coveted Kassabian Award.

The JDR Manual subcommittee has completed its first edits for the judges' review. Beset with losing members, illness, and other unforeseen obstacles, the committee soldiered on to complete its task, and is looking forward to planning a CLE in the fall.

During the course of drafting/editing the *JDR Manual*, a question arose as to the requirements with regard to certification by the Fairfax County J&DR District Court of Guardians *ad litem*. A circulating old list left one with the impression that you must be certified for adults, children, and possibly court appointed criminal work in order to accept GAL work. The issue has been clarified and the old list taken out of circulation. Certification in all three areas is not required to be a Guardian *ad litem*.

In addition, the J&DR Court commenced *ex parte* hearings regarding domestic abuse Protective Orders in the fall of 2014. A complainant is given the option of completing /filing an Affidavit or proceeding with an *ex parte* hearing in judges' chambers. These hearings are held each day at 3:00 PM and are placed on the Chambers' Docket. Legal Services of Northern Virginia helps provide volunteer attorneys to help petitioners receive protective orders in the permanent protective order hearings, and is often looking for new volunteers to help represent victims of domestic abuse.

The court's budget with regard to funding judicial positions lingers as a concern and is an issue begging for a good resolution. Fairfax County is in danger of losing one of our eight Juvenile and Domestic Relations judge positions upon the retirement, resignation, or death of one of our current judges. The Relationship Value of Mediation

In our roles as "Attorneys and Counselors at Law," how often do we focus on the counselor aspect as we learn about the circumstance a client has brought to us? Do we ask questions like: "What is the history of your relationship with the other party?"; "How has what transpired affected that relationship?"; "How do you see relational factors contributing to the circumstances that have you wanting legal help now?"; "What might you want to accomplish or preserve concerning that relationship?"; "What is—or could be—the value of a relationship with the other party?"; or "Even if the legal problem is resolved, might the relationship continue to be a source of difficulty?"

Certainly in family disputes, neighborhood disputes, and the vast majority of business, service, contract, and other commercial disputes, relational factors are involved. In many cases the relational impacts of a dispute may be of greater lasting consequence than the substantive or legal issues. Relational factors can very often be influenced in a positive way when the dispute is addressed in a mediation setting, in contrast to the almost always negative impact on relational factors when the means chosen for resolution is an adversarial forum.

A client's faith background can also be an important consideration. Virtually all faith and wisdom traditions place high value on people's consideration of each other's interests, gaining understanding of, and giving consideration to, the other party's perspective on the circumstances and its resolution, looking for the praiseworthy rather than the derogatory in others, and above all this, the reconciliation of relationship breaches and resolution of substantive disputes between the parties at the lowest possible level of external involvement. Much of this is the bedrock of classic mediation, which brings parties together for facilitated negotiation and guidance through the process of reaching resolution.¹

Getting to know our clients' objectives, and the needs and interests under those objectives, not only in a substantive, but also in a relational sense, is essential to being able to effectively advise our clients on advantages, disadvantages, and availability of other dispute resolution processes as means of addressing those needs and interests. This point is highlighted in the comments to Rules 1.2 and 2.1 of the Virginia State Bar Rules of Professional Conduct.

Rule 1.2 ("Scope of Representation")—Comment 1 provides in part: "Both lawyer and client have authority and responsibility in the objectives and means of representation. The client has ultimate authority to determine the purposes to be served by legal representation, within the limits imposed by the law and the lawyer's professional obligations. Within those limits, a client also has a right to consult with the lawyer about the means to be used in pursuing those objectives. In that context, a lawyer shall advise the client about the advantages, disadvantages, and availability of dispute resolution processes that might be appropriate in pursuing these objectives." (Emphasis added.)

Rule 2.1 ("Advisor")—Comment 2 provides: "Advice couched in narrowly legal terms may be of little value to a client, especially where practical considerations, such as cost or effects on other people, are predominant. Purely technical legal advice, therefore, can sometimes be inadequate. It could also ignore, to the client's disadvantage, the relational or emotional factors driving a dispute. In such a case, advice may include the advantages, disadvantages and availability of other dispute resolution processes that might be appropriate under the circumstances." (Emphasis added.)

These comments to the Rules highlight the appropriateness of discussing alternative dispute resolution processes, and specifically highlight the potential inadequacy of not venturing beyond legal advice into the relational or emotional factors.

In my twenty years of dispute resolution practice, it has been very rare to see a case where there is no relationship element, and in most cases the relational element has been significant. Types of disputes in which relational elements often play a significant role include:

- · partners dismantling their shared business
- supplier/vendor issues, and other business disputes where there is often a high value of maintaining the business relationship
- · employment and workplace disputes
- construction disputes
- · contractor/consumer disputes
- · community disputes, such as between neighbors or with an HOA
- · parent/school disputes
- · boundary disputes
- · estate distribution disputes
- · elder care issues
- parenting, support, and separation and the list goes on as imagination allows.

In many cases, the remedies available at law are limited in reach, completely inadequate, or simply unavailable to address, let alone meet, the needs and interests of one or more of the parties. In contrast, conciliation and mediation are not constrained by what legal remedies are potentially available. These approaches to conflict resolution are generally limited only by the openness and creativity of the parties and the skill of the mediators in fostering the environment needed for the parties to work together to develop solutions that can maximize satisfaction of all parties' interests. Mediators do this by facilitating effective communication between parties, fostering understanding between them, and thereby helping to soften the barriers to collaboration that many parties initially bring to the table. Mediators help the parties explore the underlying reasons for their dispute and the interests, values, and beliefs underlying their positions. We help them get to the root of what drives their choices, and guide and encourage them to co-create solutions that meet their own, and the other party's, key needs

Often times, it is the relationship aspect that must be constructively addressed in order to have any productive dialogue on substantive issues. A man I knew well in his service as Chaplain to the Institute for Christian Conciliation, Rev. Don Bubna, applied this "equation" to disputes: "R before I, except after T." This stands for the need to address Relationship matters before substantive Issues unless there is Trust between the parties. Sometimes the relationship aspect might not be obvious, and it can be present even when the parties do not know each other, as the following example illustrates.

In a dispute between a home buyer and seller, the buyer claimed fraud, asserting a knowing false declaration by the seller of "no known defects." The defect caused major expense and livability issues to the buyer. By the time the buyer went to his lawyer to threaten a lawsuit (nearly two years after the purchase), the buyer was angry to the point of bitterness towards the seller in his presumption of the seller's ill motives, gleaned from his learning that many other homes in the neighborhood had experienced the same defect. Trust was totally absent. The buyer had a terrible relationship with a man he had never even met. The seller's counsel suggested mediation, despite a likely successful defense being apparent to him. The buyer came in wanting the seller's head, but on meeting and speaking with him, discovered that the seller's head did not have horns. Through the opportunity for dialogue with each other, they gained an understanding of, and appreciation for, each other's perspectives, needs, and interests. The buyer came to accept the likely honesty of the seller and took responsibility for his rush to judgment and inflated demands. The remainder of the mediation was about whether or not the buyer would accept the seller's offer to contribute to remedying a defect that likely was genuinely unknown to him and, therefore, not likely his legal responsibility. Although first refusing any assistance from the seller, the buyer and seller ultimately agreed to share the cost of needed repairs.2

Face-to-face mediation provides the opportunity to address both the relational and substantive interests in ways that can fully take them into consideration in crafting solutions. It also provides a forum to understand and address relational contributions to the dispute, allowing a safe place to accept responsibility where appropriate. Acceptance of responsibility, which rarely happens in litigation, can go a long way

towards achieving effective substantive resolutions, rebuilding damaged or broken relationships, and clearing residual venom from relationships that are ending. If you want to understand more about Alternative Dispute Resolution or become involved in developing greater awareness and use of such means, please consider joining the Fairfax Bar Association's Alternative Dispute Resolution Section, or just come to a meeting, typically held the third Wednesday of the month at 8:30 AM in the FBA offices at the Courthouse (check the calendar at the FBA website).

¹ Those of you who know me or of my practice, Conflict to Peace, understand that I put high value on applying biblical wisdom in guiding parties through conflict to peace with the outcome and with each other. Without the "each other," resolution can only be partial. Mutual agreement upon, rather than imposition of, a resolution is more likely to yield for each party a sense of peace with the outcome, and it adds the potential for peace with each other that simply cannot be addressed by a third-party decision. Without the "each other," lingering negative residue from the conflict can potentially contribute to reduced well-being of one or more of the parties and leave the stage set for future damaging conflict between them or with others. Hebrews 12:14-15.

² Key aspects of our opening comments in mediations include encouraging the parties to set aside presumptions, to address the interests of others, not just their own, and to enter into the process with a forgiving spirit towards the other. In this case, the buyer quickly realized the inappropriateness of his judgmental and self-centered focus when faced with the seller's genuine consideration of the buyer's needs and interests.
