# INTERVIEW: HONORABLE HELEN LEINER

Judge Leiner, are you a native Virginian?

No, I was born in New York. I grew up in Far Rockaway, which is in Queens, where my family lived near the beach.

Where did you attend law school?

When my children were two and four years old, I went to law school nights at George Mason University Law School, where I became the Editor in Chief of the *Law Review*.

What drew you to the law in the first place?

I was an American history major in college, and I was always fascinated by the development of this country's legal system, and by the role of an attorney as an advocate for individuals in need of assistance in having their position heard and properly considered in our very complicated justice system.

How long did you practice law before coming to the bench? Twenty-two years.

Did you have a particular concentration?

Yes, when I began my practice I did family law as well as criminal law. Over the past few years I've exclusively done criminal law, especially focusing on juveniles accused of criminal conduct.

Having been on both sides of the bench, what do you think are the most important qualities for an attorney in the courtroom?

I respect attorneys who are well prepared and ethical.

# PRESIDENT'S COLUMN **McMissiles and Other Flying Objects**

The early bird may get the worm, but the second mouse gets the cheese in the trap—Larry the Cable Guy

I've been busier than a one-legged soccer goalie these days, but I had to take a moment to weigh-in on one of the most publicized crimes of recent memory-that's right-the McMissile case. In case you were in a coma for the last six weeks, the case I am referring to involved Jessica Hall, who while driving north on I-95 with her three small children and her six-month pregnant sister on a hot and sticky day

last July, threw a McDonald's cup of ice (hence the name "McMissile"-I'm sure McDonald's is thrilled with the name) at another car that she felt had cut her off several times. Apparently, while the offending car was stuck in traffic, Ms. Hall drove along the shoulder of the highway and tossed the cup of ice at the driver. She was convicted on January 4th of maliciously throwing a missile into an occupied vehicle, which is a felony. According to the jury instructions, a missile is "any physical object" that is "propelled by any force, including throwing." Although no one was injured in the incident, she was sentenced by the jury to the minimum sentence of two years in prison.

The case received, in my opinion, a significant amount of publicity for several reasons. First, it was a crime everyone could relate to, because I believe most people who drive in Northern Virginia gridlock traffic have, at one time or another, thought seriously about committing the same crimeor worse. Hence, one could argue the jury was a tad bit hypocritical for convicting her.

The more important reason for the degree of publicity that is significant to us as lawyers is the punishment meted out in this case. As noted above, the law makes it a felony to throw any object at any occupied vehicle, whether moving or not. What really grabbed people's attention was the severity of the sentence imposed by the jury for what appeared to the average person to be a minor offense (although still an offense for which there should have been some punishment). But two years in prison as the minimum punishment seemed to strike people as over the top (or as the old expression goes, she "got the book thrown at her"). By imposing such a sentence, the legal system appeared unduly harsh and irrational under the circumstances, especially since no one was hurt and Ms. Hall is caring for her three young children while her husband serves in Iraq. However, we can't blame the jury, because that is the minimum sentence under the statute.

The lesson for us as guardians of the legal system is to resist the trend of attempting to overlegislate conduct via criminal and civil penalties [e.g., Va. Code §18.2-102.2 (unauthorized use of dairy milk crates as a class 4 misdemeanor) is one of my favorite examples]. Frankly, two years in prison is as much of a punishment to the taxpayers as to the defendant because it can cost tens of thousands of dollars per year to incarcerate a single person in Virginia. For my money, I could have thought of better ways to punish Ms. Hall. A year of one day a week picking up trash along I-95 would do far more for Virginia than having her sit in a prison. Or, if we felt that was not

# FBA Presidents' Day

The FBA recently celebrated its own Presidents Day. On February 15, 2007, FBA presidents from years past, ranging from our current Past-President, Richard Ruddy, to William Cremins who served his term 27 years ago, gathered with the current Board of Directors to share their advice and experience in addressing some of the challenges the FBA is facing.

Peter DePaolis helped organize the event and Koonz, McKenney, Johnson, DePaolis & Lightfoot sponsored the dinner. The pro-

gram started with an introduction from the current President, Steve Ray. I then presented a report on the "State of the FBA" and some of its current challenges, which are summarized as follows.

The state of the FBA is strong. We are one of the leading bar associations in Virginia and have over 2,000 members. The FBA is financially sound and has not raised dues since 1999. We have benefitted from proactive leadership, which is always looking ahead to improve the bar and address potential challenges before they become crises. Our association is amazingly active and many of our members do not realize the number of programs, services, and events the FBA offers. Due to the number of activities, we posted the list online at: fairfaxbar.org.whoweare/memberbenefits. That list is almost as long as the list of powers I give a trustee (a little estate planning humor).

Not only does the FBA manage a vast amount of programs but it regularly receives requests for new programs, many of which would be beneficial to our members. This immense amount of activity leads us to one of the FBA's challenges.

Many programs, activities, and events used to be run by volunteer members. Increasingly, the FBA has fewer and fewer volunteer hours. This might be due to increased demand for billable hours, competing activities for a volunteer's time, changes in lifestyles, etc. Whatever the cause, this trend is likely to continue. Less volunteer time means that we have to rely more and more on the FBA staff. The FBA and Law Library have eight full-time employees and several part-time employees. The staff is already reaching capacity, and giving them additional responsibilities without taking away programs or services elsewhere risks overextending them. We previously pared down some of our programs, but it is very hard to



terminate programs (it is easy to add them). Additional staff can help, but employees are very expensive. This inevitable increase in costs leads us to another challenge—finances.

As I stated above, the FBA is financially sound. This is no easy task, as over the last few years, there have been significant reductions in income from our traditional sources of revenue, such as library copier machines and CLEs. Despite increasing costs due to inflation and other factors, the

FBA has not raised dues since 1999. It has successfully maintained its financial stability in this economically challenging environment because past FBA leaders had the foresight to cut costs by better utilizing technology. Where possible, we have used the Internet instead of paying for the printing and postage of costly "snail mail." For instance, judicial evaluations and many member communications are done online. Unfortunately, cost cutting can only go so far before it starts impacting the FBA's ability to serve its members. For example, many of our members felt that they lost touch with the FBA when we went to a purely electronic Journal, so we brought back the print Journal. After having cut costs about as much as possible without significantly impacting the services we offer to our members, the FBA has also begun looking for ways to increase revenues (other than from increased dues). We have increased efficiencies with the FBA's Lawyer Referral and Information Service (LRIS) by implementing a percentage fee program for participating attorneys and encouraging individuals to pay for referrals up front with a credit card (you no longer have to collect the \$40.00 fee on behalf of LRIS and send it in). Additionally, the FBA started an affinity program which not only provides our members with discounts from banking services to catering to credit card machines, but also provides the FBA with a stream of income. The other area that the FBA has focused on to generate income is increased membership. Membership, however, is one of our biggest challenges.

The number of FBA members has remained fairly consistent over the past several years. This is quite an accomplishment in itself, as voluntary bar associations around the country have struggled with significant reductions in their memberships. However, our membership is aging and few young attorneys are joining. It is unclear precisely why, but possible reasons may include that they don't see the need to belong to a bar

association, that as the practice of law becomes more specialized, they join specialty bar associations instead, or that they simply do not have the time given increased pressure to bill hours. We have focused on better serving our members and making membership more attractive, however, this is an issue with which we continue to struggle.

Following my report, the past presidents discussed the FBA's issues and brainstormed for ideas that could help. Peter DePaolis compiled their comments in a report to the Board of Directors. The Board will use this report as part of its strategic planning process. Here are some of the highlights: Many past presidents felt that the FBA's current challenges are very similar to problems they faced during their terms. Some felt that we should increase dues to help defray increasing costs. Others felt that we should reduce dues to encourage new members to join. (You didn't really think a room full of lawyers would agree on everything). Many felt the FBA should reduce the number of programs it offers, although there were not many suggestions on which programs should be terminated. One program recommended for eventual termination was the FBA's judicial evaluation program. The FBA should be very proud that its program was used as the model for the new statewide judicial evaluation program. Once the statewide program is fully operational, it was suggested that the FBA's efforts would be duplicative. There were also suggestions on ways to reach out to young attorneys and large firms. All in all, the consensus of the group was that the dinner was productive and a similar event should be held every two to three years.

# MODEL JUDICIARY PROGRAM ANNUAL TRIAL DAY

The ice storm of January 2007 missed the Model Judiciary Program's Annual Trial Day by less than 24 hours, and a good thing it did, too: This year's program brought over 250 parents, teachers, and students to the Judicial Complex. Teams from Centreville, Chantilly, Lake Braddock, McLean, Paul VI,

Robinson and West Potomac High Schools fielded enough student attorneys, witnesses, deputies, clerks, and jurors to fill twelve courtrooms. The students tried the case of Hunt v. Commonwealth, a well known (and hypothetical) murder case to anyone who has acted as an attorney mentor to one of the high schools or served as a judge on Trial Days in years past.

The student trials are a real spectacle, with verdicts ranging from "not guilty" to "second degree murder." The student jurors prescribe the range of punishments after receiving instructions on the law. Some student attorneys are so convincing that they inevitably draw remarks from the Bench and Bar alike that they do a better job than many practicing attorneys. The volunteers from the Sheriff's Department add tremendously to the "real feel" of the program's Trial Day event, and the Bench and Bar are very grateful to Sheriff Stan G. Barry for the kind assistance of his dedicated staff, particularly, this year's volunteers: Sgt. Roger Scott, MDS Ronald Jennings, PFC Al Boyd, PFC Matthew McCracken, and PFC Charla Price.

Members of the Bench and Bar who gave generously of their time to judge the trials on January 21, 2007, are also responsible for the program's success again this year, and our thanks go to the Hon. Ian M. O'Flaherty; Hon. Michael J. Cassidy; Hon. Thomas P. Mann; Hon Charles J. Maxfield; Bruce D. White, Esq.; Michael F. Devine, Esq.; Jerome Friedlander, Jr., Esq.; Brett Kassabian, Esq.; Steven M. Garver, Esq.; Beth Bittel, Esq.; Charles Dunn, Esq.; and Michael J. Holleran, Esq. Many attorneys and members of the FBA volunteered their time to train the student mentors in general trial practice, and they include Julia B. Judkins, Esq.; Kelly R. Dennis, Esq.; Bruce A. Levine, Esq.; Kyle F. Bartol, Esq.; and Whitney E. Minter, Esq. There were many other members of the Bar who donated time directly to their children's schools without formal contact with the program, and we thank them.

One of the most important reasons that the program continues to make great progress in student participation is the tireless work of the Hon. Stanley P. Klein, Chief Judge of the Fairfax County Model Judiciary Program and his secretary Dana Marcaccio. He and his staff, including all of the coordination of Ms. Kim Pratt, make the Trial Day event seem seamless to the kids and their parents. Anyone who has seen the attendees at the event will wonder what kind of grassroots machine made the event possible, and the credit goes largely to Judge Klein. Judge O'Flaherty, as in past years, is also to be

commended for his gracious willingness to assume all of the duties of the sitting judge for the Model Judiciary's Northern Virginia intermediate appellate round. Several students from McLean, Centreville and Chantilly, we are happy to report, will be arguing their appeals to the Virginia Supreme Court in Richmond.

Finally, warm thanks are also extended to Chief Judge Michael P. McWeeny, who makes it possible for the students to try their cases in the Judicial Complex.

# I-CAN! Online System Helps Fairfax County Residents File for Family Abuse Protective Orders

The Fairfax County Juvenile and Domestic Relations District Court (JDRDC) has developed Fairfax-specific information for the web-based I-CAN! (Interactive Community Assistance Network) system. The system was developed by the Supreme Court of Virginia. I-CAN! helps residents file Family Abuse Protective Orders by taking filers through the process step-by-step. I CAN! is available 24 hours a day, 7 days a week. It can be accessed through any computer that has Internet access, and there is a link to I-CAN! from the JDRDC web page at <a href="http://www.fairfaxcounty.gov/courts/jdr/jdrFamilyViolence.htm">http://www.fairfaxcounty.gov/courts/jdr/jdrFamilyViolence.htm</a>. The JDRDC serves residents of Fairfax County, the city of Fairfax, and the towns of Herndon, Vienna and Clifton.

"The I-CAN! system is the result of a collaborative effort to provide an essential service to those in Fairfax County affected by domestic violence, including children and families," said JDRDC Judge Gayl Carr. "I-CAN! is another resource available to Fairfax County residents who are in need of services." Judge Carr headed a group of representatives from the courts, county agencies, state and community legal organizations that developed Fairfax-specific information for the I-CAN! system. Group members made sure information about available services and Fairfax Court practices was accurate and complete. The Fairfax-specific information can be accessed on the I-CAN! site under "Additional filing information for a Family Abuse Protective Order."

The I-CAN! system provides easy and convenient information and assistance in one place. Through responses to a series of questions, I-CAN! creates properly formatted petitions for a Family Abuse Protective Order than can be brought ready for filing to Intake (the Domestic Relations Services of Fairfax County's JDRDC). I-CAN! can be accessed anywhere there is Internet availability—at home, a local library, a domestic violence shelter, an attorney's office. The I-CAN! program also is available in Spanish; however, the Fairfax County-specific information posted on the Virginia I-CAN! website is currently available only in English. The county information explains court practices, the law and the steps for users to pursue their matter. Practical information includes how to find the JDRDC; what to expect in court; what time the court reviews petitions for protective orders; and how to access county and community-based resources, such as supportive services and legal assistance.

A Family Abuse Protective Order issued by a JDRDC judge can direct an abusive person to stop the abuse. It can further direct that person not to contact the person protected by the order and any of his/her family/house-hold members. In addition, the abusive person can be prohibited from going near the protected party's residence or place of employment. More detailed information about Family Abuse Protective Orders is available on the JDRDC webpage at http://www.fairfax county.gov/courts/jdr/jdrFamilyViolence.htm.

The Fairfax JDRDC I-CAN! work group included representatives from the Fairfax County JDRDC; Department of Systems Management for Human Services' Countywide Domestic Violence Coordinator; Women's Shelter; Police Department; Sheriff's Office; and the Public Library. Other work group members represented the Magistrate's Office; Foundation for Appropriate and Immediate Temporary Help; Office of the Public Defender; Office of The Commonwealth's Attorney; Shelter House; Legal Services of Northern Virginia; MacDowell and Associates PC; and the Office of the Executive Secretary of the Supreme Court of Virginia.

I-CAN! was created by the Legal Aid Society of Southern California and adapted for use in Virginia by the Office of the Executive Secretary of the Supreme Court of Virginia through a Virginia Services, Training, Officers, Prosecution (VSTOP) grant from the Virginia Department of Criminal Services. The system is currently in use by several Virginia localities. During the next year, the Office of the Executive Secretary of the Supreme Court of Virginia will be convening similar work groups across the state to assist other localities in developing the same type of detailed information as Fairfax County.

# RESTAURANT CHANGE OF OWNERSHIPS CAN BE SMOOTHER

Each month in Fairfax County, a number of permitted food establishments will change ownership. In many instances, the intent is to have a smooth transition and not miss a minute of business operation in the process. This is certainly achievable. It is important, however, to remember that the Health Department Permit to Operate a Food Establishment is not transferable and the new owner must have a permit in their name before they can open the establishment for business.

The buyer's first step is to make application for a Permit to Operate from the Fairfax County Health Department. A fee is required, as is a copy of the applications for a business license in the prospective buver's name. The Health Department also recommends that a "courtesy inspection" be conducted well before (2-3 weeks) the proposed settlement date. Only the CURRENT owner may request the courtesy inspection from the Health Department. The buyer must ask the seller to request this inspection if it is going to happen. Often, this inspection will result in a list of items which must be corrected BEFORE the Permit to Operate will be issued. It is in the buyer's interest to request a copy of the courtesy inspection from the seller, because the next inspection will be his responsibility.

The "change of ownership" inspection is for the purpose of issuing the buyer a Permit to Operate. When all cited items on the courtesy inspection have been corrected to the BUYER'S satisfaction, he should call the Health Department to schedule the change of ownership inspection. Also at this time, the buyer should have a solid idea of a settlement date.



The change of ownership inspection may be conducted up to seven days prior to settlement. If all items from the courtesy inspection have been corrected and no other critical violations are cited, a report will be generated which states, in part, that the establishment is in compliance with the Fairfax County Food Code; however, the Permit to Operate will not be issued until the Health Department has been notified that the settlement has occurred. At that time a permit will be faxed to him and the original will be sent by mail.

The change of ownership inspection focuses on the condition and functioning of facilities and food equipment of the food establishment. To that end, the seller should make any needed kitchen repairs to floors, walls, and ceilings to meet the requirement of "smooth and easily cleanable." All maintenance must be current for hood cleaning, grease trap cleaning and pest control. All equipment must be clean, functional and in good condition. If it is not working, repair it or dispose of it!

sufficient humiliation, considering the fact she was able to throw a cup of ice from the driver side of her car into the driver side of another car hitting the passenger of the other car, all while moving (no small feat), she could be sentenced to pitch for the Nationals, in light of the weakness in their current bullpen, and she could lose her dignity along with the rest of the team.

The second point regarding the punishment that is instructive to us as lawyers is the action of the judge during the sentencing phase, who wisely suspended her sentence conditioned on five years of good behavior. This demonstrates the need for judges to have discretion in evaluating the decisions of juries and the punishment imposed by juries. Failure to allow reasonable discretion to judges will remove the wisdom of our legal system, render it more a bureaucracy, and cause it to lose its credibility with the public.

Last Month's Question: After reviewing the many lengthy and well-researched responses to last month's question concerning the basis for depreciating a pond, I decided that the question was too difficult and abstract. As such, I am awarding credit to everyone who made a good faith attempt to provide the answer. The answer I was looking for was the loss of water. The basis for depreciating the pond is the loss of water as a result of things such as usage by livestock, ground seepage and evaporation.

In the short time you have been on the bench, what have you found to be most challenging?

Oh, there's no question about that. The most challenging aspect of being a judge is scheduling and docket control; keeping things moving while giving each litigant the time, respect and consideration that they need to effectively present their case.

When you were practicing, what aspect of your practice did you enjoy the most?

I enjoyed working with young people and their families.

What did you find to be most difficult?

The most difficult aspect of practicing was trying to explain the law to people who needed representation, and to make them understand that sometimes the results could not be quaranteed.

If you were addressing a group of young people, what would you say to them to encourage them to seek a career in the law?

I would say the same thing that I said to my children, who are both family law attorneys. My son, Harris Leiner, is with the Barnes Law Firm in Richmond, and my daughter. Sara Leiner. is with Feldesman Tucker Leifer Fidell. I would say that being a lawyer is an exciting, challenging, and stimulating occupation, which would give them the opportunity to help others, and to utilize their intellectual and advocacy skills.

What has been the most satisfying aspect of your own legal career?

The most satisfying aspect of my career occurred when I was able to obtain a fair result for a client. I also enjoyed working with and mentoring new attorneys.

Are there people who have had an important influence on you during your career?
