

HONORABLE JANE P. DELBRIDGE RETIRES


J&DR District Court Judge Retires After 23 Years on the Bench by Nicole McGuire and Carol Coile



udge Jane P. Delbridge was honored at a retirement ceremony at the Courthouse on February 8, 2006, which included friends (old and new), and family, including her "court family". The ceremony began with a presentation by the Sheriff's Department Color Guard and the singing of the Star Spangled Banner by 2nd Lt. Myra Kinney.

Judge Delbridge was recognized as the moving force in the court for the establishment of two specialized programs: a Court Appointed Special Advocates Program, which provides volunteer advocates for abused and neglected children; and more recently, Drug Court, which provides intensive court intervention in certain drug-related cases.

Chief Judge Carr presented Delbridge with a plaque and a Certificate of Appreciation. Judge Carr recounted in her remarks that she once told former J&DRD Court Judge Kathleen MacKay (now a Circuit Court Judge) after observing Judge Delbridge in the courtroom, "That's the kind of judge I want to be".



Judge Delbridge expressed her appreciation for having the good fortune to have such good friends and colleagues. She spent several minutes reminiscing about friends, people with whom she has worked, and groups with which she has been



BOARD OF DIRECTORS STRATEGIC PLANNING RETREAT

n January 26, 2006, the FBA Board of Directors held a day-long strategic planning retreat at the Country Club of Fairfax. The purpose of the retreat was twofold: (1) develop a vision for the FBA for the next three to five years; and (2) evaluate and determine whether to continue to operate each of the current FBA events and programs. To help prepare for the retreat, we asked for input from our members via an on-line survey that was conducted between January 6 and January 20, 2006. The survey was well received in the level of participation (almost 300 respondents--a new high for any survey or voting conducted by the FBA on-line). In addition, as described below, the Board agreed to eliminate certain events and programs that no longer appeared to support our core mission and to retool others.

Vision Statement

As a result of the retreat, the Board agreed upon the following Vision Statement to help guide us through the next few years:

Vision Statement of the Fairfax Bar Association: To be an essential resource for legal professionals practicing in Northern Virginia.

THE JOURNEY OF A "SELF MADE" MAN

You hear from time to time about the "self made" success story. whether it be an attorney, business person, student, or some public figure. The fact is each of us has had mentors along our respective journeys, and I would like to share with you a couple of important letters I wrote and am writing now to folks that helped me along the way.



The first and most important letter was written to my parents, Edythe and Dick Ruddy, during my sophomore year at Saint Vincent College. No, I was not writing home to ask for money. Rather, in a reflective moment one day it dawned on me that these were two wonderful parents, and so I penned a letter to let them know that I truly appreciated all their personal and financial sacrifices, moral example, and quiet mentoring. As was typical of my parents, they never mentioned the letter, but some years later, shortly after the last of my parents passed away, I returned to clean out the family home with my siblings. As I was going through my dad's chest of drawers, I found tucked near the back of one of the drawers that letter I sent them over 20 years earlier. Attached to my letter were similar letters from my brother and sister. I was surely blessed with wonderful parents, and to their eternal credit they raised some good kids.

I wrote another important letter just a few years ago to one of my former law partners, Keith Putbrese. Keith was practicing law in McLean when I joined his firm in the early 80s. No one worked harder than Keith at the profession he loved, and that work ethic coupled with his legal skills, ethics, and common sense earned him a very successful law practice over 30 plus years. I subsequently became one of Keith's law partners and practiced with him for over a decade. Much of what I learned and use today as an attorney was handed down to me by that man. Keith and I parted company in 1992 when I started my own firm. A few years later, around the time Keith retired from the practice of law. I wrote him a note of thanks for the education. guidance, and support he gave me during the early years of my legal career. Like my parents, Keith never mentioned the note, but I trust he derived satisfaction in knowing that he made a difference in the career of one lawyer.

We have reached the point in my term as FBA President where I can begin to see daylight in my schedule as my FBA responsibilities diminish. It has been a treat to view the FBA from this perspective, and many members have been very generous with their time, support, and advice this year. The balance of the year will pass quickly, so I thought this an appropriate time to extend this thank you to all for helping along the way during my FBA journey.

Many years ago I very reluctantly became involved with the FBA. Frankly, you guys can be a bit intimidating to a newbie lawyer, and I was very slow to jump into FBA activities. Certainly my perspective has been different than most over the years, and my opinions were not always received with enthusiasm by the FBA leadership. Over time, however, I either wore people down, or maybe my message simply found the right audience, who can really say. Some 20 years later, I must confess that my experience has been rewarding, and I am a better person and attorney because I chose to make this journey. Thank you for letting me make my contribution to the FBA.

There remains much to do in the FBA as we head towards the Presidential terms of Steve Ray beginning this July, and then Dan Ruttenberg in July 2007. Please give them a hand in their FBA leadership journey. They are talented attorney volunteers, and with your support, the FBA, will be a better servant to you, our members.

Award Ceremony Honors Outstanding Pro Bono Efforts

Pro Bono Lawyer of the Year: Charles Tievsky

he Fairfax Bar Pro Bono Program recognized the exceptional pro bono efforts of legal professionals serving our poverty and low income communities. At the February Bar luncheon, Judge Jane Marum Roush presented this year's awards to the following:

Pro Bono Law Firm of the Year: Whiteford, Taylor and Preston



The lawyers of Whiteford, Taylor and Preston have been working in Fairfax County for years through the Neighborhood Outreach Program to regularly meet with clients and provide legal advice, referral and representation. Since February 2002, they have partnered with Homestretch, a transitional housing program helping homeless families transform themselves in order to lead more productive lives. Whiteford, Taylor and Preston provides assistance in various civil areas including family, trusts and estates, tax, insurance, housing and employment law. The staff and participants of Homestretch greatly appreciate the efforts of the firm, which has included representation of individuals in courts throughout the Commonwealth of Virginia.



Chuck Tievsky has dedicated himself to helping the low income and immigrant community in the Herndon area. After some basic training in January 2004, Chuck sensed an overwhelming need for immigration law assistance and began singlehandedly staffing a clinic at the Herndon Neighborhood Resource Center. Chuck continues to meet with clients on a weekly basis without public recognition. In addition to providing individual representation, he has worked to dispel myths about the immigrant communities, lobbied on immigration reform, and provided valuable information and resources to the immigrants.

Pro Bono Paralegal of the Year: Russ Reiff



As an independent paralegal, Russ has structured his time to specialize in pro bono poverty law. He has been enthusiastic, dedicated, and creative in his efforts on behalf of the residents of Mondloch House, a homeless shelter on the Route 1 corridor. He has worked with the residents and the Neighborhood Outreach lawyers to ensure that these homeless residents receive excellent legal assistance. He has extended himself to appear an extra night at the shelter, just to explain the program to those who may need advice from a lawyer. Over the past five years, Russ has averaged over 600 clinical pro bono hours and almost 700 administrative pro bono hours to the poor in the greater Washington, D.C., area.

James Keith Public Service Award:

William L. Schmidt



Bill Schmidt, a well known member of our legal community since 1973, was awarded the James Keith Public Service Award for his demonstrated personal and long standing dedication to public service, including both pro bono legal service, as well as broader contributions to the community. Bill has been committed to the improvement of our community, which has been demonstrated both through individual representation and actions on behalf of organizations. Bill has been active in both the Fairfax Bar Association and the Fairfax Law Foundation, on which he served as president and a member of the Board of Directors. He has cochaired the Community Outreach Committee, and served on the Fairfax Bar Truancy Project Task Force. Bill has been a volunteer Neutral Case Evaluator in Fairfax Circuit Court since 1997, as well as serving as a Motions Day Conciliator since that time. Bill's work with the Salvation Army, Fairfax District, has always been important to him. He has worked as chair of the Board of Advisors and can be found ringing the bell in front of a Giant each Christmas. Bill has worked on repairing homes for the needy for the Bar's Christmas in April program since 1997, volunteered to work on the Katrina Relief Fund, and organized the Can-U-Care Food Drive Program.

WHEREAS, Jane Pritchard Becker Delbridge, judge of the Juvenile and Domestic Relations District Court of Fairfax County, retired after 23 years of outstanding public service to the citizens of Fairfax County, and

WHEREAS, Jane Delbridge was born and grew up in Bluefield, West Virginia, where her parents owned and operated radio station WVOW; and

WHEREAS, Jane Delbridge graduated from West Virginia University with a degree in political science and broadcasting and earned a degree in law from the Catholic University in 1973; and

WHEREAS, Jane Delbridge lived in Washington, D.C., worked for the Federal Communications Commission and later for the law firm of McKenna, Wilkinson, and Kitner, which represented the American Broadcasting Network; and

WHEREAS, Jane Delbridge moved to Virginia and for a decade worked in a private practice specializing in family law; and

WHEREAS, on March 3, 1983, Judge Delbridge was elected to the Juvenile & Domestic Relations District Court of Fairfax County, and

WHEREAS, dedicated to improving the quality of life for all children, Judge Delbridge helped to establish Fairfax County's Court Appointed Special Advocate (CASA) program, which trains volunteers who are appointed by the court to support and advocate for neglected and abused children; and

WHEREAS, Judge Delbridge served as the chief judge of the Fairfax Juvenile and Domestic Relations Court for four years; the court was the Family Court of Record for two years, and during that time she heard 25 percent of the county's divorce cases in addition to cases concerning families;

WHEREAS, committed to the young people of Fairfax County, Judge Delbridge served as a member of the board of advisors of Project Opportunity, the county's first school program for pregnant and parenting teens; and

WHEREAS, since 2003, Judge Delbridge served as the judge of Fairfax County's pilot Drug Court for teenagers, which was established after a year and a half of study and planning by a multi-agency drug court task force; and

WHEREAS, Judge Delbridge is an active member of numerous civic and professional organizations, including the Soroptimist International of Woodbridge, the Fairfax Bar Association, and the Virginia, District, and National Associations of Women Judges, and is a dedicated member of all Saints Episcopal Church, Sharon Chapel; and

WHEREAS, Judge Delbridge served the Fairfax County courts with dignity, profound wisdom, and compassion, and is greatly respected for her fairness as well as her sensitivity and concern for the well-being of the families and children of the Commonwealth, now, therefore, be it

DICK CORP

he Jennings Building expansion reached a milestone on February 10 when the topmost part of the structure was completed. Those who attended the traditional construction ceremony or passersby saw a flag and a tree hanging proudly from the tall construction crane.

Why a tree and a flag? The tree symbolizes that the project structure went up with no personal accidents and represents a good luck charm for the rest of the project. Scandinavians are credited with placing a Christmas tree on the top-most part of their structures though Native Americans hold similar traditions said to appease the tree spirits for using trees for lumber. The flag tradition dated back to the early 1900s when the last cable strands of the Brooklyn Bridge were decorated with the American flag by iron workers.

Planning began in 1994 for the Jennings Building expansion. Bonds financing construction and renovation projects were part of the Public Safety Bond Referendums in 1998 and 2002. The total project is estimated at \$115 million.

"The courthouse expansion is greatly needed to match the growth of the

county," said Ellen vanHully Bronson, DPWES project coordinator, who noted that the county's population has increased to more than 1.2 million people, directly affecting the number of cases, judges, and support staff required.

The project includes 316,000 square feet of new space which will be used for courtrooms, judicial chambers, office space and support space as well as allowing for after-hours access to a newly expanded public law library. Construction started in July 2004 with a celebrated groundbreaking event featuring county leaders. "The project is 40 percent complete and on schedule," said vanHully-Bronson. The Dick Corporation, the general contractor, will turn over the expansion on a floor-by-floor basis beginning in late 2006 with the lower level and ending with the fifth floor in April 2007. The total expansion and renovation project is scheduled for completion in March 2008.

When the project is completed, most of the Juvenile and Domestic Relations District Court staff will move to the new facility, freeing parts of the

old courthouse for historic records and associated use.

In addition to vanHully-Bronson, other DPWES members of the county Courthouse Expansion and Renovation Team are Magdi Imbabi, senior project engineer; Vish Kowdley, engineer; Frank Lentini, engineer; Nikolai Dubynin, project engineer; James Andrews, engineer technician; Ron Waldrop, senior inspector. Other team members include Cathy Spaine, space planner from Facilities Management Division and the firm of HDR Architecture, Inc.

Construction Progress as of January 2006

- Overall project is 40 percent complete;
- The last major structural concrete placement was January 27;
- Perimeter wall backfill is 95 percent complete;
- Reshores have been removed on the lower level, first floor, second floor and approximately 60 percent on the third floor;
- Mechanical ductwork, electrical cabinets, conduit installation are in progress on the lower level;
- Masonry block work is 90 percent complete on the lower level;
- Masonry block work has begun on the first floor;
- The expansion portion of the project is on schedule and on budget.

As you might expect, the development of the vision statement generated much lively, but thoughtful discussion. The Board had several years ago developed and agreed on a Mission Statement, however, what was missing was a clear vision that would guide us in fulfilling our mission1--the core of which is to serve our members. The debate among the board members centered on how we are best able to serve our members, to also include judges and paralegals rather than just attorneys. Some board members felt that our focus should be limited to serving FBA members only with respect to the practice of law in Fairfax County. The majority, however, noted that many members live and/or practice law in surrounding jurisdictions and that the trend for our membership would continue to expand beyond the borders of Fairfax County and, therefore, being a resource for all legal professionals in Northern Virginia was more appropriate. Nevertheless, our core focus will continue to remain on Fairfax County and our exceptional relationship with the judges of the Fairfax courts.

Evaluation of Current Events and Programs

The next area we examined was the events and programs that we currently offer. We relied upon and received much valuable feedback from the survey responses. As the survey reflected, the FBA currently provides its members with almost 60 different events, programs, and awards throughout the year, which included community service, social events

among members and the bench, and professional opportunities. Unfortunately, due to limits on the size of the FBA budget (at least without a dues increase), and the number of FBA staff, the ability to operate these programs at a level of quality that our members deserve, has become challenging, and in many cases, unrealistic.

As part of the evaluation, the Board conducted a SWOT analysis (Strengths, Weaknesses, Opportunities, and Threats). The Board noted many strengths of the FBA, which include: our relations with the bench; opportunities for networking; exceptional staff; the FBA website; our CLE programs; the judicial screening and evaluation program; the Circuit Court Manual; existing infrastructure; highcaliber of our membership; the relationship between the Fairfax Law Foundation and the FBA; the presence of the FBA in the courthouse; the LRIS program; the pro bono program; the law library; and the demographics of Northern Virginia.

The Board also identified several weaknesses that currently exist in the FBA, such as: limits on staff resources; lack of effective communications to members; lack of diversity within our membership that is reflective of the demographics of Northern Virginia; recent negative perception of the judicial screening process; outside competition of CLE programs; the impact of congestion in Northern Virginia; and the decline in overall member participation in FBA events.

Despite these weaknesses, many of them also present the following opportunities for the FBA: increase in

potential new members; the new courthouse and expansion of the courthouse facilities; enhancements in technology that can improve our ability to communicate with members; partnerships with other local bar associations; our relationship with the Northern Virginia legislative delegation; and our affinity partners programs.

Lastly, the biggest threats the Board foresees in the next three-five years are: increased competition for our members from other professional associations and CLE providers; increased congestion; and the ability to offer in person events; maintaining the financial viability of the FBA; and limitations on the FBA's office space in the new courthouse.

From the above SWOT analysis, the Board developed criteria for how we will evaluate our current and future events and programs. Based on our discussion, the Board agreed that the following criteria will be used going forward to evaluate all existing and any new events, programs, awards, etc.:

- How does the event/program benefit members?
- What is the cost of the event/program, including staff time and opportunity
- How does the event/program fit with the FBA mission and vision state-
- What is the impact of the event/program on the legal and local community?
- What is the expected level of participation by the members?

Using these criteria, the Board next evaluated all of our current offerings. The Board agreed that our core programs include the following:

- CLE programs
- Committees and sections
- Law library
- FBA Journal
- Lawyer Referral program
- · Law Related Education programs and events
- Young Lawyers section
- Social/networking opportunities for members and the bench

The Board agreed that many other programs either needed to be retooled or eliminated. With regard to those to be eliminated, the Board decided that those programs that are not legally related should be discontinued. Of course, the FBA will still partner and support such programs so long as they do not utilize FBA staff or financial resources. Another longstanding event that the Board decided to suspend at this point is the out-of-town convention. The convention has been unable to attract the level of attendance that merits the time and resources required to put it on. Examples of programs that require some retooling include the live and on-line CLEs, the annual bench-bar dinner dance, luncheons and the in-town convention.

The Board has committed itself to utilize the vision statement and tools discussed above to work to improve the FBA and the services it provides to its members and the community. Of course, the Board cannot do this

alone and relies on the continued support and participation of all our members. The Board is grateful to all of those who volunteer their time to chair committees, plan and run programs and events, and participate in our activities. We hope that you will share with us your thoughts on the foregoing and any suggestions you have for improving the FBA.




