## President's Column

In the not-too-distant past, I attended my high school reunion in Cupertino, CA. Many of my classmates had reaped the full benefit of growing up in Silicon Valley and shared wonderful stories of their lives in retirement. I must admit it took some time for me to convince myself that choosing the noble profession of law, instead of a career in the fast growing world of technology, had been worth it. However, affirmation of my decision to become part of the legal



profession was rekindled when I read an excerpt from the U.S. Equal Employment Opportunity Commission's 2003 Report on Diversity in Law Firms.

"Lawyers are very often key players in designing and activating the institutional mechanisms through which property is transferred, economic exchange is planned and enforced, injuries are compensated, crime is punished, marriages are dissolved and disputes are resolved. The ideologies and incentives of the lawyers engaged in these functions directly influence the lived experiences of Americans..." at 2.\*

My high school class was well represented by doctors, business owners, computer specialists, screenwriters, artists, and entrepreneurs in employment fields I didn't even know existed. As my classmates and I revisited stories of our youth, it became clear to me how much these individuals, many of whom I hadn't seen in years, had so greatly impacted my life during those formative years. It also became clear to me how fortunate we were to have been exposed to the expansive paths life had to offer, including career choices.

In addition to describing the virtues of the legal profession, the U.S. EEOC report compared percentages of representation of women and minorities in the legal profession and evaluated their increases between 1975 and 2002. Women in the legal profession demonstrated great strides as they moved from just 14.4 percent of all professionals in the legal services industry in 1975, to 40.3 percent in 2002. Regretfully, however, African Americans in legal services rose from only 2.3 percent in 1975, to 4.4 percent in 2002. A review of the 2000 census reveals similar startling figures. According to the census, minorities make up less than 11% of the legal profession, whereas 30% of the country's population is minorities. These figures document the need for further diversity in the legal profession.

From September 25 through September 28, 2008, a diversified group of federal and state judges will be coming to Washington, D.C. for the Just the Beginning Foundation Eighth Biennial Conference "Reaching Back, Lifting Up." Just the Beginning Foundation is a non-profit organization comprised of lawyers, judges, and citizens whose mission is to expand racial diversity in the legal profession and on the bench by developing and nurturing interest in the law among young persons from various ethnic backgrounds underrepresented in the legal profession. Over the course of the conference multiracial teams comprised of federal and state judges will reach out to high school, college, and law school students to share their paths to the bench, strategies and tips for success in the profession, and insight into career-building opportunities in the court system. The convention will also reach out to lawyers and citizens by providing panel events and discussions on topics including the impact of the media on the justice system, fixing racial inequalities in education and at law schools, and attracting and inspiring young generations of students and lawyers.

Diversity in the law benefits all persons in the legal profession. The world is becoming more multicultural and it is important for the legal profession to keep up with it. Diversity provides the legal profession with differing perspectives, provides more ideas, and expands opportunities for problem solving and new ways of thinking.



# NEW PILOT PROGRAM BY JUVENILE & DOMESTIC RELATIONS (J&DR) DISTRICT COURT AND DIVISION OF CHILD SUPPORT ENFORCEMENT (DCSE)

The J&DR District Court and the DCSE are piloting a new program in the County of Fairfax.


During the 2008 General Assembly Session, legislators passed House Bill 1257 which authorized the establishment of Intensive Case Monitoring Programs (ICMP) for child support enforcement as an innovative method to maximize collections and decrease incarceration due to nonpayment. Starting July 1, 2008, designated judges in Campbell, Fairfax, Hampton, and Spotsylvania Counties can, as they deem appropriate, order non-custodial parents (NCP) to participate in the ICMP as an alternative to incarceration. Program caseworkers will assist the selected NCPs to secure employment, housing, training, and other services needed to overcome the barriers that hinder their ability to pay support.


The DCSE is very excited about this proactive and progressive response to the problem of nonpayment. The Governor, Legislature, and the Department of Social Services are committed to this effort and recognize the benefits to families and the potential savings to the Commonwealth if NCPs successfully complete the program and begin to pay child support as ordered.

# 2008 Fairfax Bar Association 7th Annual Spring Golf Tournament in Honor of Clerk of the Circuit Court John T. Frey

he Fairfax Bar Association held its 7th Annual Spring Golf Tournament at Westfields Golf Club on Monday, June 30, 2008. While the golf tournament was originally scheduled during the spring on Monday, May 12, 2008, inclement weather consisting of sideways rain, 35 mph winds leaving debris all over the golf course, and temperatures in the 40s, resulted in the closure of Westfields Golf Club and the rescheduling of this event. This year the tournament was held in honor of John T. Frey, Clerk of the Fairfax County Circuit Court. Mr. Frey is currently serving his third term as the Clerk, having won re-election last fall in a close election.

There were 99 golfers registered for this tournament and the golfers were treated to an event full of various activities. A new addition to this year's golf tournament was a \$1 million Hole-in-One Shootout that was sponsored by the Capital Reporting Company. The four golfers during regulation play who were closest to the pin on the par-3 17th hole went back out to the tee box and each had one shot at the hole-in-one prize of \$1 million. Unfortunately, none of the four golfers came close to the \$1 million prize, and David J. Kiyonoga, having been the closest, was awarded a Nike Sumo driver.

As in past years, a silent auction was held along with the golf tournament, with the proceeds again benefitting the Fairfax Law Foundation. Those items purchased at the silent auction included a Phil Mickelson autographed 2004 Masters flag; a Jack Nicklaus autographed 1986 Masters scorecard with photographs; an Arnold Palmer autographed photograph; a gift certificate for two to the Westfields' Marriott Sunday brunch; and rounds of golf at Westfields Golf Club, Heritage Hunt Golf & Country Club, Raspberry Falls Golf & Hunt Club, Old Hickory Golf Club, the Lowes Island Golf Club, and Virginia National Golf Club. Funds raised by the silent auction help support valuable programs such as *pro bono* legal services to indigent clients, maintaining the public law library, and offering law-related education programs to area students, including the court tours that are conducted at the Courthouse.

The format of this golf tournament remained a scramble (captain's choice). The 1st-place team, with a score of 57, was the team of Steven Frei, Paul Romero, Charles Sickels, and Gary Mims. The 2nd-place team, with a score of 59, was the team of Steve Luxford, Anne Luxford, Sam Hawkens, and Mike Smith. The team of Steven Merril, Brian Drummond, Dickson Young, and Ted Sibert came in third with a score of 59.

Approximately an hour before of the golf tournament, the annual putting contest was held on the practice putting green, and Peter Schwartz won that contest. The women's longest drive competition on hole #11 was won by Anne Rocktashel, while the men's longest drive contest, held on the 15th hole, was won by John Latham. It should come as no surprise to those that know him well that the Closest-to-the-Keg competition, with a drive that was only 16" away from the keg, was Dickson Young.

# Fairfax Law Foundation "Making a Difference"

The Fairfax Law Foundation was founded in 1982 with the goal of "Making a Difference" in the community by creating innovative approaches to providing access to the law, and law-related education for victims of domestic violence, the homeless, military veterans, children, the elderly, the poor pro se litigants, and many others in the community. Carol summed it up with a statement that every member of the Foundation Board stands behind: "The Foundation's programs provide critical services necessary for access to justice, education, and an effective judicial system."

#### **GENERAL DISTRICT COURT NEWS**

#### **Felony Continuance Requests**

Requests filed on the morning of the court date for continuance of a felony charge in the General District Court will no longer be considered immediately. Instead, the request will be attached to the case for the judge's consideration in the courtroom at the 2:00 PM preliminary hearing.

#### **Transportation Orders**

Transportation Order requests filed in the Criminal and Traffic Divisions of the General District Court must be submitted at least 1 to 3 full work days in advance of the court date according to the following guidelines: 1 full work day in advance—for adjoining counties of Prince William Loudoun, Alexandria, and Arlington; 2 full work days in advance—for jails located two counties away (Rappahannock Regional Jail, Fauquier, P. Creek); and 3 full work days in advance—for all other jurisdictions. Requests received without adequate lead time will most likely not be accommodated.

#### Traffic—Take a Number, Please

When taking a number to speak with a clerk at the General District Court Traffic Clerk's Office, attorneys are asked to select "I - Attorneys" rather than taking numbers for each category to see which number gets called first. Selections G (Motions, Appeals, Continuances, Copy Requests, etc.) and I (Attorneys/Officers) feed into the same group of windows, so the first number taken will be served first. We cannot serve you at two windows simultaneously, and taking multiple numbers actually slows down the system.

#### Civil: Garnishment Backlog

When selecting court dates for garnishments, please add 4-6 weeks extraprocessing time to allow for a current backlog in the Civil Division of the Fairfax County General District Court.


